Item 1 - Burnaby Minor Lacrosse Club fee waiver request - Jack Crosby All Star Novice Tournament

Tournament Co-ordinator for the 2015 Jack Crosby Novice All Star Tournament requested a fee waiver for the use of three City of Burnaby arenas for the 30th annual tournament from July 02 to July 05. The allotment cost is estimated to be \$5,622.23 which represents community group rates for both prime and non-prime times. Additional staff time is required to assist with the facilitation of the event. Food Services revenue will assist in offsetting the impact of waiving the allotment fees. The staff cost estimate of \$1,332 will be covered by the Burnaby Minor Lacrosse Club (BMLC). The BMLC has provided a valuable service to the sport of lacrosse and have given a positive experience to the youth of Burnaby since 1963.

It was recommended:

- 1. THAT Burnaby Minor Lacrosse Club be granted a fee waiver for the use of Bill Copeland Sports Complex and Burnaby Lake and Kensington Arena for the 2015 Jack Crosby Novice All Star Tournament.
- 2. THAT a copy of this report be sent to Ms. Debbie Heard, Burnaby Minor Lacrosse Club Secretary (BMLC) and Jack Crosby Tournament Co-ordinator.

<u>Item 2 – 2015 special outdoor events</u>

This will include the City's Annual Symphony in the Park, the Burnaby Blues and Roots Festival and up to 8 ticketed concerts hosted by outside promoters and/or community groups at the Festival Lawn. At Swangard Stadium, this will include the annual European Festival event, the City Canada Day Concert, and up to 13 other special events. This is congruent with past practise and with the provisions of the relevant municipal bylaws (Burnaby Noise and Sound Abatement Bylaw #1979 Amendment No. 12066; Section 2).

It was recommended:

- 1. THAT approval be granted for up to 10 outdoor events at the Deer Lake Park Festival Lawn between 2015 May 01 and 2015 September 30, and up to 15 special events at Swangard Stadium between 2015 March 28 and 2015 November 07.
- 2. THAT this report be advanced to City Council for approval.

- 2. THAT Council be requested to bring down a bylaw to appropriate \$1,967,850 (inclusive of GST) from Capital Reserves to finance these projects.



On behalf of the Gilpin Elementary School Parent Advisory Council (PAC), please accept this letter as our application for the City of Burnaby's 2015 Playground Development Grant.

Gilpin is located in a beautiful park setting and the playground is used year round by the students at Gilpin, the preschool program run by the Neighbourhood House and by the entire community that live in Deer Lake Place. Our school has increased by two divisions over the last couple of years which demonstrates the appeal our school has to many families and the higher proportion of young families in our catchment area.

The Gilpin PAC has been working tirelessly for the last 2 years to raise funds to enable the following playground enhancements:

- Expand the playground area by approximately 12 feet to the west.
- Add a wheelchair accessible merry-go-round spinner to be enjoyed by any child on the playground.
- Add a very popular and fun double twister play apparatus.
- And a huge climbing net, our biggest addition to the playground.

We have raised \$41,000 of the \$45,000 we need and ask that the Burnaby Parks, Recreation and Cultural Services grant us the remaining \$4000.

The Burnaby School District has approved our project and a letter of support is attached. A letter of support from our principal, Sean Gaster, is attached as well.

The daycare and preschool facility on school premises that is run by Burnaby Neighbourhood House uses the playground to allow children in its care time outdoors. A letter of support from Antonia Beck, its Executive Director, is attached.

REPORT

Appearing on the agenda is correspondence from Ann Johannes, Gilpin Elementary Pac Chair and Sean Gaster, Gilpin Elementary Principal. Also included on the agenda is correspondence from the Pac Executive of École Westridge Elementary (Janice Ho, Co-Chair, Debra Phillipson, Co-Chair, Rhonda Manson, Vice-Chair, Colin Sian, Secretary, Yuko Kiyama, Treasurer). Both PACs are requesting a grant from the 2015 Annual Operating Playground Development Budget to assist with the redevelopment of their playgrounds.

There is \$12,000 budgeted annually for playground funding requests and, with few exceptions, the fund is expended each year. The Playground Funding Requests Criteria are attached (Attachment #1). The first two schools to request a grant this year are Gilpin and Westridge.

Both schools meet the Playground Grant guidelines and have received approval from the Burnaby School District to install the playground components within 12 months of receiving the Playground Grant. Gilpin Elementary last received a grant in 2001 and Ècole Westridge Elementary last received a grant in 2011.

CRITERIA FOR PLAYGROUND DEVELOPMENT FUNDING REQUESTS

The purpose of the Playground Development Grant is to recognize the fundraising efforts of Burnaby parents, as well as improve the play experience at school playgrounds for the community at large, as a valuable way to participate in physical activity and connect with neighbours, uses these assets.

CRITERIA:

- 1. The project is initiated and cost shared by a parent group and the Burnaby School Board. The parent group must have 50% of the project cost raised at the time of the request. The Playground Development Grant will provide matching funds up to a maximum of \$4,000.
- 2. The facility will be accessible to the public and thus provide a public benefit beyond serving the schoolchildren during school hours.
- 3. The parent group may request a grant once every 4 years.
- 4. The remainder of the funding for the entire project needs to be either in place or very close to being finalized.
- 5. Parks, Recreation & Cultural Services staff will be allowed input into the design process.
- 6. The Burnaby School Board must approve the project and its installation of the playground within 12 months of the grant approval. Consequently, a letter from the School District must be included with the request. The parent group may contact Sandra Brunner (Sandra Brunner@sd41.bc.ca) to arrange for a letter of support.
- 7. The grant can be used for equipment and/or for the purchase and planting of trees and/or shrubs for the playground area or garden projects.

OPERATIONAL GUIDELINES:

- 1. Projects are considered on a first come, first served basis. Requests will be time dated and received after the 3rd Monday of January of the year the grant is available.
- 2. Playground Development Grants are only available if approved in the City of Burnaby's Annual Capital Budget
- 3. In the event the Playground Development Fund is completely allocated prior to year end, staff will advise Commission of all subsequent requests for their consideration.

THAT approval be given for use of two sites within Burnaby Fraser Foreshore Park for required Department of Fisheries and Oceans compensatory environmental instream and salmonid habitat enhancement works along Glen Lyon Creek and Fraser River foreshore riparian plantings, for the dyke rehabilitation and upgrade works undertaken by the City along reaches one and nine of the Fraser River North Arm dyke, as outlined in this report.
- 2. THAT a copy of this report be sent to the Environment Committee for information.

REPORT

As part of the City's ongoing program to upgrade flood protection works along the Fraser River the Director Engineering is requesting the use of several areas within the Burnaby Fraser Foreshore Park for the installation of aquatic, riparian and terrestrial habitat compensation works required by the Department of Fisheries and Oceans. The City's Burnaby Fraser Foreshore Park, a linked system of linear and large park area, extends over about half of Burnaby's river corridor. The proposed compensation sites are at two separate locations within the park as illustrated in the park map (Attachment #1), and involve building meanders and fish habitat into a section of the Glen Lyon Creek watercourse in an upland area of the park, and riparian planting along the Fraser River dyke and foreshore from Byrne Road to the Fraser Park Drive cul-de-sac.

Engineering Department Staff have submitted conceptual plans for the proposed habitat compensation works prepared by Dillon Consulting which meet the DFO's requirements and are acceptable to Parks Staff. Preservation of visual corridors to the Fraser River have been considered and protected in the riparian planting plan. The proposed Glen Lyon Creek stream channel alignment changes, including pools, and in-stream habitat complexing and riparian area planting will enhance the habitat value of this conservation zone within the park to support aquatic and terrestrial wildlife species, including Stickleback and Chinook Salmon found along this reach of Glen Lyon Creek.

Signs will be posted in the park notifying the public of any temporary disruptions.

The construction contract will include a five year monitoring and maintenance period for the compensatory works on Glen Lyon Creek. Provision has been included in the channel design for a sediment pond facility at Marine Way with access for Engineering Operations, who are responsible for maintaining the Glen Lyon Creek watercourse.

The City must complete the installation of the required compensation works by 2015, December 21st. In order to meet this timeline, a number of approvals are required in sequence commencing with Commission approval, at its 2015, February 18th meeting, for use of the proposed compensation sites within Burnaby Fraser Foreshore Park.

REPORT

Background

Burnaby Fraser Foreshore Park comprises 79.09 hectares (195.5 acres) and provides unbroken access to the North Arm of the Fraser River for approximately 4.5 kilometres between the City of Vancouver boundary and the Big Bend. For thousands of years the river was an important source of salmon, a primary food source for aboriginal communities, and acted as a transportation conduit. Much of the park land remains as open space today with direct access to the shore where sawmills, warehouses and industrial shops once stood. The most visible remaining remnant of river industry is the Commonwealth Pier near Tillicum Street which was rebuilt for public use in 1999.

Today, Foreshore Park has become one of the most popular parks in Burnaby and offers a legacy of remnant riparian forests along rehabilitated streams interspersed with recreational amenities and a continuous waterfront path system.

CIRCUIT

Proposed Fitness Circuit Design

To enhance and expand the park user experience, a 12 station fitness circuit has been proposed to be added to the park between Byrne Road and Tillicum St. The layout of the circuit (<u>Attachment #1</u>) responds to the linear configuration of the park and the majestic views of the Fraser River.

The circuit utilizes both the lower waterfront trail and the upper dike paths adding connections at either end to create a loop system. Geographically, the circuit would be approximately 450 metres long, with an overall ground route length of about 960 m. The circuit would be demarcated by vertical timber gateway piers symbolizing river industry at the east and west entry points. The west gateway would also have a bronze plaque embedded in a concrete plinth to mark Canada's Sesquicentennial 150th Birthday. The fitness stations will be located in four universally accessible "pods" each having three work stations. It is anticipated the fitness circuit construction cost will be approximately \$150,000 including path upgrades and new path returns, gateway structures, exercise equipment, plaques, taxes, fees and contingency.

Proposed Fitness Circuit Sponsorship

The Rotary Clubs of Burnaby have expressed an interest in sponsoring the development of the fitness circuit in Burnaby Foreshore Park to commemorate Canada's Sesquicentennial, 150th birthday. Pending approval of the concept, an agreement between the City of Burnaby and the Rotary Clubs of Burnaby would be drafted and executed. The Rotary Clubs would create an internal donation program with the intent of raising \$150,000 to cover all costs for the project. Provision for sponsor recognition would be made at individual exercise stations where a small bronze plaque with limited number of characters would be installed. In addition, the gateway entry features would be designed to support both the City of Burnaby logo and the Rotary International logo. The intent is to fundraise, build and then open the facility on July 1st 2017.





The 2015 Provisional Financial Plan for Parks, Recreation and Cultural Services contains the following 13 projects to be funded from Capital Reserves. To enable work to go ahead on these projects, approval is requested to bring down a bylaw for funding

1. Shadbolt Centre

\$40,000

Interior Fitouts to acquire additional tables, chairs and related furniture and refurbish existing furniture in Shadbolt Centre common areas.

2. Recreation Equipment

\$110,000

Annual life cycle replacement of fitness and weight room Equipment, tables, chairs as well as arena ice maintenance equipment.

3. Graffiti Wrap Program

\$25,000

Covering of park site lighting control, electrical and irrigation kiosks with graffiti wrap similar to the program on City boulevard kiosks.

4. Tennis Court Renovations

\$185,000

Resurfacing, fencing, gates, benches and net upgrades as required. Focus for 2015 is for Ernie Winch, Stoney Creek and Central Valley courts.
