PURPOSE: To provide information on Coquitlam Search and Rescue Society, and to seek

approval for financial support to replace the Mobile Command Centre

### **RECOMMENDATION:**

1. THAT the Executive Committee of Council recommend Council approve a grant to the Coquitlam Search and Rescue Society for replacement of the Mobile Command Centre

## **REPORT**

The Executive Committee of Council, at its meeting held on 2014 December 04, received a delegation from Coquitlam Search and Rescue Society outlining their various operations and responsibilities, and seeking assistance to fund the Mobile Command Centre Replacement Project (detailed SAR's report on the Mobile Command Centre Replacement Prospectus is available in the Office of the City Clerk).

#### 1.0 BACKGROUND

Coquitlam Search and Rescue (SAR) serves the communities of Coquitlam, Port Coquitlam, Port Moody, Anmore, Belcarra, Burnaby and New Westminster, and has provided emergency services in both urban and wilderness settings since 1972. The services provided include:

- wilderness search and rescue
- wilderness medical rescue
- swiftwater rescue
- mountain rescue
- rope (high angle and slope) rescue
- avalanche rescue
- inland waters rescue
- missing children and adults with dementia searches

- animal rescue
- disaster assistance
- evacuation due to flooding, earthquake, landslide and interface forest fire
- tracking
- community services, and more.

## 2.0 THE TEAM

The team, based at Coquitlam's Town Centre Fire Hall, operates under the provincial Emergency Management BC (EMBC) and performs searches and rescue in an area that is over 1000 km². The team also assists the RCMP detachments in the Lower Mainland jurisdictions.

Coquitlam SAR currently has 54 active members, all volunteers; members are on call 24 hours a day, 7 days a week, on a year-round basis.

In 2013, the team responded to 38 operations for a total of 3,044 volunteer hours, resulting in the rescue or recovery of 29 persons. Professional emergency service providers, i.e. police, BC Ambulance, the provincial Coroner's Office, and the communities have come to rely upon Coquitlam SAR for the essential services it provides.

## 3.0 COQUITLAM SAR RESPONSES TO THE CITY OF BURNABY (2010 – 2014)

Coquitlam SAR responded to incidents in the City of Burnaby 16 times in the last five years, on an average of three times a year. Coquitlam SAR devoted a total of 1422 person hours to these responses, averaging 284 hours a year.

## 3.1 COQUITLAM SAR COMMUNITY TASK RESPONSES (2010 – 2014)

Coquitlam SAR's primary area of responsibility includes the communities of Coquitlam, Port Coquitlam, Port Moody, Anmore, Belcarra, Burnaby and New Westminster. The team also responds under mutual aid agreements to other SAR teams when requested, i.e. Ridge Meadows SAR (responses to the Pitt River / Pitt Lake / Upper Pitt River areas) and North Shore SAR.

In the table below, there is a list of communities and the number of tasks Coquitlam SAR responded to in the last five years.

<sup>\*</sup> The Village of Anmore is part of the Coquitlam RCMP detachment. Parts of the area around Belcarra are under the jurisdiction of the Port Moody Police, including parts of Belcarra Regional Park. Pitt Lake responses are most often shared with Ridge Meadows SAR.

#### 4.0 THE MOBILE COMMAND CENTRE

Search and rescue activities are planned, implemented and managed in the Mobile Command Centre (MCC). The MCC allows the team to deploy where needed with the aid of pre-plans, maps, radio and satellite communications, internet access and equipment for the team's full range of technical rescue skills. The MCC activities include all aspects of the provincial Incident Command System.

#### 4.1 CURRENT MOBILE COMMAND CENTRE

The current Mobile Command Centre, a Grumman panel truck, has a chassis that is commonly used for delivery of bulky, but light, goods. SAR operations require a vehicle which can support command centre operations, but also transport heavier cargo such as stretchers, ropes, generators, fuel, batteries, rescue equipment and an array of computer equipment.

### 4.2 NEW MOBILE COMMAND CENTRE

The new Mobile Command Centre consists of three major components:

## 1. Cab & Chassis

A Freightliner M2-106 Extended Cab with a Cummins 6.7L turbo diesel engine or equivalent cab & chassis has been determined to meet the needs of the new MCC and address shortcomings of the current vehicle.

#### 2. Command Centre Module

The heart of the centre contains the infrastructure and equipment necessary to support the effective management of all phases of a SAR operation. The module includes metal enclosure, desks, cabinets and shelves, wiring, lighting, auxiliary generator air conditioning and space heating systems, etc.

## 3. Command Centre Technology

This centre is comprised of the electronic technology which directly supports search and rescue management (computer hardware, video monitors and a smart board, printers, software, batteries, communication systems, including radios, cell and satellite phones, and internet connectivity).

#### 5.0 FUNDING

The estimated project budget, including all applicable taxes, is \$407,300. Funding in the amount of \$100,000 has been already committed to the replacement of the Command Centre from CSAR Endowment Fund (\$35,000) and City of Coquitlam (\$65,000).

Funding is also being solicited by the Society from the following sources: Spirit of Coquitlam Grant, BC Gaming Grant, City of Port Moody, City of Port Coquitlam, City of Burnaby, Metro Vancouver and other corporate sponsors.

#### 6.0 **SUSTAINABILITY**

The projected life span of the new Mobile Command Centre is 20 years, commensurate with the command centre that is to be replaced. The City of Coquitlam will maintain and repair as necessary the Cab and Chassis over the lifespan of the Mobile Centre as an 'in kind' donation, while Coquitlam SAR will maintain, repair and upgrade, as necessary, the Command Centre Technology as part of its operating budget and from future grant applications.

#### 7.0 **CONCLUSION**

The SAR's current Mobile Command Centre, in which search and rescue activities are planned, implemented and managed, is 20 years old and due for replacement. In addition to providing command centre capability for the next 20 years, a new Mobile Command Centre will provide a more robust vehicle to meet the needs of one of the fastest growing areas of the Lower Mainland, with the capability to travel on more challenging roads and with greater fuel efficiency, transport additional field equipment, and enhance search and rescue management capability through new technology and additional floor space for work stations and briefings. It is recommended that a grant be approved to support the Coquitlam SAR Mobile Command Centre Replacement Project.

### REPORT

#### INTRODUCTION

Burnaby City Council, at its Open meeting held on 2012 September 17, approved a report from the Executive Committee of Council that focused on providing a more efficient and sustainable Election that would improve the overall elector experience and increase voter turnout. Leading up to the 2014 Local Government Election, initiatives for enhanced election systems and voter engagement were implemented. These systems introduced new and adapted technologies resulting in improvements to election operations in keeping with the City's *Environmental and Social Sustainability Strategies*.

Establishing an Election Communication Plan became the base for building public awareness initiatives targeted at voter turnout. This Plan focused on the delivery of effective, focused and timely communications. New approaches were developed to provide a positive voter experience, expand citizen engagement and create community outreach programs, while encouraging partnerships with stakeholders and other Lower Mainland Municipalities.

Successes from the 2014 Local Government Election have been summarized through results, statistics and voter feedback in the *Burnaby Election Systems and Engagement* document (provided under a separate cover).

### ENHANCED ELECTION SYSTEMS

Municipal VoterView (MVV) and the concept of 'Vote Anywhere', as part of an enhanced election system, were first piloted at Advance Voting Opportunities in 2011. This system was approved by Council for use throughout Burnaby in 2014 it increased efficiencies and streamlined the election process as highlighted in the *attached* document.

'Vote Anywhere' made it possible for citizens to vote outside their neighbourhood at any one of the 35 voting locations and five Advance Voting Opportunities in Burnaby. In addition, Special Voting Opportunities were made available at 18 care facilities and Burnaby General Hospital. As a result of positive feedback from Burnaby citizens, 'Vote Anywhere' was a successful component to improving the voter experience.

Moving forward, new technologies in the areas of vote counting machines, improvements to hardware and enhancements to the connectivity infrastructure throughout the City, will further improve and increase efficiencies.

### Municipal VoterView

MVV delivered a comprehensive suite of election services that consisted of Voter List Management, Worker Management and Candidate Access. These three modules provided web hosting, internet voter lookup (IVL), electronic voter strike-off and voter registration. Outcomes from data analysis made possible through these modules, are highlighted in the attached document.

Electronic voter strike-off was synchronized at each physical voting location, tracking in realtime when and where a voter had cast their ballot. This feature enabled citizens to vote only once at any voting location in Burnaby. MVV was a complete election solution and a vast improvement to the manual processes used in past elections with multiple benefits, including data collection and measurable staff efficiencies. In addition, significant environmental savings were realized through a decrease in printed materials.

## **Vote Counting Machines**

Through discussions with two leading Canadian vote counting machine and election management solution providers, staff will initiate a Request for Proposal (RFP) for the lease of machines during the 2018 Local Government Election, as previously directed by Council. This process will include involvement and partnerships with City stakeholders and interested Lower Mainland Municipalities. Recommendations arising from this evaluation will be submitted to Council for final approval.

#### VOTER ENGAGEMENT

The Election Communication Plan objectives outlined by the *Burnaby's Social Sustainability Strategy* and findings from the 2011 Election, identified the following four focus areas for voter engagement:

- 1. Clearer communication
- 2. Increased use of Virtual City Hall
- 3. Implementation of social media
- 4. Enhanced community outreach

The 2014 Local Government Election voter turnout was 28.9%, an increase from 23.3% in 2011. Successes, statistics and stories from these four areas of voter engagement have been highlighted in the *attached* document.

Leading up to the 2018 Election, staff will continue to develop the Election Communication Plan, to address new voter engagement strategies and technological trends, shaping future elections.

## **Opportunities to Vote**

Burnaby citizens unable to attend existing voting opportunities provided feedback requesting alternative solutions. With low voter turnout at Special Voting Opportunities, staff will identify areas for improvement and work with assisted living and complex care facilities to develop and roll-out a program that meets their specific needs.

An evaluation of voting opportunities will be conducted to identify optimal locations to maximize voter turnout. This review will be based on accessibility, convenience, feedback from voters, staff, voter-turnout statistics, and future development within the city. Results from this analysis will be provided to Council for consideration.

## New Ways to Engage

Through partnership with care facilities and their residents, assessments will be conducted to identify specific needs and areas for improvement to increase resident participation in the voting process. Also, with a focus on new and non-voters in Burnaby (e.g. youth and new Canadians), staff will evaluate and research best practices that build the 'habit' of voting in Burnaby residents.

#### FUTURE RECOMMENDATIONS FOR REVIEW

This report, in conjunction with the *attached* document, builds on outcomes from the 2014 Local Government Election and provides direction to expand efforts for increased voter turnout. These improvements explore and develop opportunities to deliver an efficient and sustainable election, while continuing to enhance the voter experience and expand public awareness.

With Local Government Elections now on a four year cycle, the span between each election may result in changes that would require further research prior to recommendations being submitted to Council for approval. Factors for study may include future development within the city, technological innovations, voter demographics, public engagement strategies and possible changes to legislation.

Staff will continue to work with stakeholders and other BC Municipalities to review areas for improvement and collaborate to establish election best practices for implementation in 2018. Information gathered will assist staff to develop recommendations for enhancements to the election process and the overall voter experience.

## Municipal VoterView (MVV)

Staff will bring forward a report to Council seeking the continued use of election services through Municipal VoterView during the 2018 Local Government Election.

## **Vote Counting Machine**

Staff will initiate a Request for Proposal (RFP) for the lease of vote counting machines for use during the 2018 Local Government Election. Recommendations arising from this investigation will be submitted to Council for consideration.

## Voting Location and 'Vote Anywhere'

Staff will research and review specific criteria to identify Voting Locations, including Advance Voting Opportunities, that best meet the needs of citizens to maximize voter turnout. A report outlining these recommendations will be provided to Council for consideration.

As a result of positive outcomes and feedback from 2014, staff will recommend that 'Vote Anywhere' be continued for future elections.



Dear Executive Committee of Council,

The Afghan Women's Sewing and Crafts Co-operative is a grass roots, community-based initiative and is an example of marginalized women finding a safe space to participate economically and socially. Members of the cooperative are a diverse group with a wide range of ethnic backgrounds, languages, religions, ages, education, mental and physical ability, marital and social status and rural and urban experiences. In September 2004, several organizations came together to support the development of the sewing group into a co-operative with the City of Burnaby playing an important role in this development.

In March 2010, Council approved the allocation of Room 206 at the Edmonds Neighbourhood Resource Centre (7355 Canada Way) to the Afghan Women's Sewing and Crafts Cooperative. The group has received a 50% lease grant each year and this grant (which is done internally at City Hall – they don't actually receive the money) reduces their rent by 50%. The pre-grant annual lease rate is \$10,851.84 which is reduced by \$5,425.92. With the reduction their monthly rent is \$452.16 plus GST of \$22.61 for a total of \$474.77 per month.

Due to unforeseen financial hardship the Afghan Women's Sewing and Crafts Co-operative is asking for a three month reprieve from the monthly rental costs of \$474.77. This arrangement would last between February 2015-April 2015.

In 2016, the Nikkei National Museum & Cultural Centre will present *Hokori*: *Japanese Canadians in the First World War* to commemorate the 100<sup>th</sup> anniversary of participation in the First World War by Japanese Canadian Soldiers. *Hokori* refers to their pride and desire to fight for Canada. The telling of this little-known slice of Canadian history is a story that is long overdue. Beginning in early 1916, over 200 Japanese Canadian recruits began military training in Vancouver. This was a time when the Japanese in Canada had no right to vote, and yet they felt called to serve the country they identified as their home. On April 19, 1916, the request for the acceptance of a Japanese Canadian battalion was officially declined by the Military Council of Prime Minister Borden. Despite obstacles of racism, refusal, and rebuke, the Japanese Canadian military volunteers persisted and made the effort to travel to Alberta where they were finally able to enlist.

The first volunteer to enlist in Alberta was Iku Kumagawa on May 19, 1916. In the end, 226 soldiers fought in the Japanese Canadian Volunteer Corps. They participated in the major battles of the Somme, Vimy Ridge, Lens, Avion, Hill 70, Passchendaele, Amiens, Arras, Cambrai, Denain, Valenciennes, Mons. Fifty-five were killed or died of their wounds. Only six came home uninjured. Letters from the front describe the exemplary and fearless fighting of all Japanese Canadian units. They won 13 military medals for bravery. Despite demonstrated loyalty to Canada, these veterans were still denied the vote until 1931. As well, during the Second World War, their military service was ignored and they were included in the mass internment of Japanese Canadians.

In this commemoration, we want to tell the story of loyalty, dedication, courage, and commitment to a better Canada from the early community of Japanese in Canada. Our events and activities will include a commemorative ceremony in the spring, a commemorative book project, historical re-enactments, historical walking tours, a museum exhibition, several special events and a commemorative plaque. We wish to recognize May 19, 1916 as the date around which the WWI Japanese Canadian soldiers' war stories revolve. This was a turning point – when the government of Canada refused Japanese Canadian participation as a battalion, the individual volunteers made a commitment to join the military through other means. Their willingness to travel to Alberta to enlist shows the Japanese Canadian volunteers perseverance and commitment to Canada. Our project partners are the Powell Street Festival Society, the Vancouver Cherry Blossom Festival, the Surrey Museum, Tonarigumi, the BC Genealogical Society, the Vancouver Heritage Foundation and the Japanese Canadian Citizens Association.

We proposed the following events to take place throughout 2016:

A commemorative ceremony and reception at the Japanese Canadian War Memorial in Stanley Park in late April. This will honour the soldiers, their story, and celebrate the beautiful cherry trees that were planted in their honour. Descendents of the soldiers will be invited.

- Bus and walking tours of special sites related to the Japanese Canadian Volunteer Corps, including Powell Street where they trained, Stanley Park, and other key locations around Vancouver.
- Re-enactment performances by professional actors of key figures in the Japanese Canadian community including Zennosuke Inouye, Masumi Mitsui, Yasushi Yamazaki, Kumakichi Oura.
- Mini-exhibit, walking tours, performances will take place during the Powell Street Festival in August. Preparation of a book telling the stories of the 226 Japanese Canadian volunteers, with several essays outlining the context of their involvement. Book launch in October 2016.
- Museum exhibit at the Nikkei National Museum to highlight the Japanese Canadian community and their involvement in 2016. This will open in October 2016.

Special programs, including a panel discussion, writing workshop and gallery tours/presentations will take place in the fall/winter of 2016.



I hope this letter finds you well. My name is Neil Belanger and I am the Executive Director of the British Columbia Aboriginal Network on Disability Society (BCANDS), which is an award winning, provincial Aboriginal disability and health organization.

BCANDS disability services are provided across British Columbia and available to Aboriginal individuals and families living with a disability, regardless of age, location, disability type or disability related need(s). I am contacting you today to request your community's support and participation in a new Society initiative:

"BC Without Barriers – Assisting Aboriginal Individuals and Families Living with a Disability in British Columbia".

As you may be aware, the Aboriginal (First Nation, Métis, Inuit) population of British Columbia is the second highest in Canada, with British Columbia enjoying the highest number of First Nation communities within the Nation. In 2011 according to the National Household Survey, over 232,000 individuals residing within British Columbia identified as being Aboriginal.

As reported by Employment and Social Development Canada in 2011, "The disability rate among Canadian Aboriginal people is higher than the overall disability rate. Regardless of age, Aboriginal Canadians are more likely to have disabilities than Canadians who are not Aboriginal".2

In 2012, 13.7% of Canadians reported living with a disability. Research has shown that 30% of Aboriginal adults report living with a disability and that Aboriginal adults, aged 15 to 34, have a disability rate that is three times the national rate for the same age group.3

Knowing this, we can conservatively estimate that within British Columbia there are over 50,000 Aboriginal persons who live with a disability.

It is additionally known that Aboriginal people, racialized communities and persons living with disabilities all continue to face higher barriers as it relates to economic inclusion (lower employment rates / living in poverty) which in turn, is correlated to decreased overall well-being, lower educational attainment rates and lower levels of social inclusion.

Understanding these factors, we see that the disabled Aboriginal population of British Columbia represent a marginalized population within an already marginalized population and have become the "invisible members" within the provinces disability sector, with minimal understanding of the difficulties, limited resources and the jurisdictional and mandate issues that are experienced by this important segment of our population.

Our Society is continually examining ways to bring awareness to the work that we do and to the needs of those we serve. As with many not-for-profit organizations, we are challenged daily in our work due to increased service requests, limited resources and increased competition for available resources from other very worthwhile and important service organizations that work within the province's not-for-profit sector.

As such, to raise awareness and to solicit support for our work and for our clients, we have developed the "BC Without Barriers" campaign, which we are hopeful your community will consider supporting both initially and on an ongoing basis.

We are requesting your support of this initiative through your community's donation of \$200 to the British Columbia Aboriginal Network on Disability Society. All donations received will be utilized to assist in the provision of current and expanded disability related support services for Aboriginal individuals and families living with a disability within British Columbia.

# Response from the Planning and Building Department (Mark Sloat)

The Rivershed Society of BC is not a regular participant at Burnaby Rivers Day events. They have sometimes been invited but usually don't participate in our event, at least in the last 10 years. That being said, I spoke with Mark Angelo and he noted that the Rivershed Society of BC has always been a fantastic supporter of BC Rivers Day and World Rivers, but at a broader level. I suppose they may not have the capability to be an exhibitor at a specific event, but are able to support Rivers Day in different ways.

For what it's worth, the swim down the Fraser River by Fin Donnely 20 years ago was a significant event in BC's river conservation history. I certainly remember it. I think it would be a worthy event to support. Their schedule suggests they will be in Burnaby on the Friday before our Rivers Day event, which is on Sunday. There might be some ways to cross promote these events.

# Response from the Rivershed Society of BC

(Christa Montpetit)

Please see the <u>attached</u> list of communities that have been contacted. At this point, we have submitted a full proposal (at their request) to the City of New Westminster and we are waiting to hear back regarding the level of commitment they intend to provide. We will also be scheduling a meeting with two Vancouver Councillors that we have been referred to by the Mayor. The City of Coquitlam has also asked us to submit a full proposal. If you like, I can update you when we hear back. On the day we are proposing in New West, we will be working with the Fraser River Discovery Centre. They have an annual event that runs the entire weekend and we are proposing to be the kick off on the Thursday evening (5:00pm – 9:00pm).

This is not (has not) been a yearly event. Fin Donnelly did his first swim in 1995 and his last swim in 2000.

I have contacted Peggy McMillan in the Parks Department and she was extremely helpful. I am in the process of putting a package together for her based on the requirements as listed in their application.

I had a brief chat with Fin and he confirmed that not only has he attended the Rivers Day event in Burnaby as a spectator but that he has also been a speaker at the event as well (I don't know the dates). The Rivershed Society of BC has also participated in the past with a booth display.

With respect to the festival booths and activities, families and school children will be invited to come and join the musical performer's Up Your Watershed!; where possible we would like to have a salmon BBQ; in addition to the speeches we will welcome the swimmers when they reach this stop; educational displays and informative booths will be set up by local environmentalists and conservation groups, First Nations and local community organizations (we have not confirmed anyone at this point but I can keep you informed as we confirm commitment). We would like to have First Nations groups provide ceremonial drumming, dance and sing along, which will have a strong focus on the youth component.

As we are in the prelim organizing stage I apologize that I cannot confirm community groups/businesses/governments/environmentalists etc., that we have on board but I am hoping this all comes together very soon as I hate to say it but September will be here before we know it!
