MINUTES

An 'Open' meeting of the Executive Committee of Council was held in Council Chambers, Main Floor, City Hall, 4949 Canada Way, Burnaby, BC on **Thursday, 2015 March 19** at 5:00 p.m.

1. <u>CALL TO ORDER</u>

The Chair called the Open meeting to order at 5:01 p.m.

2. MINUTES

(a) Minutes of the Executive Committee of Council Open meeting held on 2015 February 19

MOVED BY COUNCILLOR P. MCDONELL: SECONDED BY COUNCILLOR D. JOHNSTON:

THAT the minutes of the Executive Committee of Council Open meeting held on 2015 February 19 be now adopted.

3. <u>DELEGATIONS</u>

MOVED BY COUNCILLOR P. MCDONELL: SECONDED BY COUNCILLOR D. JOHNSTON:

THAT the delegations be heard.

CARRIED UNANIMOUSLY

(a) Chris Schafer, UBER Public Policy Manager - Canada Re: UBER Ride-Sharing Service Speaker: Chris Schafer

Chris Schafer, UBER Public Policy Manager, Canada appeared as a delegation providing an overview on UBER as a ride-sharing service and referenced operation in Toronto, Ottawa, Edmonton and various cities throughout the United States and Europe. The speaker advised that a customer would sign up with an email address, download a free app to their smart phone to book a ride and pay via their phone. All drivers use their own vehicles with real-time GPS tracking technology to locate and pick up customers.

Mr. Schafer highlighted the following main points:

- drivers must be 21 years old, have a current license issued in BC and personal auto insurance
- drivers are able to earn extra money through ride-sharing
- vehicles are mid or full size with 4 doors in excellent condition
- complements the service provided by public transport
- vehicles are given a 26 point safety inspection
- the service improves the customer experience and behaviors
- cash does not change hands
- high percent of women drivers
- drivers are ranked and receive written feedback in real-time
- 30-45 percent less cost than the traditional taxi

Mr. Schafer provided additional details regarding UberBlack, a limousine service with an app that alerts you where to stand for your pick up and provides a picture so the drivers know who you are. The speaker noted that airport pick up service is available and that different options are in place to ensure airport annual service fees are being paid.

The Chair inquired why the Germany Court had banned UBER. The speaker advised that UBER operates in over 300 cities worldwide and was not aware of the number of cities that were currently banning UBER.

The Chair advised that UBER must follow the bylaws and legislation as stipulated for City of Burnaby and emphasized the following three key factors that must be in place to operate:

- PTB (Passenger Transportation Board) Licence
- Burnaby Business Licence
- Chauffer's Permit (issued by the RCMP)

The Chair thanked Mr. Schafer for appearing as a delegation at the request of the Committee and advised his presentation was strictly to gather information and clarified that a licence was not being considered.

(b) Emon Bari, General Manager, Bonny's Taxi Mohan Kang, President BC Taxi Association Re: Uber Ride-Sharing Service Speakers: Emon Bari and Mohan Kang

Emon Bari, General Manager, Bonny's Taxi and Mohan Kang, President of BC Taxi Association appeared as a delegation expressing concerns regarding the UBER ridesharing service noting that a previous attempt to launch UBER was done in 2012.

Mr. Bari advised that the UBER Business Model disregards existing legislated requirements for the Province as they will not:

- obtain a commercial licence
- complete the RCMP checks
- obtain appropriate liability insurance (10M)
- meet vehicle inspection level as required of taxi service
- undergo the Taxi Host Program (currently required by the City)

Mr. Kang, President BC Taxi Association, echoed Mr. Bari's concerns regarding the disregard for regulations and rules that govern public safety. The speaker noted that UBER wishes to 'cherry pick' only customers with a credit card which would ultimately disenfranchise seniors or young persons who want to pay by cash.

In closing, Mr. Kang emphasized that the taxi industry in BC is closely regulated through the Passenger Transportation Act and if the UBER Business Model was approved it would create chaos and public safety would be compromised.

A letter of appreciation was received from Scouts Canada, Pacific Coast Council thanking Burnaby City Council for awarding a grant in support of Scouting programs for Beaver Scouts, Cub Scouts, Scouts, Venturer Scouts and Rover Scouts in the amount of \$5,000 for 2015.

(b) Correspondence received from Steve McConnell Re: <u>UBER</u>

Correspondence was received from Steve McConnell encouraging the Committee to look favourably on the UBER presentation. The writer noted his experience with the service in LA and that the ride-sharing program is vastly superior to existing taxi companies.

(c) Correspondence received from Harry Randhawa, Coordinator, TaxiHost Program, JIBC School of Public Safety Re: UBER Ride-Share Service

Correspondence was received from Harry Randhawa advising that the Justice Institute (JIBC) Taxi Host Program works in conjunction with the Passenger Transportation Board, Taxi Industry, City of Burnaby and other Lower Mainland jurisdictions, community groups, Tourism BC and the Burnaby RCMP to ensure drivers and taxi companies are compliant with the requirements established as per the current bylaw. Mr. Randhawa recommended that the City consider expanding the bylaw to include any and all chauffeured, limousine or ride share drivers to go through this training.

(d) Memorandum from Deputy City Clerk Re: Municipal Broadband

A memorandum was received from the Deputy City Clerk advising that Burnaby City Council at the Open meeting held on 2015 March 09 received correspondence from Dave MacKinnon regarding the provision of municipal broadband.

Arising from discussion, Council adopted the following motion:

(e) Correspondence received from Kevin Harding Re: <u>UBER, Taxis and Burnaby – a Cooperative Solution</u>

Correspondence was received from Kevin Harding providing information regarding a taxis cooperative solution as a better form of business. Mr. Harding noted that a taxi cooperative in Burnaby could empower drivers and connect business to the community. The writer referenced an article on the differences between UBER and taxi companies at ttp://inci.pe/taxicoop-burnaby.

Dear sirs and madams,

We would like to present you the petition sheets which contain signatures of those who oppose construction of the Comfort Women statue and the monument at Burnaby Park in Burnaby City.

We can classify the important comments into types as follows:

- 1. This statue erection violates the policy and philosophy of Canada, multiculturalism. And any local government should not be involved in international affairs. It should work on the promotion of happiness, prosperity, welfare, safety, and harmony of the citizens.
- 2. The "Comfort Women" issue is not a present issue, but a past issue. It happened more than seventy years ago, and Japan officially apologized to them many times and compensated them financialy.
- 3. One comment requested to Burnaby Council to make new ordinance and enforce the penalty in case that the hate crime, bullying, and discrimination against Japanese occur. I would like you to refer to "The Independent Verification Committee report for Comfort Women articles by Asahi Shimbun.", as being attached. *
- 4. Many Japanese will stop visiting Canada. The negative impact to Canada tourism industry would be extensive. Canada has a good image of beautiful, peaceful, and easy place to enjoy nature. This image will change for Japanese. For your reference, the number of Japanese who visited Korea decreased by 30% from 2012 to 2013.
- 5. Boycott of Canadian products might start. For your reference, many Japanese stop going to Korean restaurants in Shin-Okubo area (Korean town in Tokyo) and due to this boycott campaign, Korean restaurant business is at the brink of death. After the erection of the statue, the Japanese might start a boycott of Canadian products.
- 6. Japanese might sue Burnaby City and Councillors, in which you can refer to the case of Glendale in the US
- 7. It is inappropriate to erect such a statue which exposes sex related content to our park; it is disturbing to the natural surroundings.

I am deeply concerned about the proposal to erect the Comfort Women statue in Burnaby as it will prevent your efforts to keep a good living-standard of Burnaby's citizens. I wish for the wise judgment of Burnaby City Council on this matter considering a peace and tranquility within the local community. I believe you will protect the children who are currently facing the problem, and those who would have a future in a future at Burnaby.


- We were pleased to confer a Big Sisters of BC Lower Mainland Big Heart Award on long-time supporter Canadian Western Bank.

The Heights Neighbourhood Association (HNA) is pleased to tell you about an exciting project we're planning to help celebrate a major anniversary in 2015. One hundred years ago, Gilmore Community School officially opened its doors to Burnaby Heights elementary students. As part of a number of activities that will mark this milestone, the HNA has commissioned a film to honour the school, its students, teachers and staff and the generations of families who have called this neighbourhood home.

Since the doors officially opened in 1915, Gilmore Elementary has seen more than 30,000 children attend classes within its distinctive red brick walls. Situated right in the very heart of the Heights neighbourhood, the school has always been much more than a place where children learn to read and write. Built when much of the Heights was still dotted with small farms created after loggers cleared the forest, Gilmore School was a central part of the City of Burnaby's promise to build a new community. "I took out the bottle of pills and just stared at it...I stared at it so long that it scared me" Sophia told the YouthInBC.com chat volunteer, Weston. "He just won't stop drinking" Sophia wrote, "I just can't do it anymore. I just can't." For years, Sophia, a 16 year old Burnaby Central Student, had been dealing with a stepfather whose alcoholism turned him into an abusive, destructive force in her life. She was feeling deeply unsafe at home, and desperately unhappy in her own skin. Sophia had started cutting herself, and her eating disorder had begun to spiral out of control. In desperation, Sophia had logged onto the YouthInBC.com chat service, telling Weston that she had a plan to kill herself that evening.

STRATEGIC CONTEXT

Suicide is the second leading cause of death among young people aged 15-19 in Canada following motor vehicle accidents (Public Health Agency of Canada, 2005) and in British Columbia, 25% of students have reported having suicidal thoughts in the past year (McCreary Report, 2013).

The teenage years are often tumultuous; young people face pressure from their peers, school environment and parents. Adolescence is a time when mental illnesses tend to emerge, and many young people struggle with issues involving sexual orientation and identity, self-harm, abuse, depression, and suicidal thoughts. The Crisis Centre is a safe confidential space for young people to seek help when these issues become overwhelming.

In 2014, the Crisis Centre's Youth Suicide Prevention Program impacted the lives of 91,930 young people through our school-based suicide prevention and mindfulness workshops and YouthInBC.com websites. Some highlights include:

- **81,301** visitors to our YouthInBC.com website accessed important resources and information on suicide prevention and stress management
- 31,902 young people accessed our YouthInBC.com website through their mobile device in times of need
- **2,803** youth contacted us through our YouthInBC.com chat service receiving immediate, non-judgmental, and confidential support when they needed it most
- 7,826 young people engaged in our educational workshops on building resiliency in times of emotional crisis and practicing mindfulness as a coping strategy when experiencing stress
- 970 youth reached out on our Regional Crisis Line and 1-800-Suicide line to speak with a highly trained, caring volunteer in times of distress.

The Crisis Centre's Youth Suicide Prevention Program is based on the principle that suicide is a complicated, multi-faceted subject that must be approached holistically. Our comprehensive approach begins at the grassroots level, working to effectively reduce the stigma surrounding suicide in our communities, helping youth at their most vulnerable times of distress, and creating a strong network of empowered young people who have the capacity to help themselves, and others, in times of crisis. YouthInBC.com connects these young people with the support they need to help themselves, and their peers, when experiencing crisis.

Community Education – School Based Workshops

- Work Your Mind Muscle Four Tools For Navigating Life (Grades 8-12): invites teens to talk about their life challenges, take charge of their stress and build their resiliency
- Multi-Session Mindfulness Program (Grades 8-12): research demonstrates the greatest outcomes in building resiliency, coping skills and mental wellness are developed as a result of multi-session mindfulness programming. School district administration, teachers, counsellors and students themselves have indicated a need for this type of enhanced mindfulness programming

In 2013, the Crisis Centre formed an instrumental partnership with the Burnaby School District that has now shifted the entire school philosophy around how they respond to suicide:

"Our partnership with the Crisis Centre has been critical. There had previously been a tendency to negate our role in suicide prevention, and to seek outside experts to deal with the situation. As a result of the training we received, we have initiated a new plan for working with youth at risk of suicide that acknowledges our role in a young person's care. Access to evidence based, consistent training at the Crisis Centre has been so valuable for us, providing an opportunity to work and learn from others in the community, helping to see ourselves as an important part of the solution."

In 2014 the Crisis Centre trained 30 an additional Burnaby school counsellors:

- This training included 9 counsellors that attended safeTALK, a half-day suicide awareness and response workshop.
- 21 counsellors participated in ASIST, an immersive, 2 day intensive suicide intervention training

The tools learned by the school counsellors have allowed them to develop first-hand knowledge of applied suicide awareness and intervention skills.

The Crisis Centre's highly successful partnership with the Burnaby School District is being used as a model for new community partnerships. In 2015 we will continue to develop our partnership with the district, providing safeTALK and ASIST training to more counsellors, as well as training counsellors to deliver safeTALK workshops themselves.

HISTORY OF THE CRISIS CENTRE

2014 marked the 45th anniversary of the Crisis Centre. Since 1969, we have tirelessly worked to ensure the continued evolution and innovation of our life-saving services and programs, never forgetting our original mission – to provide non-judgemental, confidential emotional support 24/7 to youth, adults and seniors in distress.

Thankfully, because of our amazing volunteer Weston, Sophia stayed on the line that night....

Sophia explained to Weston that she needed to take frequent breaks from typing because she was sobbing uncontrollably. Weston helped Sophia with some breathing exercises, allowing her to calm down and catch her breath. Weston slowly began engaging Sophia, asking her about her interests and passions, and waiting patiently for Sophia to respond.

At first, Sophia was so distraught that she was having trouble forming coherent sentences. Eventually, Weston was able to establish some common ground with her. Weston asked Sophia about the pills that were sitting beside her, and he told Sophia "I would like to make a plan to keep you safe tonight." Sophia agreed, and moved the pills from her immediate vicinity.

Sophia spoke with Weston about resources for her eating disorder, and seeking alternative housing options for when her stepfathers drinking became out of control. She told Weston that she wasn't sure how soon she would be able to deal with it all, but said "coming on here tonight has stopped me from hurting myself...Thank you." Weston told Sophia to call back whenever she needed. Crisis Centre volunteers and staff checked in with Sophia over the next few days, making sure that Sophia had access to valuable resources that could positivity impact her life, but most importantly, that she was safe, and felt supported.
