Humanity.

#### **REPORT**

#### 1.0 BACKGROUND

A proposal was received by the City from the local chapter of a not-for-profit organization, Bicycles for Humanity (B4H) with a request to donate surplus bicycles.

Bicycles for Humanity is a grassroots group with the principle that the mobility a bicycle provides positively impacts the lives of many in a community in the developing world. Bicycles for Humanity created programs to help people in developing countries with the gift of mobility that a bicycle provides as well as the gift of education, data gathering and tele-health which a tablet enables in conjunction with a technology platform.

The B4H approach is to provide tools that empower people to take charge of their own situation to improve their lives. B4H ships bikes in containers that are turned into bike shops (Bicycle Empowerment Centres) and train local people to repair and maintain the bike. B4H has over 50 chapters of volunteers in the developed world that collect bikes and send them to B4H partners in Africa, Mexico and Central America. To date B4H have grown to over 50 chapters, established over 125 Bicycle Empowerment Centres and in total delivered about 100,000 bicycles to Africa.

B4H's initiative has also helped direct 25,000 bicycles a year away from the landfill with the estimated 10 million bicycles landing in landfills every year.

#### 2.0 DONATION OF BICYCLES

Each bike container sent overseas by B4H is known as a 'Bicycle Empowerment Centre' and it is a bicycle shop-in-a-box with stock of 450-500 bicycles, tools, spare parts and comprehensive training material on bicycle maintenance designed to empower people and their communities with transportation and the means to maintain it. B4H tries to match each Bicycle Empowerment Centre with bikes of similar model and the City currently has twenty-five (25) bicycles through Police recovery that meet the specifications of B4H's request.

The standard process when the Burnaby RCMP recovers stolen property is to retain the property for a defined period to allow the rightful owner to claim the property. If the property remains unclaimed by the rightful owners, the property is turned over to the City as surplus goods. The City periodically sends the goods to auction and the auction proceeds are returned to the City as sundry revenue. Over the last three auctions that included bicycles, bikes sold on average for approximately \$25 each. The value of the twenty-five (25) bicycles proposed to be donated to B4H are estimated to have a total value of \$625 before auction costs.

The City's donation to B4H will help empower the people in the developing country to drive initiatives. If approved the donation of bicycles will help impact many aspects of a community in a developing country as bicycles provide mobility giving people better access to education, healthcare, fresh water and economic opportunity. B4H volunteers will organize the logistics for the pickup of these bicycles from the City and arrange for the shipment to Africa. All responsibilities for the transport of the bicycles will be transferred to Bicycles for Humanity.

It is recommended that Council approve the donation of twenty-five (25) surplus Police recovered bicycles to Bicycles for Humanity (Vancouver Chapter).

Dear City of Burnaby Mayor and Council,

My name is Lyda Salatian, I'm the founder of the registered charity Green Teams of Canada. In 2011, with just a laptop, a passion for the environment, I started a volunteer group on social media called the Lower Mainland Green Team. We organize and deliver hands-on outdoor habitat restoration activities in Metro Vancouver using social media to recruit and engage volunteers. Activities are run in collaboration with park staff and existing environmental and stewardship groups, who provide local knowledge and expertise in ecology and habitat restoration. Activities include: removing invasive plants, planting native plant species and picking up litter. Issues we address include:

- Rapid loss of biodiversity; BC is home to more native species than any other province;
- Lack of awareness and education of the threat of invasive species on biodiversity;
- Less time spent in nature and more time spent in front of TVs and computers;
- Lack of younger volunteers in existing stewardship groups;
- Insufficient park staff capacity to care for parks adequately (i.e. to control the spread of invasive species).

Our objectives are: Educate about local environmental issues; engage a new urban volunteer base (aged 12-45); conserve, restore and enhance ecosystems, connect volunteers to nature, connect volunteers to existing stewardship groups; and be a resource to park staff. We run activities for youth, at-risk and special needs youth during school hours and for the general public on weekends. In 4 ½ years we have run over 200 volunteer work parties, and grown to become BC's largest volunteer environmental group (our volunteer base is at 2,300). We have received: the National Earth Day Hometown Heroes Award and three local awards: the Frank Sanford Award from Nature Vancouver, a YWCA Distinction Award for Environmental Sustainability and non-profit award from Recycling Council of BC for providing services beyond expectations in environmental stewardship. Media outlets such as television, radio stations, newspapers and magazines have featured the amazing work of the volunteers!

Our biggest challenge is securing long term funding. Our budget to organize and run 60 activities in municipal, regional and provincial parks between Aug 1 2015-July 2016 throughout Metro Vancouver is \$97,255.

So far, we have not received any funding from local municipalities for our services. If we do not secure longer term funding soon we will not be able to continue running any activities at all, so we are seeking funding from local governmental agencies. We request \$4,000 from the City of Burnaby annually. We will provide a report each year so you may assess whether you wish to continue funding us. Your funds will ensure we can continue engaging volunteers in the restoration and conservation of your parks and offers the following benefits to you:

- A strong message to thousands of volunteers and the public that your municipality values and supports volunteerism:
- Promotion of your municipality's parks and park stewardship programs;
- Promotion of your municipality's local stewardship and watershed groups;
- Additional capacity for park staff and existing stewardship groups to conduct conservation and restoration work;
- A partnership with a charity who can help access funding (i.e. from Foundations) not typically open to municipalities for resources such as native plants and trees and interpretive signs;
- Media exposure for supporting an innovative grassroots initiative.



#### **Executive Summary**

Since 1996 the City of Burnaby has awarded Burnaby Community Services with an annual grant to administer a portion of the Burnaby Recreation Credit program.

Currently, the grant is provided in two installments:

- (1) A fixed \$17,000 annually to reflect the fixed costs of the program (such as office space, office equipment & supplies, telecom, insurance, staff salaries and benefits, and other expenses).
- (2) With a supplemental grant at the end of the year of \$4 per approved application to reflect variable costs (such as printing & reproductions, postage and additional staff hours).

#### Background

Founded in 1971, Burnaby Community Services is a charitable society providing people who need support with a voice, resources and opportunities. We believe change can only occur when people are empowered to improve their lives and their community. Currently we offer a range of programs and publications to support families with low income and isolated seniors.

Since the fall of 1996, Burnaby Community Services has assisted *Burnaby Parks, Recreation and Cultural Services* by administering income verification services for the Burnaby Recreation Credit program. The Recreation Credit program provides low- income residents with credits that can be used towards various programs and admissions offered through Burnaby Parks, Recreation, and Cultural Services.

Burnaby Community Services is responsible for:

- providing intake of application forms from low income individuals, families and seniors, and those on Long Term Disability or Canada Pension Plan;

I would like to thank you so much for your consistent support in the past years. Prior to 2014 we submitted three community grant applications throughout the year. Last year we submitted a single grant application to cover these three requests. Following this approach, please consider this 2015 application for:

- (a) \$15,000 grant to help support our Camping Bureau program and various publications;
- (b) \$8,000 grant to support the Seniors Transportation program; and
- (c) \$5,000 grant to support the Burnaby Christmas Bureau.

Your funds have allowed us to make a meaningful impact in the lives of Burnaby residents. We utilize these funds to empower people to improve their lives and their community.

Founded in 1971, Burnaby Community Services is a charitable society providing people who need support with a voice, resources and opportunities. Currently, we offer a range of programs and publications to support families with low income and seniors experiencing isolation.

We have a variety of programs that help us achieve our mission, including (but not exclusively):

#### **Burnaby Camping Bureau**

Burnaby families with low income have the opportunity to send their children to an organized summer camp that they would not otherwise be able to afford. In 2014, we provided 303 children with \$64,932 in subsidies.

#### Seniors Transportation

In 2014 our volunteers drove 70 seniors to 570 medical appointments, a 170% increase over 2013. This increase is largely due to the significant partnership with Citizen Support Services and the Burnaby Better At Home program. However, over 38% of our clients are not subsidized through Better at Home.

#### Christmas Bureau

We are again very grateful to the City of Burnaby for providing the use of 7252 Kingsway (the old Kingsway Library) for the 2013 and 2014 Christmas Bureau Toy Room. Your generosity allowed us to reach 3,150 people—including 1,487 children and 137 seniors—and distribute \$188,470 in gifts.

#### **Publications**

We published and distributed 93,550 guides in 2014. These brochures and cards to ensure that everyone in our community has access to resources and support:

60,000 Community Resource Guide, a listing of programs and services in Burnaby and New Westminster, were distributed on partnership with the Burnaby Now.

12,000 Ready, Set, Learn Brochures, a mapped resource guide of services for families with children birth to 5 years old, were printed in collaboration with the Burnaby School District.

5,000 Middle Childhood Matters Brochures (previously only available on-line), a mapped guide to services for Burnaby families with children between the ages of 6 to 12 years.

15,000 Seniors' Guide to Health & Wellbeing, a guide to services for seniors, published in collaboration with the Burnaby Now.

1,350 Seniors Resource Cards, a guide to services for seniors at-risk.

200 Community Outreach Resources Cards, a weather-resistant guide for those who are homeless or at-risk of homelessness, were distributed in partnership with Progress Housing and the Burnaby Task Force on Homelessness.

#### New advocacy programs

In 2014 we began a new series of programs and partnerships to help people access services and break the cycle of poverty. The new programs included a *Community Volunteer Income Tax Program* and the pilot of a new *Form Completion Assistance* program that combined helped 513 people; and partnerships with *Access Pro Bono* and UBC's *Law Students' Legal Advice Program* to deliver legal advice and law clinics.

#### **Brentwood Community Resource Centre**

On May 2<sup>nd</sup>, 2014, Burnaby Community Services, along with the City of Burnaby, the YMCA of Greater Vancouver, MOSAIC Settlement Services and Burnaby Meals on Wheels, opened the new Brentwood Community Resource Centre. The Brentwood CRC provides support and resource to meet the diverse needs of one of the fastest growing communities in the Lower Mainland. We offer programs for children, families, youth, seniors and newcomers.

In collaboration with the Burnaby Public Library and Literacy Now Burnaby we have introduced very popular *Book Swap Library* and the Brentwood Community Resource Centre. We expanded the program during the Burnaby Christmas Bureau to ensure every child received a new book.

- 4. If parking needs to be removed the City will install "no parking special event" signs Because it is a Sunday, parking meters wouldn't be an issue.
- 5. The City would install 2 informational signs, 1 on Bonsor and 1 on Bennett, 1 week prior to the event regarding the road closure.
- 6. Transit would need to notified as this is a bus route.
