(a) Maura Fitzpatrick, Children of the Street Society
Re: Sexual Exploitation Affecting Children and Families in Burnaby
Speaker(s): Maura Fitzpatrick, Fundraising Manager

<u>Maura Fitzpatrick</u>, Fundraising Manager, Children of the Street Society appeared before the Committee providing information regarding workshops being offered in Burnaby schools that are bringing awareness to sexual exploitation and trafficking of children and youth. The speaker advised that prevention and early intervention toolkits are provided as a means of educating parents to help them recognize the warning signs to safeguard their children. Ms. Fitzpatrick noted that sexual exploitation is on the rise with 12 – 14 year old children reporting their first experience of being exploited through the sex trade.

The speaker advised their highly successful school-based program TCO² (*Taking Care of Ourselves, Taking Care of Others*) which focused on human trafficking was delivered 31 times to 800 children in Burnaby. In addition, TCO² Workshops were presented to every resident at the Burnaby Youth Custody Centre and groups considered high-risk, including alternate education programs, youth-groups, gang diversion programs, residents of youth custody, ESL and new immigrant youth. The speaker emphasized that these workshops are equally important for members of the community, parents and caregivers to help educate against these anonymous predators.

Ms. Fitzpatrick expressed concern with the advent of new technology as sexual exploitation has dramatically shifted online. Increased reports of child luring, bullying and online photos going viral have caused a great deal of pain and suffering. Numerous requests have been received for presentations to audiences starting as young as grade 5, with requests now being received from grade 4 teachers.

Ms. Fitzpatrick requested consideration by the Committee for a grant in support of funding four workshops in Burnaby at a cost of \$500 per workshop.

The Chair recognized the value of the work being carried out by the Children of the Street Society and thanked Ms. Fitzpatrick for her informative presentation.

4. <u>DISCUSSION</u>

a) Lease Grants, Tax Exemptions and Other City Contributions to Service / Non-Profit Organizations

The Chair advised that the Committee would like to establish structure around the Terms of Reference, consistency for awarding grants and receive greater background detail to assist in their evaluation of support. In addition, the Chair requested that organizations be required to clearly communicate all funding support received from the City of Burnaby in their annual financial statement.

The Director of Planning advised that Council in 1992 set guidelines around Resource Centre applications and subsidies which are adjusted annually for inflation. Also, the lease renewal grant process stipulates that organizations must recognize the City of Burnaby and use the City logo in advertising. However, staff noted that the current process does not confirm if they are using the City logo though steps can be taken to mandate a more formal process.

The Director of Parks, Recreation and Cultural Services noted that Festival Grants recipients are given specific instructions they must adhere to with follow up. After each event, staff ensures they have met the required criteria.

The Chair requested that Finance create a spreadsheet that will ultimately publish subsidies and grants allocated annually by the City of Burnaby.

PURPOSE:

To propose an adjustment to the allocation of non-profit office/program space at

the Brentwood Community Resource Centre.

RECOMMENDATIONS:

1. **THAT** Council authorize an adjustment to Burnaby Community Services Society's lease space allocation to permit Burnaby Seniors Outreach Services Society to occupy 117 square feet (room L2 – meeting room 2) at the Brentwood Community Resource Centre, as outlined in *Section 3.0* of this report.

- 2. **THAT** Council authorize the execution of adjusted 2016 lease grants for Burnaby Community Services Society and Burnaby Seniors Outreach Services Society, as outlined in *Section 4.0* of this report.
- 3. **THAT** Council authorize staff to undertake the necessary lease arrangements between the City and the tenants.
- 4. THAT Council authorize staff to issue a Request for Proposals to occupy space vacated by Burnaby Seniors Outreach Services Society at the Holdom Community Resource Centre.

REPORT

1.0 INTRODUCTION

In 2015 September, Burnaby Seniors Outreach Services Society (BSOSS), through the Licence Department, submitted a letter of request to move from their allocated space at Holdom Community Resource Centre to a space in the Brentwood Community Resource Centre.

BSOSS has indicated to City staff that it is seeking a smaller space than it currently occupies at Holdom Community Resource Centre due to staffing decreases and a reduction in its funding. The proposed move to a space at the Brentwood Community Resource Centre is preferred due to the initiation of a long term partnership between Burnaby Seniors Outreach Services Society, Burnaby Community Services Society (BCSS) and Burnaby Meals on Wheels to deliver a

continuum of seniors' service. Through this partnership, BCSS is also seeking Council permission to provide BSOSS with the subject portion of its space, Room L2 – Meeting Room 2 and a portion of its common area, at Brentwood Community Resource Centre.

BSOSS currently occupies 570 square feet at Holdom Community Resource Centre, which, if its proposed move is approved, would then become available for lease to another organization.

2.0 GUIDELINES FOR THE USE OF SPACE

In 1990 July, Council established policy guidelines for the use of space at the City's resource centres. As indicated in the guidelines, the space is intended to accommodate community groups whose primary purpose is to provide facilities, services or programs intended to promote the physical, social and mental well-being of individuals and families in Burnaby. The guidelines also seek to encourage a broad range of services within each Resource Centre.

3.0 PROPOSED CHANGE IN OCCUPANCY AT BRENTWOOD COMMUNITY RESOURCE CENTRE

Room L2 – Meeting Room 2 is 117 square feet in size and located on the second floor of the Brentwood Community Resource Centre. It comprises a portion of the total floor area of 1,984 square feet leased to BCSS. The space was allocated to BCSS in 2013. As part of the new partnership between BCSS, BSOSS, and Burnaby Meals on Wheels, BCSS is requesting to release a small portion of its leased area to enable BSOSS to work with them from a common location. The combined floor area, including its share of common space of 71 square feet, proposed to be released to BSOSS is 188 square feet. The move to a smaller space would also better meet the needs of BSOSS's reduction in staff and funding.

If the proposed changes were adopted, new lease agreements would be required for BCSS and BSOSS. The joint operating agreement between all tenants at Brentwood Community Resource Centre would also need to be amended to include BSOSS as a tenant.

4.0 LEASE GRANT CHANGES

In 1992 April, Council approved guidelines for the issuance of grants to offset lease rates for non-profit groups allocated space at the City's Community Resource Centres. In general, tenants at the resource centres can qualify for a grant to offset their lease costs depending on the extent of service provided to Burnaby residents. Where 75 percent or more of the recipients of programs or services of the non-profit group are Burnaby residents, a tenant can qualify for a full lease grant to offset lease costs by 50 percent. Where 25 to 75 percent of service recipients are Burnaby residents, a group can qualify for a partial lease grant to offset costs by 25 percent.

At its meeting of 2015 March 30, Council approved a 2016 lease rate for City-owned non-profit office/program space of \$12.81/square foot per annum. In addition, at its meeting of 2015 September 28, Council approved lease grants for eligible tenants, based upon the above guidelines.

Based on the proposed space reallocation described above, BSOSS and BCSS have both, through their lease grant applications, successfully demonstrated eligibility for a 50% lease grant.

As such, Table 1 *below* indicates the proposed adjusted lease grants for BSOSS's 188 square feet of space in Room L2 – Meeting Room 2 and BCSS's adjusted lease area of 1,796 square feet at Brentwood Community Resource Centre, based on the approved guidelines.

5.0 NEXT STEPS

With Council approval of the proposed adjusted allocation and 2016 lease grants, staff will begin preparations of the lease documents and arrangements for the tenants to be able to occupy the spaces. The anticipated occupation date would be 2016 January.

If given approval, the Finance Department will adjust the monthly lease charges for the benefiting organizations to reflect the approved grant amount.

In addition, should Council approve the proposed changes, staff request Council's authorization to issue a Request for Proposals to find a new non-profit tenant to occupy space vacated at the Holdom Community Resource Centre by BSOSS.

6.0 CONCLUSION

Burnaby Seniors Outreach Services Society (BSOSS), in consultation with Burnaby Community Services Society (BCSS), has requested to move from its allocated space at the Holdom Community Resource Centre to the Brentwood Community Resource Centre to facilitate a new partnership between BSOSS, BCSS and Burnaby Meals on Wheels, as outlined in Section 1.0 of this report. Both BCSS and BSOSS are current tenants in the City's Community Resource Centres and meet all of the City's guidelines for allocating space within these facilities.

It is recommended that Council be requested to approve the adjusted allocation of space at Brentwood Community Resource Centre, reducing BCSS's allocated space and authorizing BSOSS to occupy Room L2 – Meeting Room 2. The requested space adjustment would require new lease agreements and approval of adjusted 2016 lease grants as outlined in Section 4.0 of this report. It is therefore recommended that Council authorize staff to undertake the necessary lease and lease grant arrangements between the City and the tenants. Finally, it is also recommended that Council authorize staff to issue a Request for Proposals to find a new tenant for the resulting vacancy at the Holdom Community Resource Centre.

This program, accommodating kids between the ages of 5 and 18, is offered from April to August; encourages kids and youth to play and engage in active sports twice weekly; and coordinates invitational soccer tournaments and exhibition games. The grand finale of the program occurs during the annual festival.

The African Canadian Soccer and Cultural Association (ACSCA) is a community non-profit organization that serves the African Community and Friends of Africa in Metro Vancouver through the organization of events that promote and preserve the African Culture and provide an avenue for socialization and the exchange of ideas.

The application has been completed in full and the applicant has shown evidence that they have the capacity to coordinate the event. Festivals Burnaby funds would be allocated toward eligible project expenses related to programming, marketing/promotions and administration.

Our team just finished a highly successful season of league play in the Burnaby/New Westminster district. We have been consistently ranked in the top 5 in the provincial high school AAA boys' volleyball rankings, currently ranked #4 and reaching as high as #3 in the Province. We entered UBC's annual Highschool tournament placing top in the 6 and placed 2nd in the Douglas college tournament. We were undefeated in league play, finishing in first place and not losing a set through the entire season of league play. The championship title match was played on November 10, 2015 versus the Burnaby North Vikings. Moscrop defeated Burnaby North in the best of 5 set final in 3 straight sets to win the Burnaby/New Westminster championship trophy on our home court.

Good morning Chad,

I hope my email finds you well, and I hope you don't mind me asking you a question about the City of Burnaby's grant process for non-profits.

I'm loving my new position at Children of the Street Society, we are small, but provide a province-wide service through our school-based prevention workshops that give kids (from elementary age to high-school) the information and practical tools they need to learn how to be safe from sexual exploitation. Last school year, we saw almost 1,400 kids through 48 workshops in Burnaby alone; province wide we saw over 26,000 kids.

In addition to our prevention programs, we also provide support and referral services to children and families already affected by this issue. My new boss, Diane Sowden tells me a city employee, Joan Selby, knows us well and could tell you more about what we do.

While we are receiving support from other cities (Coquitlam, Langley, Richmond, Vancouver), for the workshops we provide in those communities, I wondered if we might qualify for one of the grant categories (C, D, or E? attached) to provide our workshops in Burnaby.

Chad, I realize we missed the grant deadline for this year, but we'd be interested in applying next year. Do you know anything more about this process that might be helpful? Is there someone I could speak to that would explain the categories (C, D, E) in the attached document, so we can determine which one, if any, might fit our organization and the work we do in Burnaby?

1. PURPOSE OF ORGANIZATION

Children of the Street Society was Incorporated under the British Columbia Society Act in 1995 and is a registered charity under the Income Tax Act. The Society is dedicated to increasing public awareness in order to prevent the sexual exploitation of children and youth. The Society provides education and awareness workshops to various groups each year throughout the province of British Columbia. The workshop participants include: students, teachers, school administrators, Parent Advisory Councils, parents, foster parents, Aboriginal communities, multi-cultural groups, police, social workers, drug and alcohol counselors, nurses, hospital staff, government officials and other community members.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Society prepares its financial statements in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO).

Revenue Recognition

The Society uses the deferral method of accounting for contributions under which restricted contributions related to expenses of future periods are deferred and recognized as revenue in the period in which the related expenses are incurred. All other contributions are reported as revenue of the current period.

Investment income is recognized as it is earned.

The accounts of the Society are maintained on the accrual basis with respect to grant related expenditures. Other sources of revenue, such as donations, are recorded on a cash basis.

Tangible Capital Assets

Tangible capital assets are stated at cost less accumulated amortization. Amortization is provided annually at rates and methods over their estimated useful lives as follows, except in the year of acquisition when one half of the rate is used. Estimates of useful lives of the assets are reviewed every year and adjusted on a prospective basis, if needed.

Use of Estimates

When preparing financial statements according to ASNPO, the Society makes estimates and assumptions relating to:

- Reported amounts of revenue and expenses
- · Reported amounts of assets and liabilities
- · Disclosure of contingent assets and liabilities

Management's assumptions are based on a number of factors including historical experience, current events and actions that the Society may undertake in future, and other assumptions believed reasonable under the circumstances. Actual results could differ from those estimates under different conditions and assumptions.

Contributed Materials and Services

Volunteers contribute an undetermined number of hours per year to assist the Society in the delivery of programs and services. Because of the difficulty of recording and determining their fair market value, contributed services are not recognized in the financial statements.

4. RENT

The premises are leased on a month to month basis. There is an agreement in place where the Society will give the landlord a donation receipt for a reduction in rent. This donation receipt is recorded as income and as a rent expense. The receipt given for the current year was \$5,920 (prior year = 5,920).

5. GAMING FUNDS

Gaming funds are received in the form of a Community Gaming Grant from the B.C. government. These grants are provided to eligible organizations for direct delivery of approved ongoing programs to their communities. One of the conditions of the grant is that the funds must be kept separate from other money raised by the Society. The funds are restricted to expenditures identified in the application, but those funds not spent during the year are recorded by the organization as deferred contributions.

I am pleased to submit a request for grant support for consideration by the members of the Executive Committee of Council.

For over 20 years, our Society has been working to keep children and teens safe from sexual exploitation and human trafficking (forced prostitution). Of course, no one likes to think about a child or teenager being sexually exploited, but the sad fact is, it happens, every single day, in communities all around B.C. No community is immune.

Every year, we present over 600 workshops for children (aged 10 to 18) in schools all around B.C. Over the years, we have presented over 270 workshops for more than 9,600 children in Burnaby. Our workshops are delivered by young adults, who use skits, multi-media, and engaging activities which makes the information very relatable to students.

As a non-profit organization, we are only able to provide our programs and services through the funds we can raise in the communities we serve. We are hoping the City of Burnaby will help us protect its young residents by providing a grant to support four of our Burnaby workshops this school year.

In addition to education and prevention, our workshops give children a safe space to share what is or has happened to them. Every year, our workshop facilitators receive between 30-50 disclosures from children. We make sure they receive the support and referral services they need.

Our Society is the only organization in B.C. providing prevention education in schools. Each year we have more schools wanting workshops, and every year, due to lack of funds, we are forced to create wait lists. A grant from the City of Burnaby would help us reach more children and teens in Burnaby schools. We hope we can count on your support.



Executive Summary

The issue

The statistics are shocking, but true. In North America, 300,000 children are sexually exploited each year. As many cases go unreported, most experts agree, this astonishing number is actually many, many times higher.

The facts are equally disturbing. Canada remains 2nd in the world (U.S.A. is 1st) to hosting the most child sexual abuse images online. Metro Vancouver has been identified as a 'destination' for travelling sex offenders who come primarily from the U.S.A.

Sexual exploitation is a direct form of human trafficking and is the sexual abuse of children and youth. It involves the exchange of a sexual act for money, drugs, food, shelter, transportation, love, acceptance or any other consideration.

"I was like a dog. I sat when I was supposed to sit. I barked when I was supposed to bark."

Exploiters and child predators are now using the internet as a tool to identify and lure children.

In September of 2014, Vancouverite Reza Moazami, received B.C.'s first ever conviction for human trafficking. He used social media tools like Facebook to lure 11 female victims, some as young as 14, to his home where they became his prisoners, forced into a life of sexual slavery.

Last year, just two days before she was set to leave, we were able to prevent a Burnaby teen from boarding a plane to meet a young man she had met on Sugardaddy.com. The man had paid for her plane ticket to New York and promised her a shopping trip, and if they got along, he'd take her on a vacation to the Dominican Republic. We met with her and helped her realize and understand the danger in this situation – like most 16 year olds she wasn't thinking things through.

Many media reports of bullying, are actually related to child sexual exploitation. Increasingly, children and youth are talked into sending sexual images of themselves (called 'sexting'), only to later find out that these images have been sent to others, and can never be totally 'erased' from the internet. One poor decision can stalk a child for their lifetime.

Our work

Children of the Street Society is a non-profit organization formed in 1995 by a group of concerned community members who wanted to develop programs and services to help deal with the growing number of children and youth being sexually exploited.

Now, 20 years after our inception, our Society is still the only organization in B.C. that provides preventative education for children, youth, and adults on the issue of child sexual exploitation and human trafficking. In B.C., we are the recognized leader on this issue, and often provide educational workshops and services for other organizations who work with children and youth.

We work in collaboration with a wide variety of organizations. In fact, the following groups provide annual training for our workshop facilitators, providing them with the most up-to-date information available regarding child/youth sexual exploitation and human trafficking:

- PLEA Society
- Experiential survivors (those who have exited sexually exploitive situations),
- Family Services of Greater Vancouver, Youth Detox Program,
- Office to Combat Trafficking in Persons (OCTIP) B.C. Ministry of Justice,
- Lower Mainland Purpose Society,
- RCMP Human Trafficking & Internet Child Exploitation Units,
- · Salvation Army Deborah's Gate,
- Vancouver Police Department Counter Exploitation Unit (CEU), Transit Police Gang Crime Unit, and Yankee 20 High Risk Youth Car.

The Critical Importance of Children of the Street Society

With the advancement of technology, online sexual exploitation of children and youth is exploding. In fact, many recent cases that have been identified by the media as "bullying", are actually related to sexual exploitation. Here are some startling facts:

- Four million children post content to the internet each and every day.
- 49% of teens who post pictures to the internet report being contacted by a stranger.
- 75% of youth have received an online solicitation for sex and DID NOT tell a parent.
- 12-14 years of age, is the average age of children who have been sexually exploited.

Children of the Street Society must expand our programs and services in order to meet the growing demand from communities throughout B.C. for our services. From our inception, our work has always been guided by our vision:

"A world where children and youth are safe and free from all forms of sexual exploitation."

The programs we create and the services we provide are all designed with this vision in mind. We take a proactive approach through providing awareness, education, and early intervention

strategies with the goal of preventing sexual exploitation. In addition, we provide support to children and their families who have already been affected. Specifically:

- We educate and raise awareness through our TCO² workshops (Taking Care of Ourselves
 and Taking Care of Others) and training sessions delivered in schools to students, parents,
 teachers, and caregivers. Our workshops are tailored to the needs of the audience, are age
 appropriate, and provide clear examples and useful tools that help children and youth learn
 how to be safe from sexual exploitation.
- We advocate for change by working with all levels of government to ensure laws are created or changed to protect young people, and prevent sexual exploitation in all forms.
- We support youth and families through early intervention services for at risk youth. We
 will always be there for children and families who have already been affected by sexual
 exploitation, by providing non-judgemental support, resources, and referrals for
 intervention and other services.

The Opportunity - Help Us Reach More Kids in Burnaby

During the last school year, our Society conducted over 600 TCO² workshops for over 27,000 kids in communities all around B.C. Specific to Burnaby, we provided 31 workshops for almost 800 children and teens. We visited four secondary schools (Burnaby Central, Burnaby South, Byrne Creek, and Cariboo Hill), went to two elementary schools (Cameron, and Clinton) and also presented workshops at Burnaby Youth Hub and Burnaby Youth Custody Centre.

Our workshop facilitators use monologues, role-plays and multimedia to interact with the children (ages 10-18) in meaningful discussions about what sexual exploitation is, how to recognize it and how to prevent it from happening to themselves and their peers.

Every year, at the end of our workshops, we have kids who linger, waiting for their classmates to leave, then they approach our workshop facilitators and share what is or has happened to them. We always make sure they get the support and referral services they need. Last school year, we received 48 disclosures during workshops.

Despite the number of children and youth we reach annually, <u>every year we have a significant</u> <u>wait list of groups and organizations requesting our workshops</u>. Unfortunately, we never have enough resources to meet the demand.

We don't want to turn anyone away or tell students we will put their school at the top of the list for next year's workshops. Many kids need help now.

Your Investment Changes Everything

A grant from the City of Burnaby would help us provide our workshops and reach more children and youth in Burnaby to give them the information and practical tools they need to be safe and free from sexual exploitation. The costs for one TCO² workshops is \$500.

Will the members of the Executive Committee of Council consider giving their endorsement for a grant to assist with funding some of our workshops in Burnaby?

We would be happy to work with you to acknowledge your support in a way that most appropriately reflects your generosity and leadership in the community.

Examples could include:

- Acknowledgement on our Donor Wall, which is located on our website.
- · Recognition in our newsletters and annual report.
- Media releases to recognize and publicize the City of Burnaby's support.
- An invitation to our annual Celebration of Success event held in March.

In addition, we will provide you with annual reporting of your donation, so that you can clearly see the impact your investment has had on children, youth and families in Burnaby.

We can provide you with specific information on the schools we reached and the number of students we were able to educate. As students and staff fill out evaluation forms and provide comments and feedback, we can provide you with measurements with respect to the effectiveness of our workshops.

We are pleased to answer any questions you may have, and hope the City of Burnaby can help us prevent the sexual exploitation and trafficking of Burnaby children and youth.

7. FINANCIAL INSTRUMENTS (continued)

Interest Rate Risk

The Society is exposed to interest rate risk with respect to the following financial instruments: cash and cash equivalents. Changes in interest rates can affect the cash flows related to interest income and expense.

Liquidity Risk

The Society is exposed to liquidity risk in meeting its obligations associated with financial liabilities, which is dependent on receipt of funds from contributors and continued support by financial institutions providing sufficient operating lending facilities.

8. CONTRACTUAL OBLIGATIONS

On December 17, 2009, the Society engaged in a 5 years lease agreement of a copier machine. Monthly payment is \$272, and the lease expires in December 2014. In December 2014, this agreement expired, and the Society signed another 5 years lease agreement of a new copier machine. Monthly payment is \$250, and lease term is from November 2014 to November 2019.
