The Chair introduced Ms. Bethany McGoldrick and Ms. Serena Mawani as the newest Citizen Representatives to the Public Safety Committee.

2. **MINUTES**

a) **Minutes of the Open meeting of the Public Safety Committee held on 2016 January 14**

3. **PRESENTATIONS**

a) **Burnaby RCMP Bike Squad for 2016**

Supt. Stephen Drolet and Corporal Brad Gibson appeared before the Committee to provide an overview of the pilot project for the 2016 Burnaby RCMP Bike Squad.

Supt. Drolet highlighted the mandate and staffing for the 2016 Burnaby RCMP Bike Squad, noting that the project will run fulltime from 01 May until 31 October 2016. The RCMP will use existing resources that have been specifically trained for the uniformed Bike Squad.

Duties of the Bike Patrol will include:

- Community engagement through special events and high visibility patrols;
- Crime reduction activities through proactive enforcement of hotspots and problem areas; and
- Operational Policing by assisting General Duty on files, ability to project police presence in areas difficult to access and low profile asset when required.

The team structure of the Bike Squad will consist of one Corporal, one Senior Constable and four Constables. The team will be engaged in day and evening shifts with the ability to adjust shifts based on priorities of the department.

Three objectives have been identified to define success:

- Operational Policing – number of enforcements, number of calls serviced as primary assisting unit and number of self-generated files

- Community Engagement – number of hours spent conducting high visibility patrols and number of community events/festivals attended
- Crime Reduction – number of hours spent patrolling hot spots as defined by Crime analyst, number of street checks conducted and number of Offender Management checks conducted

Assessment will be conducted by a Steering Committee consisting of an Operational Officer and four Non-Commissioned Officers from all business lines. The assessment will include:

- Daily reporting of the Bike Squad;
- Monthly review to assess effectiveness, impact on other activities and readjust as necessary; and
- End of project comprehensive review to determine operational effectiveness, impact on other programs and determine feasibility including recommendations moving forward.

The RCMP will be reporting back to the Committee on the outcomes of this pilot project.

a) Memorandum from the City Clerk
Re: Consultation About Revisions to the Emergency Program Act, RSBC 1996 (The Act)

Correspondence was received from the City Clerk regarding the consultation of revisions to the Emergency Program Act, RSBC 1996 (The Act). The report provided Council with staff comments and suggestions in response to the Ministry of State for Emergency Preparedness' document, *Prepared and Resilient: a discussion paper of the legislative framework for emergency management in British Columbia*.

***Councillor Kang, retired from the meeting at 6:46 p.m. ***

The discussion paper was reviewed by staff and they supported a majority of the changes and findings by the Provincial Ministry; however, Discussion 6, *Ministerial authority to direct emergency planning*, is not supported by staff. The proposed change increases provincial authority over local government emergency planning and emergency plan content. This would have the potential

to not only usurp a local authority's power to make decisions on and control emergency management programs and plans for their jurisdiction, but also cause a local authority extraordinary financial burden.

***Councillor Kang, returned to the meeting at 6:50 p.m. ***

Lambert Chu, Acting City Manager informed the Committee that the City's Emergency Management office coordinates training, planning for emergency management and provides support to the City's Emergency Operation Centre in the event of a major disaster. Mr. Chu advised that the report, outlining the staff's comments and recommendations, has been submitted to the Province.

5. **MONTHLY REPORTS**

a) District #1 - March 2016

Mr. Wong, Chair, District #1 provided a monthly report advising that the Heights Merchants Association has been encouraging merchants to report crime to the RCMP. Reporting of crimes will bring awareness to the issues and assist the RCMP with mitigation of the crimes.

The Community Response Team and the Heights Merchants Association are working with drug users in the area to initiate and promote a safe syringe disposal program.

Hats Off Day is scheduled for Saturday, June 04.

b) District #2 - February 2016

Ms. Oraziotti, Chair, provided a monthly report of activities that took place in in District #2.

Ms. Oraziotti expressed gratitude for the support and guidance District #2 has received from the Burnaby RCMP. The Business Watch and Crime Prevention teams have been very proactive with a series of awareness seminars, including Senior Fraud, Financial Fraud Awareness and Digital Tips.

The RCMP has also provided assistance and strategies to a local business owner who is experiencing an inordinate number of merchandise thefts.

Student representatives from Burnaby North Secondary and Burnaby Mountain Secondary schools are continuing to forward crime prevention information to their student communities through Crime Prevention Clubs. Burnaby Mountain is currently undertaking an outreach/educational program with local feeder schools.

c) District #3 - January 2016

Ms. McQueen, Chair, provided a monthly report which summarized activities that took place in District #3.

District #3 has further implemented initiatives in the District to mitigate Theft of/from Auto to reduce crime levels. A more visible presence at the Edmond's Community Centre has also been implemented.

District #3 will participate in the EPIC Edmonds Clean Sweep on May 07.

d) District #4 - January and February 2016

Ms. Gates, Chair, provided a report summarizing activities which took place in District #4.

Ms. Gates highlighted discussions around the impact of homelessness throughout Burnaby. The RCMP are collaborating with the City to assist the homeless population through a stepped approach and information regarding community support. Staff at Bonsor Community Centre, the Bob Prittie Library and Metrotown Mall are receiving training to develop strategies to assist with members of the public suffering from mental health issues.

f) Graffiti - January February 2016

Cst. Murphy, Anti-Graffiti Coordinator, submitted a report highlighting activities that took place in January and February regarding the four elements of the Anti-Graffiti Strategy (Eradication, Education, Prevention and Identification and Deterrence).

Cst. Murphy, provided an overview of the Auxiliary Graffiti Training session that took place on 2016 February 23. The eight RCMP Auxiliaries who attend the

training session will take over the Graffiti Busters program at Burnaby Mountain Secondary and assist with establishing new Graffiti Busters' pilot programs in other Burnaby high schools. The team will also provide education packages to Burnaby businesses regarding Burnaby's Graffiti Program and participate in Graffiti Paint Outs.

The Graffiti Busters members at Burnaby Mountain Secondary are currently working on a comic book and a video highlighting the consequences of graffiti and the difference between graffiti and art. Once completed, the information will be presented to feeder schools.

On February 18, 2016 Burnaby RCMP hosted a Graffiti Task Force meeting with police and city employees from across the Lower Mainland to share common tags and in an effort to identify the offender(s) and determine where they are actively offending.

g) Fire - March 2016

Joe Robertson, the new Fire Chief, submitted a report summarizing fire department service delivery and programs. The department is currently in a stage of transition with the retirement of previous Fire Chief and an upcoming retirement of the Deputy Chief Operations.

A recruit class of eleven new members graduated on March 05. A mentorship program, unique to Burnaby, pairs mentors with new recruits to instill the right attitude, teach the right things and prepare the probationary firefighter to do the job correctly.

e) RCMP - January and February 2016

C/Supt. Critchley provided the Committee with an update regarding the five recent sexual assaults in Burnaby. C/Supt. Critchley advised that of the five assaults, three were gropings near Holdom, while the other two were violent assaults that transpired along the Burnaby Mountain Urban Trail.

The Burnaby RCMP are using various media forums to proactively warn the community regarding the assaults and to appeal for witnesses to come forward. Although a dedicated team is permanently in place to investigate all sexual assaults, the Task Force was struck to investigate the violent assaults that transpired on the urban trail.

C/Supt. Critchley thanked Susan Salame, Burnaby RCMP Crime Prevention Unit and Insp. Kathy Hartwig for the 'Safe Communities' education forums being offered throughout this year. The forums have been established to connect with and bring awareness to the community. On March 30 at Burnaby Mountain Secondary School, the Crime Prevention Unit will be hosting a personal safety

awareness presentation entitled 'How Safe Are You?'. Forums are also being offered on 'Senior Financial Fraud' at Bonsor Recreation Complex and a 'Community Safety Forum' at the Ismaili Centre.

In January and February the traffic section targeted high risk cross-walks to increase education and awareness regarding pedestrian safety. Auxiliary Constables handed out reflective decals to pedestrians. March is 'Distracted Driving' month and the traffic section will focus on ensuring safe streets and driving habits.

Thefts from and of autos has increased in District 1, 3 and 4; however, it has decreased in District 2. The crime statistics have also decreased in Robbery, Break and Enter to Businesses and Residential Break and Enters.

C/Supt. Critchley advised that harassment complaints are increasing due to the internet, Facebook and other social media forums.

PSC Report from D2

May 4th, 2016

As a result of the recent altercation with a firearm and a shop keeper, the person who heads up Security at Lougheed Mall (Clayton Roy) decided that training was needed to educate the tenants about minding their own personal safety. He put on 'Tenant Safety Training' sessions, using the resources of the Burnaby Business Watch team. He invited many business owners to attend his training sessions and also went door to door giving out their safety tips. He also has initiated a program where shop keepers who make their nightly deposits at the banks in the mall can get an escort to the bank, and also posts static guards at these banks. Additionally, any shoppers or staff who do not feel safe going from the mall to their vehicles at closing time or otherwise can call their "Safe Walks" program number and get a Security Guard escort out to their vehicle.

Our CPAC really takes advantage of the different police agencies sitting at the table. Transit Police are assisting the Burnaby RCMP around the recent incidents of sexual assaults in Burnaby and around the Skytrain system. Like CPAC, partnerships are the key to a safer community. Transit Police recognize the value of community partnerships and are in the process of implementing a new Community Service Officer to be assigned to the Lougheed hub. That person will be a part of the Lougheed CPAC meetings.

Transit Police also value the partnerships of the Lougheed CPAC in particular with the high school representatives. As personal safety being a concern for everyone in light of the recent attacks, the CPAC students from Burnaby Mountain Secondary did a personal safety campaign and did up posters. One of the posters was for the Transit Police Text Reporting and the other poster was for pedestrian safety. This proactive and positive relationship with the youth has been an incredible experience.



Partnerships! The BIA is hosting a small event at North Gate Village Mall on April 30th and is going to have a couple of the CPAC youth manning a Community Safety Table, giving away swag from the CN Rail Police program “See Tracks – Think Trains”; the Transit Police’s “See Something Say Something” giveaways (including their paper sky trains for kids to build) and the RCMP are supplying us with tattoos for the kids.

The RCMP are completely proactive in their response to the issues raised at our monthly CPAC meetings. Whether it is about the dial a dopers seen at different locations; the panhandlers at the local malls in the area who need moving along, people speeding through residential areas, helping business owners with their security issues or coordinating the involvement of the School Liaison Officers with the High School Safety Clubs - we get nothing but total support. All this is all a direct reflection on our cordial working relationship, which also has a trickle-down effect. One of our youth (Aki Ediriweera) is leaving high school for University in the fall, but he has got two replacements lined up who are excited about joining our CPAC in his stead. This just speaks to the synergy of the members at the table who are all dedicated to Community Safety.

On March 17, 2016, the Crime Prevention Unit hosted a Senior Fraud Awareness Forum at Bonsor Rec Centre, which was very well attended.

A member witnessed a purse snatching at Save-on Foods at Highgate Mall.

Highgate Security has found that the most effective way to lower crime seems to be educating the victims.

There still seems to be issues with the Hillside Gardens residents and the management and a meeting with the Ministry of Housing is possibly being set up in order to address these issues.

Chairperson report from CPAC District 4 April 26, 2016

- Senior Financial Fraud Awareness Forum held March 17, 2016 at Bonsor Recreation Complex was well supported and received positive feedback . A suggestion was received that fraud calls and emails enquiries that are received by the RCMP offices should be tracked even though they often originate offshore and RCMP may have limited ability to address them. These stats would be useful to determine how prevalent the problem has become. Files will be generated for reports where money has been exchanged.
- The March 30 forum , How Safe are You?, was well attended and a good reminder to follow safe practices when walking in our community...be aware, be visible, listen to your instincts
- April 13 forum focusing on Business Watch Information was not as well attended as hoped and will be repeated at a later date with further promotion of the event
- The Suncrest School Speed Watch Patrol on April 19, 2016 was noted to be of growing concern. Travelling east on Rumble St the drivers have travelled through the posted 30 km zone for the park and then enter into another speed zone sign for the school and continue to travel over the posted speed, 133 drivers exceeding the limits, 15 driving over 60km.
- Library continues to monitor racist and problem behaviours as they have experienced an increase of issues. Looking at Internet Only card for accountability of public computer users.
- I attended the Annual Performance Plan Planning Session to review the 2015 priorities for Burnaby and establish the 2016 priorities. Property Crime, Youth, Road Safety, and Violent Crime file remain priorities for policing resources.
- With help from the RCMP members working with the homeless some of the Library issues have improved since last month.

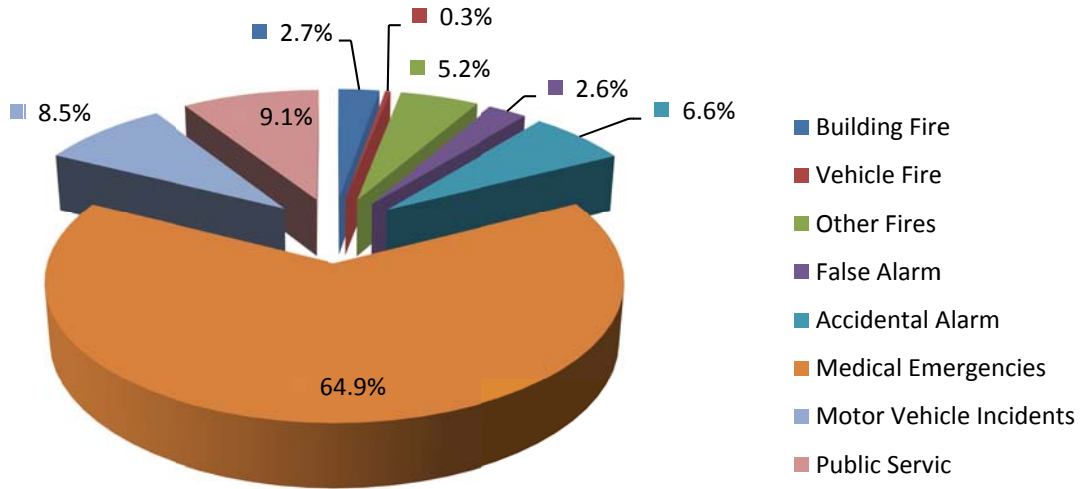

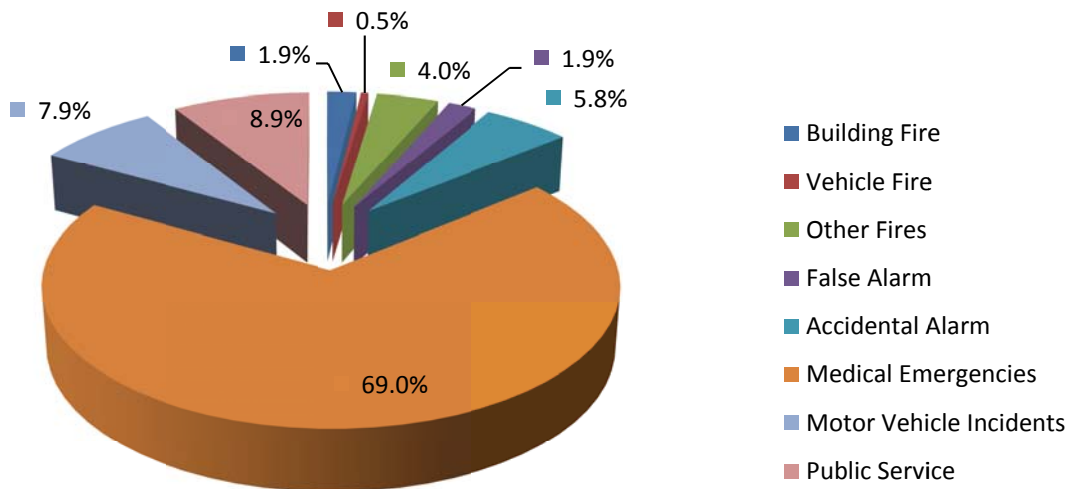

TRAINING

As the Fire Chief had previously mentioned in last month's report, the Training division is paramount to ensuring our members are trained to highest standards. This enables them to have the highest possible success rate when protecting our citizens, guests, property within the city and of course themselves as firefighters in potentially dangerous situations.

During our spring training block we achieved training 40 of our members in the topics of; Fire Officer 1, Fire Officer 3, Hazmat Technicians, Driver Training Instructors as well as First Responder Instructors.

FIRE PREVENTION

Fire Prevention and enforcement is a legal responsibility for the City and the Fire Department, so the focus of this Division is to comply with our obligations under the Fire Code. Due to long term illnesses the Fire Prevention Office has been understaffed for some time, but we are addressing these issues which will assist with the workload and better serve the community. FPO personnel make every effort to conduct as many routine inspections as possible.

Members from this Division did attend the Community Safety Forum at The Ismaili Centre on April 30, 2016 to provide some public education on fire safety and fire extinguishers. They also attended safety fair at Bill Copeland Sports Centre on May 4 to provide public education.

Message from the Chief



The May report covers all of March and the first two weeks of April. Each spring we host the Annual Performance Plan (APP) planning sessions with police and municipal staff and key community stakeholders gathering together to assist us in developing our local policing priorities for the upcoming year.

This year our five operational priorities are:

- ☐ Property Crime
- ☐ Mental Health
- ☐ Youth
- ☐ Road Safety
- ☐ Violent Crime



Our Crime Prevention Unit continues with their excellent work hosting a number of public safety events including a very well-attended and successful event for seniors on financial fraud with over 120 people attending.

You'll notice in this report an account from Cst. Shelby Murphy detailing our efforts to diminish the negative impact of graffiti. I'm pleased to say that with the help of our community partners including Burnaby high school students and the City of Burnaby we are tackling the issue of graffiti with a number of people recently charged criminally or facing significant bylaw fines.

There is little change in crime statistics for thefts from vehicles for March and April compared to the same time last year, although auto theft is up by 7 per cent. In our other key tracking areas, we are down in robberies by 18 per cent, break and enters to businesses are down 16 per cent while residential break-ins have dropped by 16 per cent.

It's been an emotional time in the policing community with the loss of Cst. Sarah Beckett who was killed in the line of duty in April. The 32-year-old left behind a husband and two small children and many friends and colleagues. By all accounts, Sarah was the kind of police officer that makes the RCMP great. Her loss will continue to be felt by many.

I'm very proud to say that Burnaby Detachment was well-represented by our members, several of whom took the day off and on their own time and expense, attended the regimental funeral in honour of their colleague.



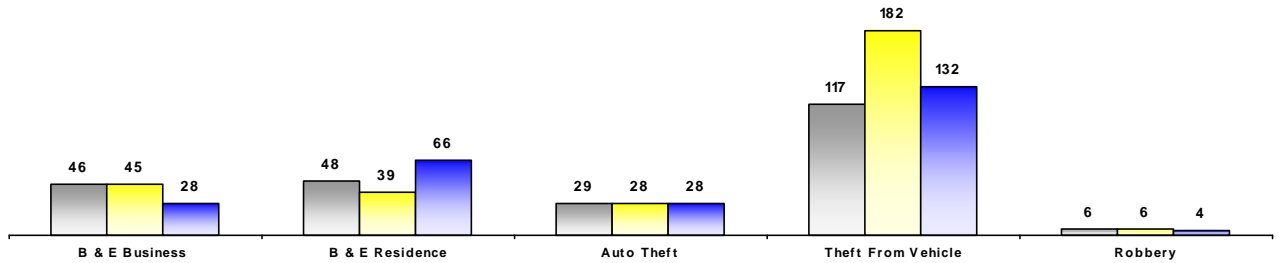

Stats Over 3 Years

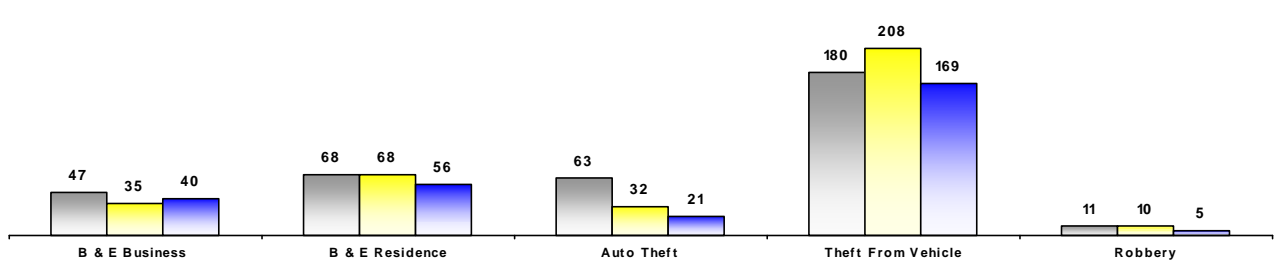
D1 Monitored Crime Types

■ 2014 YTD ■ 2015 YTD ■ 2016 YTD



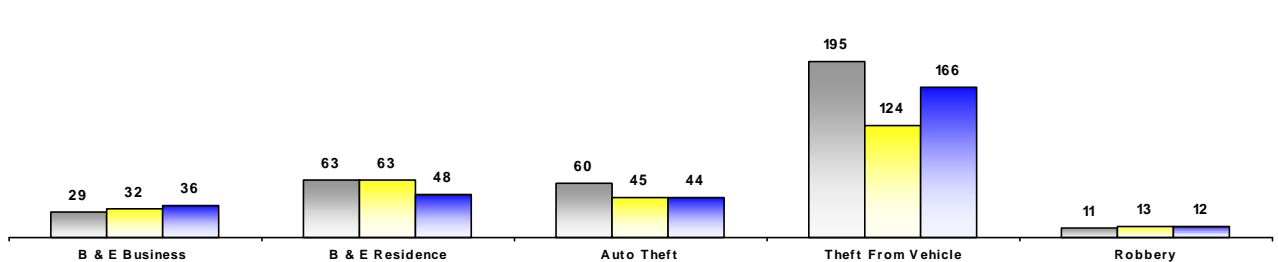
D2 Monitored Crime Types

■ 2014 YTD ■ 2015 YTD ■ 2016 YTD



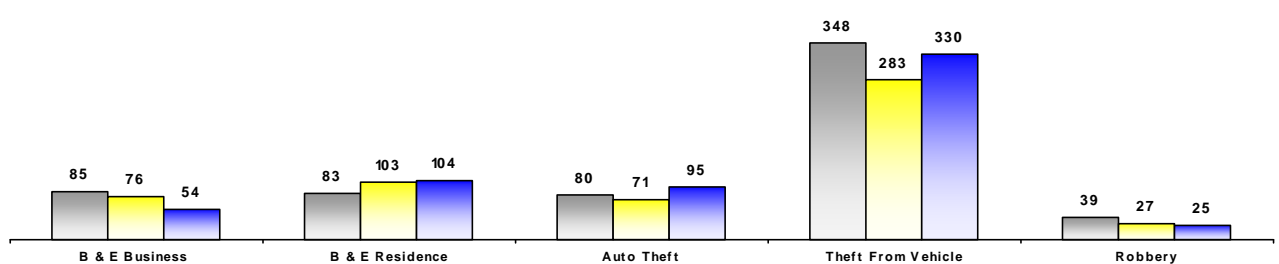
D3 Monitored Crime Types

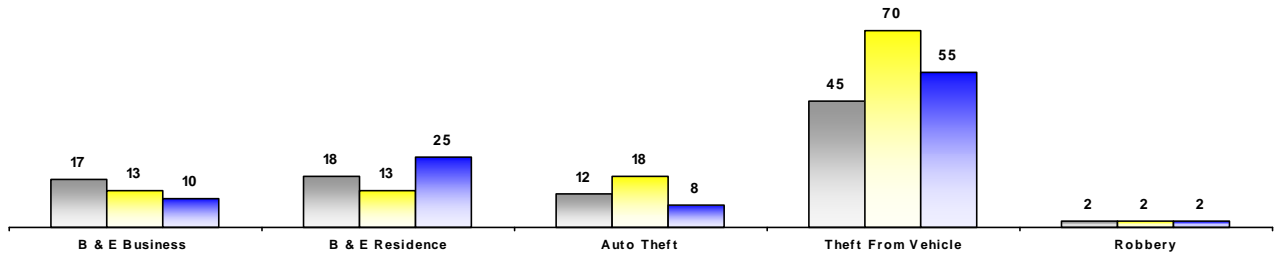

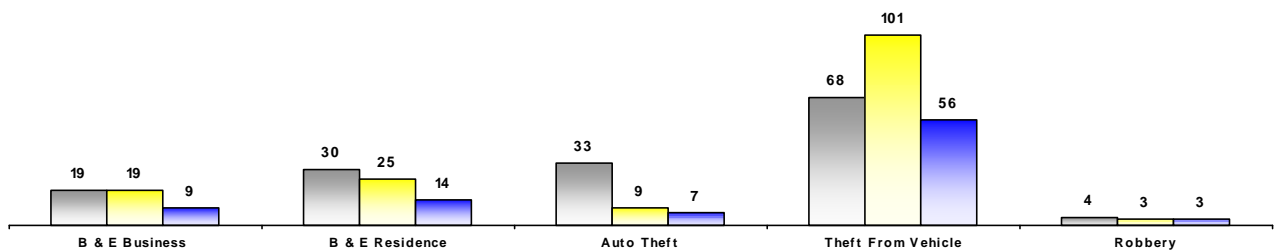

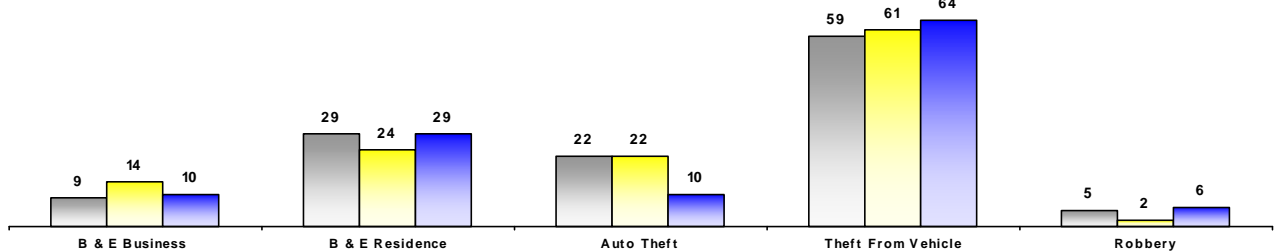

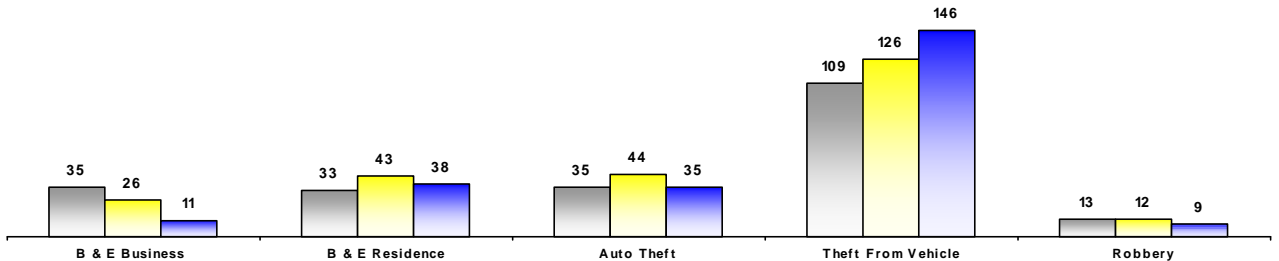

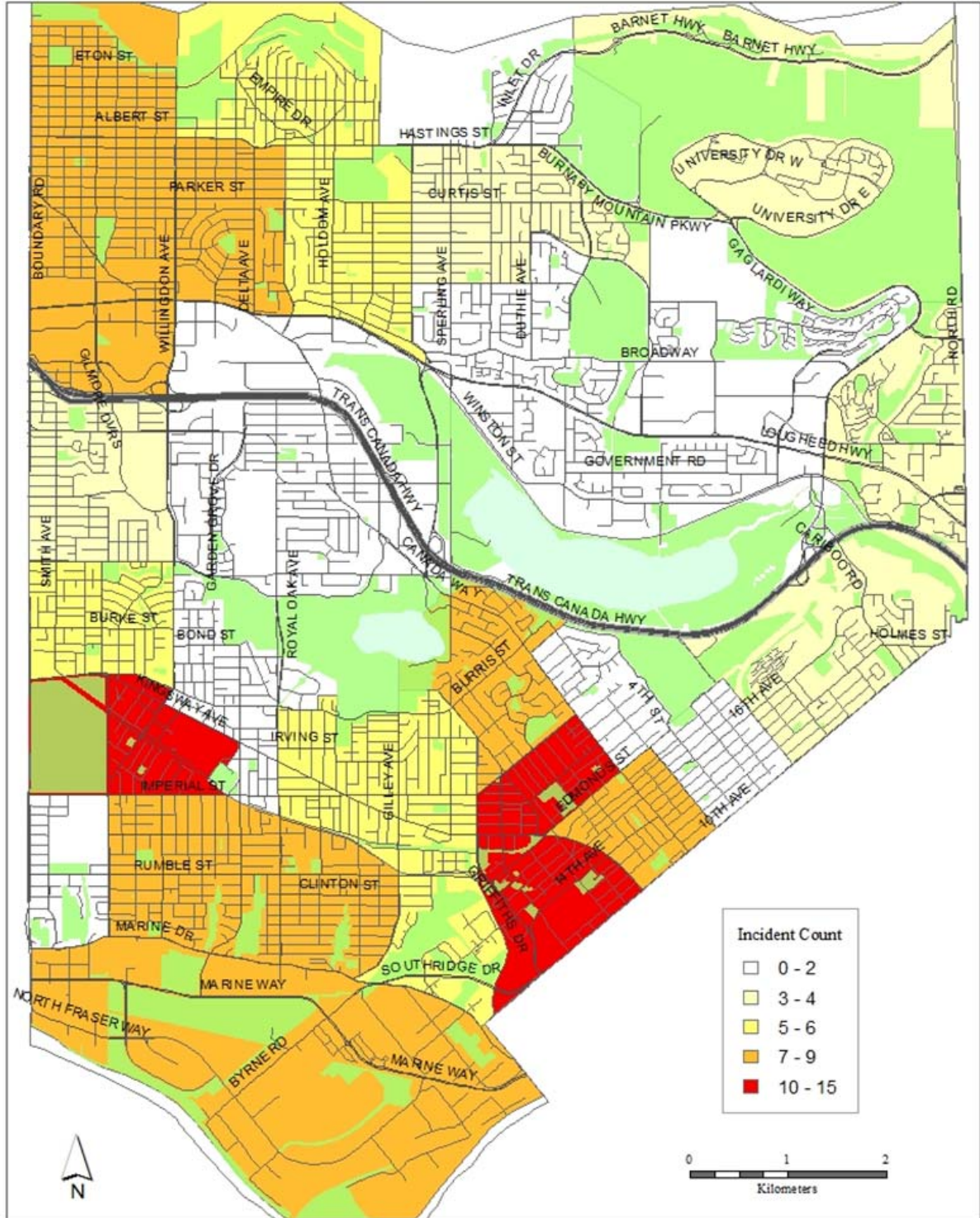

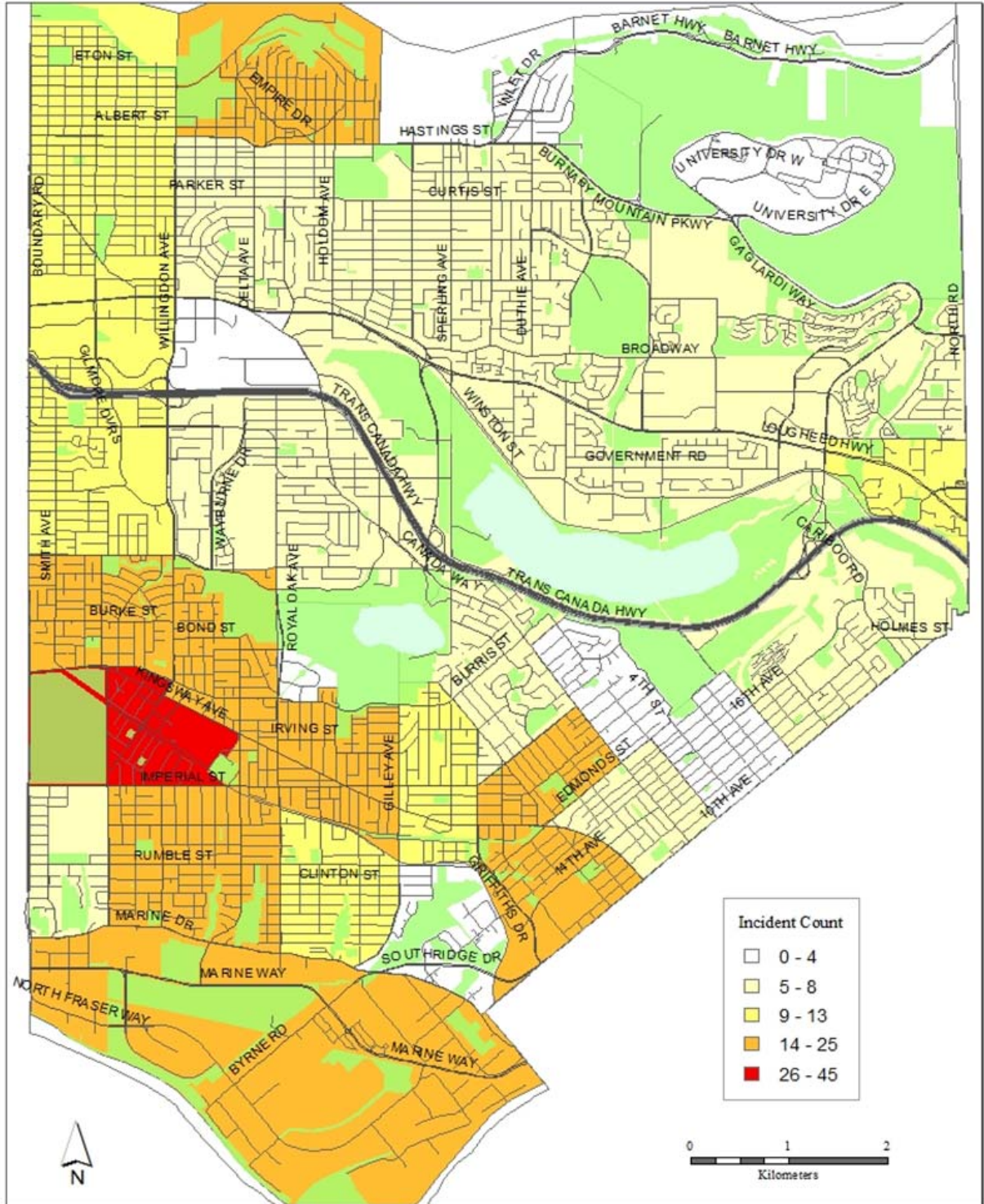
Crime Density Map

Break & Enter by Neighbourhood -- March 1 to April 15, 2016



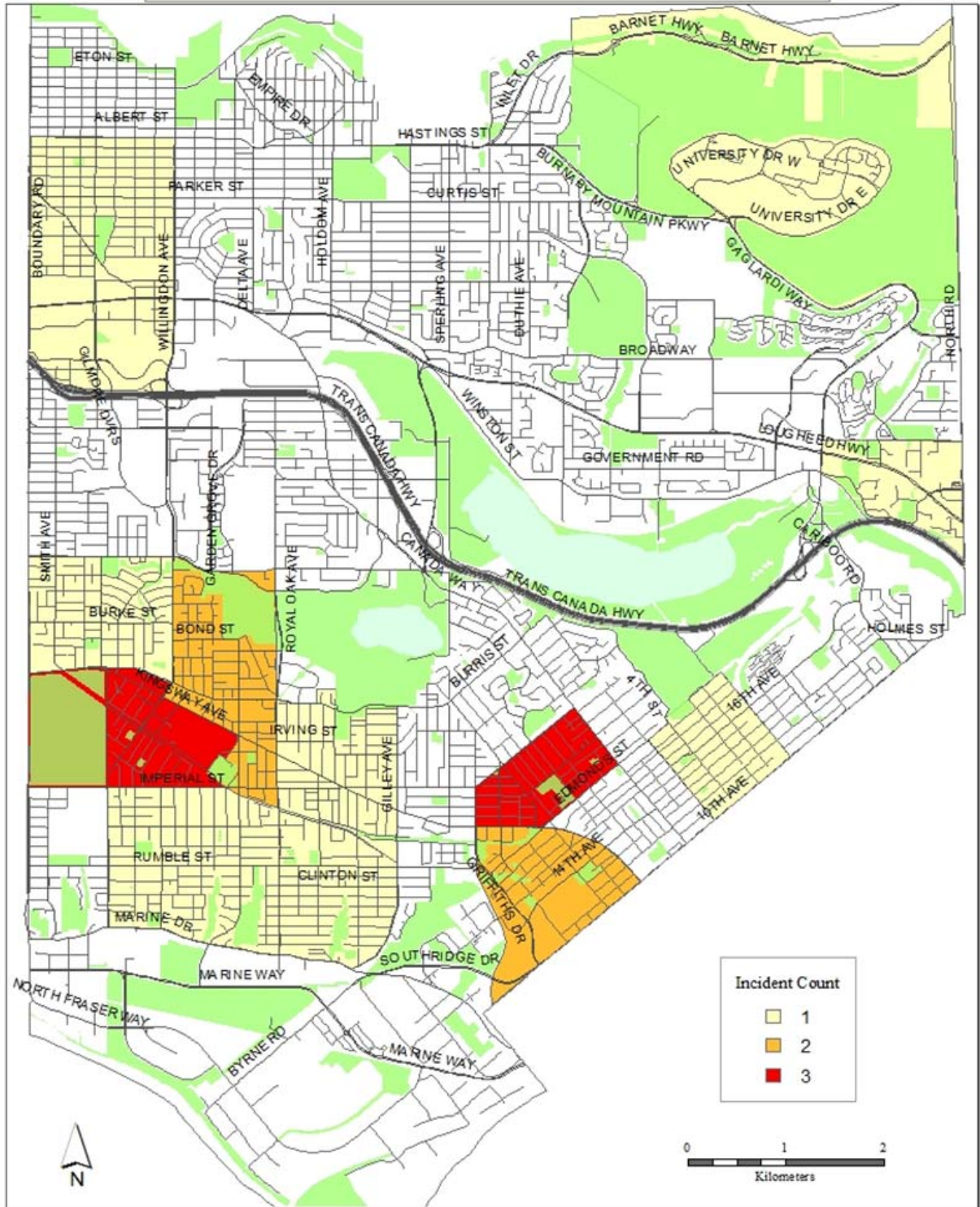
Crime Density Map

Community Operations

Community Programs is the face of Community Operations in Burnaby. The mandate is to target specific neighbourhood and community problems such as problem properties, repeat calls for service, social chronic offenders and crime hot spot problems in Burnaby with the goal of enhancing public safety and reducing calls for service

Prolific Offender Suppression Team (POST)

In March, POST began to investigate a series of thefts from several convenience stores across the Lower Mainland. A specific modus operandi was identified and the same suspect was observed on video surveillance committing thefts. POST liaised with other law enforcement and regulatory agencies and identified a suspect. Police then conducted surveillance and found the suspect who was arrested for the theft offences. A search warrant was also obtained which yielded several items that are allegedly linked to the offence. The investigation concluded with several investigational files and resulted in the disruption of these targeted offences against convenience stores across the Lower Mainland.

CRT (Community Response Team) members donated volunteer time in the community for Cycle for a Cause with \$3,500 raised going to the Law Enforcement Torch Run in support of Special Olympics.

CRT members were patrolling high crime areas when a call came in about a Break and Enter in progress at a local residence in North Burnaby. With the assistance of General Duty and the Police Dog Section, members surrounded the house when the suspect ran out with stolen property. CRT and General Duty members chased the suspect and captured him a short distance from the house. A great ending resulted in all of the stolen property being recovered and the male charged with Break and Enter.

CRT Recover Stolen Car

CRT members overheard a citizen reporting a suspicious vehicle parked in their parking stall. CRT members looked into the matter and discovered the vehicle was stolen. CRT members located the vehicle and waited to see if the suspects would return to pick it up. A short time later, two males did return to the vehicle and they were arrested by CRT members without incident. Both males had stolen property in their possession.

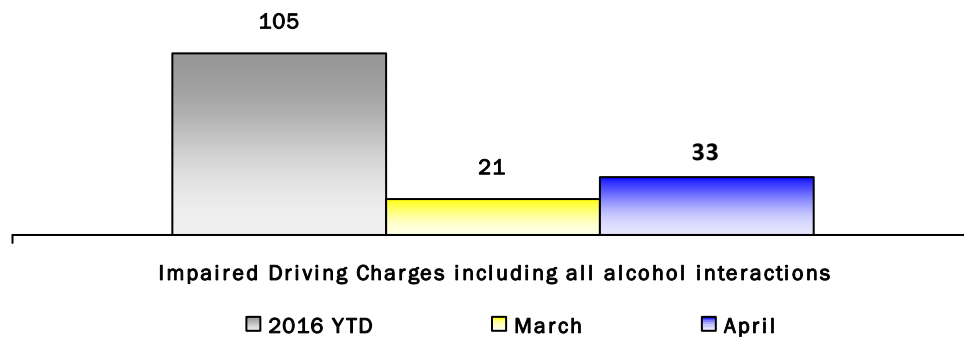


Traffic Operations Stats

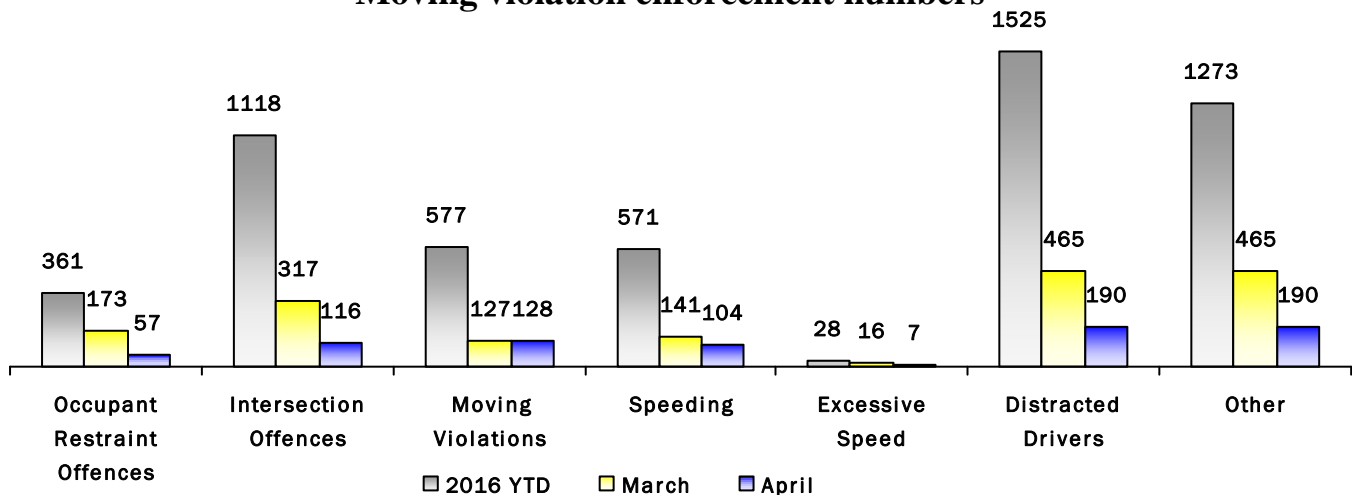
During the month of March, 185 collisions were investigated in Burnaby. Of those, 36 involved non-life threatening injuries and tragically one fatality. It was also Distracted Driving month and Burnaby RCMP made a significant effort towards reducing distracted drivers on Burnaby streets by Issuing 802 tickets.

For the first two weeks of April, 83 collisions were investigated. Of those, 12 involved non-life threatening injuries and no fatalities occurred in Burnaby.

Moving violation enforcement numbers

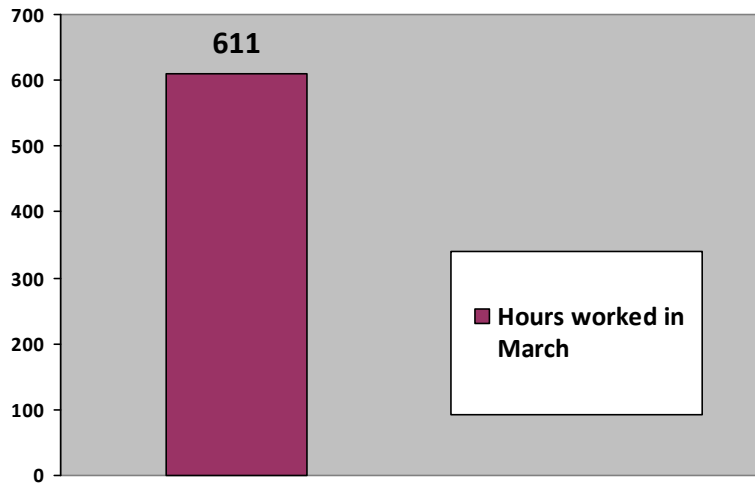

Graffiti Program: March/April Highlights

The City of Burnaby and Burnaby RCMP Anti-Graffiti Coordinator continue to work together on the key components of the Anti-Graffiti Strategy: Eradication, Education, Prevention, Identification and Deterrence.

Graffiti Busters – Burnaby Mountain Secondary

Burnaby Mountain Secondary students have been working on the Community Safety Initiative (CSI), which includes the Graffiti Busters Program. They will present their programs at the upcoming Public Safety Committee Meeting. They are also in the process of putting dates together to paint out graffiti in the community with Burnaby RCMP Auxiliary members.

Graffiti Bylaw Enforcement and Tickets

A Graffiti offender disputed two Graffiti Bylaw Tickets from 2015. The Adjudication Hearing was held on March 23, 2016. In attendance as witnesses were Burnaby RCMP, City of Burnaby Anti-Graffiti Coordinator, Transit Police and City of Vancouver Anti-Graffiti management. The disputant did not show and as such, the bylaw tickets were upheld. The offender will owe the City of Burnaby \$1,000 plus \$70 in service fees.

A second Graffiti offender was recently issued a Graffiti Bylaw ticket from an offence in 2015. He disputed the ticket. An extensive report from the Burnaby RCMP, in partnership with the City of Vancouver, Transit Police and CN Police was submitted to the Screening Officer for the dispute. The file and investigation is ongoing.

In March, 2016 a male who did extensive graffiti damage around Burnaby was charged with two graffiti-related offences. In April, Burnaby RCMP submitted seven more offences to Crown Counsel for extensive graffiti (Mischief) for the same individual.

Graffiti Eradication and Prevention

In March and April volunteers in the community continued to actively remove graffiti on private property, to assist owners, especially in the high traffic areas, replacement wraps were installed on thirty traffic signal cabinets and there are four upcoming mural applications that will take place this summer.

Crime Prevention Unit

The Crime Prevention Unit (CPU) hosted a Senior Financial Fraud Awareness Forum on behalf of the Officer-in-Charge of Burnaby RCMP, Chief Superintendent Dave Critchley. The forum was held March 17 at the Bonsor Recreation Centre. Approximately 120 people were in the audience including representatives from Burnaby council. Keynote speakers included Better Business Bureau, Canadian Anti-Fraud Centre, and Burnaby RCMP Economic Crime Unit.

On March 30, Burnaby RCMP held a Safe Community Series presentation on Personal Safety Awareness. It was held at Burnaby Mountain Secondary School. About 150 people attended to hear tips on how to recognize danger and what to do in a compromising situation.



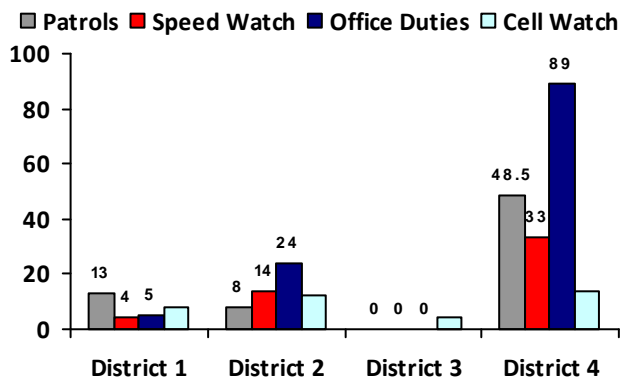

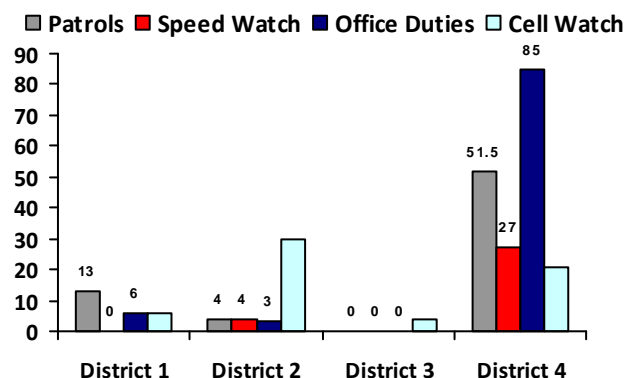


