 Subject: Year in Review and Operating Funds

A video presentation was made which highlighted many of the year's activities organized by the Burnaby Arts Council. Ms. Martin advised that the Burnaby Arts Council has created a broad range of arts and culture programs and activities for all ages. These were made through some 3,000 volunteer hours of high school students and various community members. Exhibitions, artists' talks and workshops, etc. at the Deer Lake Art Gallery drew 7,000 visitors. A new on-line membership administration system has been established. The 2017 and 2018 programming and engagement plans and budget were presented. They expect an expansion in their capacity and budget in 2018.

The Chair thanked Ms. Martin for the presentation.

b) Spokespersons: Gaetan Royer, Fred Soofi and Soudeh Jamshidian Human Rights Park Society Subject: Human Rights Park Mr. Royer introduced the Human Rights Park Society and their directors at the meeting. The Human Rights Park Society has received the support of Amnesty International Canada and an offer for a formal partnership with them. The Society's vision is to create a beautiful park for human rights. They are looking at the Burnaby Mountain Conservation Area or the Barnet Marine Park as they are easily accessible with amenities in place. Their plan for the Human Rights Park would see 200 sculptures and works of art with interpretation signs placed over a 10 year period. The sculptures and works of art will be funded by donation and sponsorship.

Mr. Soofi advised that he operates a restaurant at Simon Fraser University. They will fund raise to build the Human Rights Park in Barnet Marine Park. The park will be unique and educational. Burnaby is a progressive city and a perfect place for the park.

Ms. Jamshidian advised that the proposed Human Rights Park will create an opportunity for people around the globe to share their experience.

The Chair thanked Mr. Royer, Mr. Soofi and Ms. Jamshidian for their presentation.

iv) Lotus Sports Club Licence Agreement Renewal

The Lotus Sports Club is a recreational and competitive boating club based at Barnet Marine Park in Burnaby. They have been operating from the City owned Texaco building for several years, and have had a licence agreement since 2005. The previous three-year agreement has expired. The Club continues to be a conscientious and responsible occupant and provides boating opportunities for Burnaby residents. This agreement will allow them to continue their use of the facility until the planning process determines future park usage.

The Presenting Burnaby Parks Gift Program has been successful in providing new and replacement opportunities of benches, picnic tables, drinking fountains and trees throughout our park system. Donors are able to make contributions to various programs or areas such as youth or seniors as well as make a donation as a memorial. In addition, Parks, Recreation and Cultural Services receive sponsorship amounts for various events. In most cases, sponsorship agreements stipulate that funds in excess of current year expenditures may be used for future year events.

Re: Parkinson Society British Columbia Support Group - Waiver of fee

I am writing on behalf of the support group that currently holds its monthly meeting at Confederation Park Community Centre every second Monday from 1 to 3 pm. The group has been meeting there for many years with attendance of approximately 20 people. As Parkinson's is a progressive disease, this number changes from time to time.

Over the past few months, the Confederation Seniors' Association and the Confederation Centre staff became aware that they had no rental agreement with the Parkinson Society Support group and that neither group was collecting any rent from the support group. Subsequently, they approached the volunteer facilitator of the group to request that the group or the Society begin paying a rental fee.

The Society operates 50 groups across the province. Most of them do not pay a fee to the community centre, church or other facility where they hold their meetings. Those that do are larger groups and pass around the hat at each meeting. The Society does not pay for these costs as each group is set up to run as a somewhat independent body. (Please see the attached excerpt from our Society bylaws governing support groups).

The rent Confederation Park requires is \$199.21 for two hours and not affordable for the 20 people who attend, mainly low income seniors, many with disability caused by their Parkinson's disease. An option is to find another location. However, both the Centre staff and the Seniors' Association view the group as providing a worthy service and important to those people with Parkinson's disease who attend. They have indicated that waiver of the rental fee is in the hands of the City of Burnaby Parks Recreation and Culture Commission.

On behalf of the Parkinson's support group, I am requesting the Commission waive this monthly rental fee so that the support group can continue to hold its monthly meetings at Confederation Park Community Centre.

EXCERPT FROM PSBC BYLAWS GOVERNING SUPPORT GROUPS

5.0 SUPPORT GROUPS, COMMITTEES AND ADVISORY BOARDS

- 5.1 **Appointment and Removal** The Board may, by resolution, appoint members to committees or advisory boards on such terms as the Board sees fit. The Board may, by resolution, remove members from committees or advisory boards as the Board sees fit.
- 5.2 A committee or advisory board so formed in the exercise of the powers so delegated shall conform to any rules that may from time to time be imposed on it by the Board, and shall report every act or thing done in exercise of those powers to the Board.
- 5.3 **Support Groups –** Members who wish to form a local Support Group affiliated with the Society may apply to the Board or the Board's designate and upon acceptance by the Board or designate, form a Support Group of the Society. The Board may, by resolution, cease affiliation with any Support Group as the Board sees fit.
- 5.4 The Board will, at its discretion, provide assistance to Support Groups, including:
 - a. the development and provision of Support Group programming;
 - b. training for Support Group leaders;
 - access to the Society's library and educational resources, including resource manual, newsletters, and conferences;
 - d. provision of literature for distribution in the community;
 - e. the referral of members of the public to local Support Groups as appropriate.

5.5 Each Support Group shall:

- a. provide a local presence for the Society in the community;
- b. manage its own affairs on a not-for-profit basis;
- c. hold meetings offering information and support to individuals with Parkinson's disease and their loved ones;
- d. distribute only literature and information supplied by the Society or approved by the Board or the Board's designate;
- e. survey its members for information and feedback on the Society's programming as requested and report the results of this survey to the Board from time to time;

- f. provide the Society with reports, including Support Group membership lists, for statistical purposes; and
- g. include contact information for the Society, the Society's logo, and the statement that the Support Group is "A partner of the Parkinson Society British Columbia" on all marketing materials produced by the Support Group.
- 5.6 **Expenses** Members of support groups, committees or advisory boards shall serve as such without remuneration and no member shall directly or indirectly receive any profit from such a position.
- 5.7 A member of a committee or advisory board may be reimbursed for all expenses necessarily and reasonably incurred by that member while engaged in the affairs of the Society.
- 5.8 Support Groups (and their members) will not be ordinarily reimbursed for expenses but may, on application to the Board and at the Board's sole discretion, be reimbursed for extra-ordinary expenses incurred in the course of providing local programming in furtherance of the Society's Constitution and Bylaws. Support Groups should seek the Board's approval for such reimbursement in writing and in advance of incurring the expense.
- 5.9 **Procedure** Unless otherwise determined by the Board, each Support Group, committee and advisory board shall have the power to fix its quorum at not less than a majority of its members, to elect its own chair, and to regulate its procedures.
- 5.10 A committee or advisory board's first order of business shall be to draft its own Terms of Reference and work plan for submission to and approval by the Board. A Support Group that intends business other than that set out in section 5.5 shall also draft its own Terms of Reference and work plan for submission to and approval by the Board.
- 5.11 A committee, advisory board, or Support Group so formed shall conform to any rules imposed on it by the Board, abide by the Bylaws and its Terms of Reference, and report every act or thing done in exercise of those powers at the earliest meeting of the Board held after the act or thing has done.

SUBJECT: SPECIAL OUTDOOR EVENTS 2018

PURPOSE: To request approval for special outdoor events in 2018.

RECOMMENDATIONS:

1. THAT approval be granted for up to 12 outdoor events at Deer Lake Park Festival Lawn between 2018 May 01 and 2018 September 30, and up to 15 special events at Swangard Stadium between 2018 April 01 and 2018 November 01.

2. THAT this report be forwarded to Council for approval.

REPORT

Every year special events are planned at two signature outdoor venues in Burnaby. The concerts and festivals for Deer Lake Festival Lawn and the special events at Swangard Stadium where amplified sound is involved are regulated by numbers and frequency. Regular scheduled events such as smaller gatherings and sporting matches occur year round as well.

This report is to secure preliminary approval for up to 12 outdoor events at Deer Lake Park Festival Lawn between 2018 May 01 and 2018 September 30, and up to 15 special events at Swangard Stadium between 2018 April 01 and 2018 November 01. The Deer Lake Festival Lawn events will include the City's annual Symphony in the Park, the Burnaby Blues and Roots Festival and up to 10 ticketed concerts hosted by outside organizers and/or community groups at the Festival Lawn. Events at Swangard Stadium will include "Burnaby Celebrates Canada Day" and the annual "European Festival", and up to 13 other special events.
