#### REPORT

#### 1.0 **BACKGROUND**

2017 saw the dual celebration of Canada's 150th Anniversary of Confederation and the 125th Anniversary of the City of Burnaby which was incorporated on 1892 September 22.

To mark Burnaby's 125th Anniversary, the Parks, Recreation & Cultural Services Department applied for and received \$75,900 in federal funding from the Ministry of Canadian Heritage under the Community Anniversaries component of Building Communities Through Arts and Heritage program. Community Anniversaries funding is available to commemorate a community's 100th anniversary or greater (in increments of 25 years). A matching financial commitment is required by the City of Burnaby to receive this grant funding.

In a report to Council dated 2016 October 13, Council approved the receipt of the \$75,900 grant along with an additional expenditure of \$205,000 from the Operating Gaming Fund for an expanded year-long program to celebrate Burnaby's 125 and Canada's 150 Anniversaries.

#### 2.0 HIGHLIGHTS

The following report summarizes the key highlights for this significant year of celebration in the City of Burnaby.

a. Local Showcase Performers: The Shadbolt Centre for the Arts initiated a call for musicians, artists and heritage performers, adjudicated the responses and established a roster of selected performers who were scheduled at many of the Celebration events. In total, there were 92 performances with more than 400 local performers who helped the City celebrate this milestone year. This roster database is a legacy from Burnaby 125. It will assist city staff with scheduling performers at civic events for future years.

- b. Celebrate Volunteers: The City of Burnaby would like to acknowledge over 80 volunteers who demonstrated community pride and spirit by giving over 525 hours of volunteer time to make the Celebrate events an incredible success.
- c. Signature Events: Over 90,000 people joined the festivities at eight Celebrate 125 | 150 signature events throughout the summer. Many of the events featured local performing artists through stage performances as well as roving throughout the crowds.
  - Canada Day: Nearly 30,000 people attended Burnaby's three official Canada Day celebrations. Family events were held at Edmonds Park, the Burnaby Village Museum and ended with a free concert and fireworks at Swangard Stadium. The day was filled with local and national pride as Canadians from coast-to-coast joined together to celebrate.
  - 125 Weekend of Fun: On September 22nd, the community joined together in an incredible three-day celebration to commemorate Burnaby's 125<sup>th</sup> birthday. Throughout the weekend, the price of admission to drop-in programs at recreation facilities, a small bucket of balls, golf clinics and lattes were rolled back to \$1.25. More than 13,000 participated in these drop-in activities. In addition, over 5,000 people took part in special birthday events at eight community centres featuring local performances, interactive displays from City departments and family friendly activities.
- d. Community events: In addition to the signature events, the Celebrate Burnaby team brought the Celebrate Burnaby Activation Tent to 18 local community events throughout the summer. From golf festivals, environment week and cultural events to sporting and neighbourhood events more than 130,000 residents and visitors joined in Burnaby-themed arts, crafts and other activities.
- e. Communications: A comprehensive marketing and communications plan was developed to increase awareness of the celebration activities. Elements of the plan included a dedicated website page with over 19,000 page views, outdoor street banners throughout the city, transit shelters, videos, eNewsletters, on-site signage, and more. On social media, over 1,000 tweets, 400 Facebook posts and 300 Instagram images were made along with over 50,000 video views. Thanks to

the corporate sponsorship from the Burnaby Now, a comprehensive advertising plan was also established in the local newspaper.

- f. Celebrating Burnaby's Past: The community was able to take a look back at Burnaby's history through an engaging exhibit entitled, *Then and Now* chronicling the city's journey over the past century at the Burnaby Village Museum; free presentations as part of the Burnaby Neighbourhood History Series; as well as a series of heritage markers which are being installed at key locations across the city.
- g. Infrastructure Projects: To commemorate these historic celebrations and thanks to the support of local non-profit groups and the federal government the City has several Canada 150 infrastructure projects underway to help serve the community for years to come. These included renovations at the Bob Prittie Metrotown Library, the Central Park tree planting, the Central Park multi-use trail, the outdoor fitness circuit at Burnaby Fraser Foreshore Park and the Willingdon Linear Park.
- h. Burnaby Parks: The Parks Department created and placed 13 new owl Ecosculptures (representing each of Canada's 13 provinces and territories) in Central Park as well as a maple leaf inspired design on a disk at the Shadbolt Centre for the Arts and the frogs at Bill Copeland Sports Centre. As well, the Parks Department created a festive community float to salute our local RCMP, and to celebrate Burnaby's 125<sup>th</sup> and Canada's 150<sup>th</sup> Birthdays.
- i. #celebrateburnaby Photo Gallery: Throughout the year, the City invited social media users to post pictures on Instagram with #celebrateburnaby. Over 2,000 images were submitted to an online photo gallery celebrating what the community loves about Burnaby. <a href="www.burnaby.ca/photogallery">www.burnaby.ca/photogallery</a>

The Burnaby 125 | 150 Celebrations have offered a great opportunity this year for the community to come together to celebrate the arts, to connect with each other, to have fun and show their community spirit.







#### 2.0 NEIGHBOURHOOD CHARACTERISTICS

- 2.1 The subject site is located within Central Park, proximate to the eastern park entry via Patterson Avenue. On the surface, the site is improved with parking, washroom facilities, and the eastern trail entry into Central Park, as well as ventilation equipment and small kiosks related to Metro Vancouver's subsurface Central Park Water Pump Station.
- 2.2 To the north are tennis courts, beyond which are the Central Park forest conservation area, Expo Line SkyTrain and baseball diamond/lawn bowling area. To the east, across Patterson Avenue, are high-rise apartment buildings. To the south, is the Central Park Pitch and Putt, beyond which is Imperial Street. To the west is the Central Park forest conservation area, beyond which is Boundary Road.

#### 3.0 BACKGROUND INFORMATION

- 3.1 In 1971, Council received a report summarizing a three year study by the Greater Vancouver Water District (GVWD) determining Central Park as the optimal location for future major water installations (water main, reservoir, and pump station) necessary to serve Burnaby. The report also concluded that recreational amenities, such as tennis courts and other allied uses, could be supported atop the subsurface infrastructure. In 1976, the water infrastructure and recreational uses were constructed and have been operating since that time.
- 3.2 Metro Vancouver has advised that the electrical equipment for the Central Park Pump Station is nearing the end of its useful life and requires replacement. Since 2015, Metro Vancouver and their consultants have been reviewing options for the replacement of the electrical equipment, including location and enclosure type. Based on the results of the review, Metro Vancouver has determined that the preferred option for the replacement electrical equipment is to locate the infrastructure within the existing Metro Vancouver statutory right-of-way at Central Park, above ground, with vehicular access for servicing and post-disaster reasons.

#### 4.0 GENERAL INFORMATION

4.1 This rezoning application is for the construction of a one-storey building, which will be used to house the electrical equipment related to the operations of the Metro Vancouver Central Park Pump Station. It is noted that the subject site, which sits atop the Metro Vancouver statutory-right-of-way, is occupied with other Metro Vancouver infrastructure, including a climate station, as permitted by the existing statutory right-of-way in favour of Metro Vancouver. As part of a suitable plan of development, the applicant in working with Planning and Parks staff will determine the preferred location for the proposed electrical building within this defined area, as well as to ensure that the building is designed in a manner that is integrated with the overall park and compatible with the adjacent Central Park East neighbourhood. The building will also be designed

with the necessary sound attenuations to mitigate any noise emanating from the electrical equipment, compliant with the Burnaby Sound Abatement Bylaw. It is anticipated that Metro Vancouver staff will access the finished electrical building on a monthly basis for maintenance and monitoring. Vehicular access to the site is via Patterson Avenue, using the existing Central Park eastern parking area.

- 4.2 No road dedication, closures or additional statutory rights-of-way are required in connection with this application.
- 4.3 The Director Engineering will be requested to provide an estimate for all services necessary to serve this site.
- 4.4 Stormwater Management Best Practises in line with established guidelines will be required.
- 4.5 Approval by the Engineering Environmental Services Division of a detailed plan of an engineered sediment control system.
- 4.6 A tree survey is required to determine if any trees are to be retained. Existing trees to be retained are to be protected by 4.0 ft. high chain link fencing, on steel posts. Temporary chain link fencing around the site area is also to be provided during construction adjacent to public park areas.
- 4.7 The proposed perquisite conditions to the rezoning will be included in a future report.





The area for planned development is within Lot 1 of District Lot 151, Group 1, New Westminster District, Plan LMP7878. The Central Park Pump Station is currently zoned P3 and the proposed zoning will be CD(P2). Only the southeast portion of this area is intended to be developed.

In this area, Metro Vancouver proposes to install an aboveground, pre-fabricated electrical building on the rooftop of the existing underground Central Park Pump Station. The electrical building will then be fenced off for approximately one-half of its perimeter. The reasons to install this pre-fabricated electrical building aboveground are the following:

- The electrical feed to the pump station is going to be upgraded from 2400V to 4160V
- The current electrical equipment at Central Park Pump Station is nearing the end of life
- There is insufficient space to install all the new electrical equipment inside Central Park Pump Station
- For operational safety and maintenance, having the new electrical equipment aboveground is preferred
- Pre-fabrication of the electrical building will reduce the overall site construction footprint and minimize disruption to the public.

Functional operations of the pump station will remain the same after the project is completed. Ongoing maintenance of the new aboveground equipment will be done at an annual frequency. Accessibility to the equipment by Metro Vancouver personnel will be by vehicles, utilizing the parking lot at the pump station.

There is a climate station located within the project site. This climate station may be relocated depending on the final footprint configuration of the electrical building. The nominal footprint dimensions of the proposed electrical building is approximately 12m x 6m x 4m high.

Metro Vancouver is currently working with CWA Engineers Inc. (CWA) on the engineering detailed design for this project. For overall sequencing and scheduling, CWA and Metro Vancouver intends to work closely with the City of Burnaby with the rezoning and permitting process concurrently with engineering detailed design. Since August 2015, Metro Vancouver and CWA Engineers worked rigorously to identify several possible locations for the electrical building before finalizing the aboveground location. Metro Vancouver/CWA has also had preliminary discussions with the Burnaby Parks Board and with BC Hydro.

Metro Vancouver intends to begin construction at the Central Park Pump Station site starting in early 2019, and finish construction in 2020. The construction start date is contingent on receiving approvals for rezoning and permitting and the ability to work through potential architectural requirements for the electrical building and

transformer enclosure with stakeholders. These potential requirements need to be communicated with vendors and suppliers prior to signing purchase agreements.

We trust that the above letter of intent satisfies the initial requirements from City of Burnaby and supports a favourable consideration of the rezoning application by Council. Please do not hesitate to contact the undersigned should you have additional questions.

Website development for better experience across desktop, tablet, and mobile platforms with the addition of emergency notification and booking modules as added features. Replacement of Deer Lake Avenue fencing and improvement for access gates. Increase electrical capacity at the Love Farmhouse for special events and improved safety. Storage and workspace improvements; to include shelving for artifact/design storage and office furniture.

2. Burnaby Mountain Conservation Area (DPW.0341) \$200,000 (estimated)
Continued development of the trail system to include safety improvements, slope
grading, riparian work and the extension and widening of trails.

# 3. Deer Lake Park (DPW.0363)

\$150,000 (estimated)

This project will include design and early preparation for construction of the Oakland staircase replacement.

4. Edmonds Park (DPW.0295) (DPW.0296)

\$230,000 (estimated)

Work for this project will include trail connections with lighting, site furniture, shade structure installations and architectural design work for the washroom building replacement. Preparation for construction of the washroom in 2019 will include excavations, removals, concrete work, asphalt work, electrical work, sewer and water hook-up.

5. Barrier Gates and Bleachers (DPW.0348)

\$70,000 (estimated)

Replacement of barrier gates and bleachers at various park sites and sports fields in the park system. Installation of new gates and bleachers are based on public concerns and requests. Proposed installations will include Burnaby Heights, Barnet Marine Park and various other sites.

6. Environmental Upgrades (DPW.0345)

\$50,000 (estimated)

Invasive species excavation, replacement fill and soil, sub base preparation, native plantings and landscaping of the areas. This responds to previous years' treatments, weather and new growth. This is also a continuation of habitat restoration in areas such as Deer Lake Park, Central Park, and Burnaby Mountain natural forest areas.

7. Fencing and Support Structures (DPW.0347)

\$150,000 (estimated)

This project is for fencing replacement and improvement to park and playfield fences. Included this year are upgrades to Eastlake, Riverway and Willingdon Park and various other locations.

8. Footbridges and Stairs (DPW.0355)

\$100,000 (estimated)

This project is for the replacement of footbridges, stairways, retaining walls and safety railings within 236 km of trails in City Parks such as Byrne Creek, Stoney Creek, Robert Burnaby, Deer Lake and additional park sites.

9. Minor Equipment (DPY.0097)

\$95,000 (estimated)

This project is for the purchase of the annual replacement of small mowers, weed eaters, leaf blowers, power saws, small turf attachments, janitorial equipment, and various other motorized pieces of equipment.

## 10. Trail System Development (DPW.0352)

Reconstruction of trails throughout the parks system and installation of new pathways with loop trails for improved access to park features. Locations to be considered include Byrne Creek Ravine, Brentwood Park, Robert Burnaby Park, Terminus Park and various other sites.

## 11. Park Signage (DPW.0263)

\$35,000 (estimated)

\$100,000 (estimated)

There are 164 parks in the system (local, neighborhood, and district levels). Each park requires at least one sign and some sites multiple signs. Signs will be installed in all parks that don't have a specialized design such as Deer Lake Park precinct. Each year new locations will be identified for sign installation.

12.Picnic Tables and Bench Replacement (DPW.0354) \$100,000 (estimated)

This project is for the replacement and addition of picnic tables and benches at popular park sites. Older tables at various sites are replaced with concrete tables to reduce vandalism, graffiti and the possibility of fire due to barbeque use. Included this year are upgrades to Central Park, Fraser Foreshore, Barnet

Beach, Second Narrows Park, Confederation Park, and various other locations.

## 13. Watermain Replacement (DPW.0359)

\$90,000 (estimated)

This project is for the installation and replacement of various park water mains originally installed from 1975-1978.

# 14. Sports Courts (DPW.0357)

\$75,000 (estimated)

This project is for resurfacing, fencing and major upgrades to basketball courts, ball hockey courts and multi-use sports courts within the Parks system. Included this year are Cariboo Hill School Park, Burnaby Heights Park, and Rene Park.

### 15. Shade Structures (DPW.0349)

\$120,000 (estimated)

Installation of shade structures in coordination with recreation program needs in various locations (spray parks, playgrounds, etc.) throughout the Park system. Locations are subject to public input and may include David Gray, George Green, Edmonds, McGill, Ron McLean, or Keswick Park for 2018.

### 16. Minor Development (DPW.0340)

\$150,000 (estimated)

Minor capital replacement work and upgrades at various park locations due to breakdowns, vandalism or unanticipated capital repairs. Projects done in the past include irrigation systems, turf replacement, culvert excavation and replacement, and watercourse riparian work.

## 17. Neighbourhood Park Landscape (DPW.0350)

This project is to enhance and improve neighborhood park landscaping including accessible path connection to facilities and parking areas and reconstruction of outdoor elements to meet current safety codes. Locations planned include Wesburn Park, Robert Burnaby Park, Kisby Park and a few additional park sites.

## 18. Parking Lots and Roads (DPW.0337)

\$650,000 (estimated)

\$90,000 (estimated)

Repaving work, as well as design specifications for 2019 tender of various access roads and parking lots in Parks, Includes paving and drainage improvements as well as repaving of parking lots in deteriorated condition, replacement of curbs and related landscape restoration. Projects planned for 2018 include nursery service road, Robert Burnaby Pool lot, Central Park Pool lot and a few smaller sites.

## 19. Cariboo Park (DPW.0288)

\$185,000 (estimated)

Replacement of the 1989 playground structure to meet lifecycle renewal timeline. Accessibility improvements will be included in the work. Includes excavation and removal of old play structures, preparation of sub-base, installation of surface materials and edging, installation of new play equipment and landscape restoration.

## 20. Kisby Park (DPW.0333)

\$185,000 (estimated)

Replacement of the 1987 playground structure to meet lifecycle renewal timeline. Accessibility improvements will be included in the work. Includes excavation and removal of old play structures, preparation of sub-base, installation of surface materials and edging, installation of new play equipment and landscape restoration.

# 21.Lou Moro Park (DPW.0334)

\$185,000 (estimated)

Replacement of the 1993 playground structure to meet lifecycle renewal timeline. Accessibility improvements will be included in the work. Includes excavation and removal of old play structures, preparation of sub-base, installation of surface materials and edging, installation of new play equipment and landscape restoration.

### 22.CSA Playground Compliance (DPW.0335)

\$160,000 (estimated)

Equipment replacement, due to wood preservative and lead paint on equipment, installed fifteen years ago at Royal Oaklands, Meadowood Park, Central Park, Bell Park, and various other locations.

## 23. Vehicle Purchase (DPZ.0022)

\$260,000 (estimated)

Additions to the Parks Fleet to reduce response time and improve maintenance standards. These vehicles will replace rental units and older equipment that has been kept in service beyond their useful life cycle. The units required include two trucksters for park maintenance, an aerovator for artificial sports fields, and an allowance for customization.

The expenditures for these projects have been included for consideration in the 2018-2022 Financial Plan which is currently under preparation. Upon approval of this funding request by Council, these expenditures will be included in the 2018-2022 Financial Plan. Sufficient Capital Reserve funds are available to finance the capital projects outlined in this report.
