2.1 <u>Minutes of the Parks, Recreation and Culture Commission Open meeting</u> held on 2020 March 10

3. CORRESPONDENCE

3.1 <u>Correspondence from Ernie Kashima, President Bonsor 55 + Society Re:</u> Purchase of New Bus

Correspondence was received from Ernie Kashima, President, Bonsor 55 + Society. The Society is requesting financial assistance for the purchase of a bus for the Seniors Society. The current bus was purchased in 2008 for \$84,000. A new bus of similar make will cost \$134,000. The bus is utilized by the seniors of Bonsor, Edmonds and Cameron Seniors Centre. The Society is asking the City to pay 40% of the initial bus purchase cost which would equal approximately \$50,000.

This item of correspondence was **REFERRED** to staff for review and report back at the 2020 July meeting.

3.2 <u>Correspondence from Jaden Raffin Re: Townsend's Moles in Burnaby</u> <u>Mountain Conservation Area</u>

Correspondence received from Jaden Raffin expresses concern for the management of Burnaby Mountain Conservation Area, and the belief that there are Townsend Moles living in the conservation area. The Townsend Mole is a protected species. A note from staff advises that staff will contact the writer and review options for future assessment and protection of the species.

3.3 <u>Memorandum from Administrative Officer Re: Child Care Centre for City</u> Employees

A memorandum was received from the Administrative Officer advising that Council, at the Open Council meeting held on 2020 May 25, received the above noted report and adopted the recommendations contained therein. The report presented a proposal to create a child care centre for the children of City employees at the City-owned property at 6570 Deer Lake Avenue. The child care centre will offer priority placement for City and Burnaby RCMP employees.

Commission members expressed concern with the projects location and the increased traffic in the park at pick up and drop off times. Commission members asked to be provided with additional information as it becomes available.
