SUBJECT: LOCAL SERVICE TAX BYLAW

PURPOSE: To impose a 2015 Local Service Tax Bylaw for works completed between 2014

June 01 and 2015 May 31.

RECOMMENDATION:

1. THAT Council authorize staff to prepare a 2015 Local Service Tax Bylaw to impose a local service parcel tax for completed local improvement works on the benefiting properties included in Attachment 1, 2015 Schedules 1 to 12

REPORT

Under Part 7, Division 5, Section 210 (Local Service Taxes) of the Community Charter, the City is required to pass a new Local Service Tax Bylaw for 2015, to impose taxes for local improvement works. This report is for works completed on or following 2014 June 01 and up to and including 2015 May 31.

Attachment 1 (which includes Schedules 1 to 12) provides a summary of the newly completed Local Area Service works. Frontage taxes and interest rates are those in place at the time of petition and are contained in the Burnaby Local Improvement Charges Bylaw 1985, (13325 consolidated). Such taxes will be billed annually over a specified repayment period with Property Taxes.

Property owners were advised of the proposed taxation amounts and provided with an opportunity to appear at the 2015 March 24 Parcel Tax Roll Review Panel.

Applicable Local Area Service Tax charges of \$40,165.15 will be added to the existing annual levy for Local Area Service Tax charges from 2015. Details of the new charges are included in Attachment 1, 2015 Schedules 1 to 12. A summary is provided in table 1 as follows:
