| 2. Burnaby Mountain Golf Course | \$25,000 |
| Driving range lobby improvements and equipment including the purchase and installation of one Range Servant Ultima 45 ball dispenser complete with blower receivers and automation system for calibration and distribution of range balls to customers. | |
| 3. Minor Development | \$150,000 |
| Minor capital replacement work and upgrades at various park locations due to breakdowns, vandalism or unanticipated capital repairs. Projects done in the past include irrigation systems and turf replacement. | |
