Shadbolt Centre</p> <p>Burnaby Arts Council backyard enhancement project to provide greater access and community engagement to the Burnaby Arts Council from Deer Lake Park including improved ground treatment, pathways and fencing, creation of a small performance space, enhanced lighting, seating and art display spaces.</p> | <p>\$30,000</p> |
| <p>2. Burnaby Mountain Golf Course</p> <p>Driving range lobby improvements and equipment including the purchase and installation of one Range Servant Ultima 45 ball dispenser complete with blower receivers and automation system for calibration and distribution of range balls to customers.</p> | <p>\$25,000</p> |
| <p>3. Minor Development</p> <p>Minor capital replacement work and upgrades at various park locations due to breakdowns, vandalism or unanticipated capital repairs. Projects done in the past include irrigation systems and turf replacement.</p> | <p>\$150,000</p> |
