A) David Beattie and Allan Hunt, The HELLO Project Re: Social Isolation in Burnaby and Metro Vancouver Speakers: David Beattie and Allan Hunt

Alan Hunt, New Wave Community Service and David Beattie, Coordinator, HELLO Project, appeared before the Committee providing an overview on efforts being done to erode social isolation in Burnaby and Metro Vancouver.

Mr. Beattie referenced a story in the Georgia Straight, asserting that 90% of people who responded to their survey say Vancouver is different from any other city they have lived in. Contribute factors for feelings of isolation could include geography, climate, drugs, language barriers and electronic influences which may add to the rising mental health concerns.

Mr. Hunt advised the challenge was getting the word out for changes in cultural and social behaviors to initiate engagement and friendlier interaction within communities. The speaker noted that along with nine partners a request seeking endorsement by Surrey Council would go forward in July. Mr. Hunt advised that following direction provided by each municipality, support would be made available to further advance the HELLO Project in Burnaby. The speaker advised these changes take time, awareness must start in schools, colleges and public places. A number of locations and ideas were identified including the use of public transportation by posting messages to say hello or by wearing hello buttons to engage conversation and build relationships.

The Committee inquired into how goals and success were identified. The speaker advised that interviews would be conducted three months after the project launch to gather information and determine effectiveness.

The Committee expressed appreciation for the informative presentation regarding the HELLO Project and plans to introduce behaviors that will create friendly and engaged communities and looks forwarded to hearing outcomes from the pilot at a future meeting.
