PURPOSE: To obtain Council approval to award a contract for the performance of pavement rehabilitation on various roadways throughout the City's local road network.

RECOMMENDATION:

1. **THAT** Council approve a contract award to Jack Cewe. Ltd. for an estimated total cost of \$2,295,888 including GST in the amount of \$109,328 as outlined in this report. Final payment will be based on the actual quantity of goods and services delivered and unit prices as tendered.

REPORT

Four tenders for this contract ranging from \$2,295,888.00 to \$2,729,215.86 were received by the closing time on 2016 May 09. The work of this assignment includes the performance of pavement rehabilitation throughout the City's local road network including the following work and road locations:

Roadworks:

1. Marlborough Avenue – Kingsway to Sanders
2. Sanders Street – Nelson Avenue to Royal Oak Avenue
3. Newton Street – Marlborough Avenue to Royal Oak Avenue
4. Norcrest Court – Still Creek Avenue to cul-de-sac
5. Stoney Creek Place – South cul-de-sac to Norcrest Court
6. Gamma Avenue – Lane south of Hastings Street to Union Street
7. 16th Avenue – Cumberland Street to 140m east of Endersby Street
8. Endersby Street – 16th Avenue to Armstrong Avenue
9. Inman Avenue – Burke Street to Thurston Street

10. Willingdon Avenue – Bus Stop at Kingsborough Street
