SUBJECT:

SOLID WASTE & RECYLING BYLAW 12875 - RATE CHANGES

PURPOSE:

To seek Council's approval to revise the Solid Waste and Recycling Bylaw 12875

effective 2016 August 01, to reflect rate increases and provision for Secondary

Suite Minimum Garbage Fee and MMBC glass recycling guidelines.

### RECOMMENDATION:

1. THAT the Committee recommend Council authorize staff to amend the Solid Waste and Recycling Bylaw 12875 as outlined in Section 2 of this report.

### REPORT

## 1.0 INTRODUCTION

Staff have reviewed the Solid Waste and Recycling Bylaw 12875 and have identified a need to reflect upcoming changes to the operational program as well as to provide some clarity on wording in the Bylaw. Changes in rates are also included to reflect introduction of the Secondary Suite program for residential properties.

## 2.0 AMENDMENTS TO THE SOLID WASTE AND RECYCLING BYLAW

## Secondary Suite Garbage Fee

In 2014, Council adopted a program to permit secondary suites in single-family homes. This program is in response to recommendations from within Burnaby's Official Community Plan and Social Sustainability Strategy. As a part of this program, all properties with a secondary suite are subject to additional user fees to cover the additional cost for providing Water and Sewer services. In addition, an amendment is required to incorporate a minimum **Secondary Suite Garbage Fee** of 240 Litres. The 2016 annual fee for 240L is \$205. This charge will be applied to all residential dwellings with a secondary suite, even if the toter in use may be smaller than 240 Litres.

Secondary Suite Garbage Fees will be billed annually with Water and Sewer charges on the Utility Charges and Garbage Disposal Fees notice. For newly constructed properties with secondary suites, or those that have been demolished and rebuilt with a secondary suite, secondary suite garbage fees will have the same effective date as the annual supplementary flat water service fee.

## Other rates proposed to be increased include:

- Multi-family Commercial and Institutional garbage and recycling receptacle rental and pickup: 5% increase in rates to recover the costs of services and other increases since the last fee adjustment in 2012.
- Multi-family, Commercial and Institutional yard waste rental containers: \$5 monthly rental fee increase for three (3) and four (4) cubic yard containers with castors. Castors normally need to be replaced every other year and this replacement cost has steadily increased over the years.
- Yard Waste Drop-Off at City's Eco-Centre: Increase in drop off fee from \$65/tonne to \$67/tonne (inclusive of applicable taxes) to reflect and bring it to par with regional rates. There is no fee for Burnaby residents with a load < 100kg.

Table 1 (see <u>Attachment #1</u>) summarizes the proposed fees increases for the Burnaby Solid Waste and Recycling Bylaw 12875.

In addition, the Burnaby Solid Waste & Recycling Bylaw 12875 to be updated to reflect MMBC glass recycling guidelines. Wording throughout the bylaw will be updated to provide further clarity.

## 3.0 CONCLUSION

Staff have reviewed the Solid Waste and Recycling Bylaw 12875 to accommodate the changes noted above and the rates as set out in *Attachment* #1. Staff are recommending that Financial Management Committee recommend Council authorize the preparation of the bylaw to amend the Solid Waste and Recycling Bylaw 12875 as outlined in Section 2 of this report.
