PURPOSE: To obtain approval to award a five year contract for external audit services.

RECOMMENDATIONS:

- **1. THAT** Audit Committee recommend Council authorize staff to award a five year contract to KPMG LLP for external audit services for the 2016 2020 fiscal years.
- 2. THAT the audit fee be set at \$79,170 for 2016 (including GST in the amount of \$3,770) and indexed by the Vancouver Consumer Price Index for subsequent years 2017 2020.

REPORT

1.0 BACKGROUND

Section 169 of the Community Charter requires Council to appoint an auditor for the municipality. Auditors are appointed to report to Council on the annual consolidated financial statements of the City.

On 2011 October 03, Council approved the appointment of KPMG LLP as the City's External Auditors for a five year term covering audits of fiscal years 2011 to 2015. The City's five year audit contract for 2011 to 2015 expired this year after the completion of the 2015 financial statement audit. The City issued a Request for Proposal (RFP) for external audit services on BC Bid. Proponents were requested to provide proposals for external audit services for the City of Burnaby and the Burnaby Public Library for a five year term covering the fiscal periods 2016 to 2020. Proponents were also required to provide a separate price for external audit services for the Burnaby Municipal Benefit Society.

2.0 **REQUEST FOR PROPOSALS**

Two proposals were received by the closing date of 2016 April 12. The proposals were evaluated by a selection committee on the stated criteria of public sector accounting standards, government experience, key personnel, methodology and approach, deliverables, value for money, value added, costs and references.

The selection committee concluded that KPMG LLP have the required expertise and resources to conduct the City's annual audit and were the strongest overall proponent.

For 2016, the external audit service contract for the City and the Library is \$79,170 (inclusive of applicable taxes). Annual audit services for 2017 to 2020 will be adjusted based on changes in the Vancouver Consumer Price Index, as published by BC Stats. Funding for the City's audit program is included in the City's 2016 – 2020 Annual Financial Plan.

It is recommended that Council authorize staff to award a five year contract to KPMG LLP for external audit services for the period 2016 to 2020.
