4. Vehicle Purchase (DPZ.0019) \$363,000

Purchase of a chipper truck with crane and a brush chipper for forestry work on boulevards, cargo van for use by Food services, a mini pick-up for use by park patrol, and a thatcher attachment to be used at golf courses.

Sufficient Capital Reserves are available to complete the above projects in the 2016 Provisional Financial Plan. It is recommended that Council be requested to bring down a bylaw to appropriate \$568,375 (inclusive of GST) from Capital Reserves to finance these projects.
