SUBJECT: CONTRACT AWARD
2017 COMBINED SEWER SEPARATION PROGRAM
CAMBRIDGE LANES

PURPOSE: To obtain Council approval to award a contract for the Cambridge Lanes under the 2017 Combined Sewer Separation Program.

RECOMMENDATION:

1. **THAT** Council approve a contract award to Gemco Construction Ltd. for an estimated total cost of \$2,165,100 including GST in the amount of \$103,100 as outlined in this report. Final payment will be based on the actual quantity of goods and services delivered and unit prices as tendered.

REPORT

Five tenders ranging from \$2,165,100.00 to \$2,626,909.95 were received by the closing time on 2017 February 08. The scope of this project includes combined sewer separation and watermain replacement work in North Burnaby. Construction includes 511m of sanitary sewer, 535m of storm sewer, 739m of watermain and 4530m² of road/lane rehabilitation at the following locations:

- Lane North of Cambridge Street (Esmond Avenue - Gilmore Avenue)
- Esmond Avenue (Lane North of Oxford Street - Eton Street)
- Ingleton Avenue (Lane North of Oxford Street - Eton Street)
- MacDonald Avenue (Lane North of Oxford Street - Eton Street)

The lowest tenderer Gemco Construction Ltd. has completed previous projects under contract to the satisfaction of the City. Review by City staff and our consultant indicates the contractor has the equipment and personnel capability to successfully complete the work required under this contract. The Director Engineering concurs with the above recommendation.

This capital work is provided for within the 2017-2021 Provisional Financial Plan under the following WBS elements: EJA.0015 (\$567,600), EKA.0015 (\$1,449,500), and EMF.0051 (\$44,900). Appearing elsewhere on the agenda is a funding report for this project.
