
INCIDENT TYPE STATISTICS OVER 12 MONTHS








FIRE PREVENTION DIVISION

During June, July and August 2017, Department Fire Inspectors:

- Initiated or completed 142 low-rise apartment routine inspections
- Initiated or completed 43 high-rise building routine inspections
- Initiated or completed 309 complex business license inspections
- Completed 61 sprinkler inspections
- Completed 61 building final approval inspections
- Approved 55 Fire Safety Plans
- Reviewed and updated numerous Pre Incident Plans
- Collected Vital Information Program data
- Investigated and/or formally reported 59 fires to the Office of the Fire Commissioner
- Conducted numerous re-inspections on outstanding issues related to previous inspections
- Care facilities along with public, private and community schools will be inspected commencing September 5th. The Fire Prevention Division will focus on completing all Care facilities and schools in September and October.

The Acting Chief of Fire Prevention has continued to focus his efforts on the professional development of the Division staff, managing rezoning issues, and approving building, fire access and sprinkler permitting plan. The Acting Chief Fire Prevention:

- Reviewed building code reports and continually attended meetings.
- Reviewed 240 permit applications including anything from a small tenant improvement to a large, comprehensive, complex, new development project.
- The complexity of conducting high rise routine inspections is made evident when we began to enforce the 5 year roof top flow test on all high rise buildings older than 5 years old. Of the 43 high rise inspections either initiated or completed in the June, July, August duration, 39 are ongoing and only 4 were completed. Many older buildings are replacing fire department connections, piping, fire pumps and components that have been shown to fail when conducting this mandatory 5 year test.
- While conducting extensive routine inspections on low rise apartment buildings, our inspectors have found several illegal suites. Most of the suites had to be vacated because of the location within the building and its non-compliance to both BC Building Code and BC Fire Code.

The Fire Prevention Division is still continuing to support the ongoing development of Department Suppression staff by providing comprehensive high-rise training system training in order to communicate newly changed design standards for mixed-use buildings containing multiple occupancies. This training partnered the Fire Prevention Division with community stakeholders to provide fire suppression crews with onsite high-rise life safety systems orientations.

WILDLAND DEPLOYMENT

We provided support of the Elephant Hill fire from July 14 until September 4. This equaled 6 deployments consisting of 9 Firefighters, including Fire Officers, as well as one Chief Officer (Deputy Chief) overseeing and in command of each deployment. Ten BFD personnel per deployment totaling 54 unionized staff and 3 from the Fire Management Team. There is a chance they may call again this season but at this time it appears doubtful.

Our role was structural protection and working alongside BC Wildland staff to support their operations. We worked exclusively on night operations and were humbled to be put in command of this portion of the incident. Our personnel worked extremely hard for extended periods of time and sacrificed time away from their families to contribute during the provincial state of emergency.
