2018 FCM MEMBERSHIP DUES

**PURPOSE:** 

To seek Council approval for payment of Federation of Canadian Municipalities

2018 Membership Dues.

# RECOMMENDATION:

1. THAT Council approve payment of the invoice from the Federation of Canadian Municipalities for the 2018 membership dues in the amount of \$36,621.45 (including GST in the amount of \$1,743.88).

# REPORT

The City of Burnaby is an active member of the Federation of Canadian Municipalities, and the invoice for the 2018-2019 membership dues was recently received.

The annual dues in 2017-2018 were \$34,446.19, including GST. The invoice for 2018-2019 that was recently received is \$36,621.45, including GST. This is calculated on a base fee of \$360.00 and a per capita fee of \$34,517.57 (232,755 x 14.83 cents) plus GST. Part of the cost increase is due to an update in the population base on which the per capita charge is levied. The fiscal year runs from April 1, 2018 - March 31, 2019. GST became payable for the first time last year due to a CRA ruling that the status of the FCM must change from a charitable organization to a not-for-profit association.

In addition to the annual membership dues, there are two optional amounts that are submitted for consideration.

#### Legal Defense Fund - \$5,621.03 (including GST)

Information provided by the FCM indicates that the Legal Defense Fund has been a critical tool in defending the national legal interests of Canada's local governments for 20 years. The fund is completely voluntary and member-supported.

The City Council, at its meeting on 2017 April 03, considered correspondence from the FCM regarding a contribution to the Legal Defense Fund, At that time, the correspondence was TABLED, and no further action was taken.

### **Travel Fund** – \$2,443.93 (including GST)

The FCM Travel Fund is intended to support the participation of elected officials from small communities on the FCM's National Board of Directors. The FCM Travel Fund was established in 1989, and BC and Saskatchewan are the only two provinces to establish a travel fund of this nature. The City of Burnaby directly covers the cost of its representative on the National Board of Directors, and as such starting in 2016, the City discontinued its voluntary contribution to the Travel Fund.

The required funding for the 2018-2018 FCM membership has been provided in the 2018 operating budget.
