projects.


## **RECOMMENDATION:**

## **REPORT**

As part of Metro Vancouver's long range plan to provide appropriate regional infrastructure in support of on-going growth across member municipalities, Metro Vancouver staff have informed the City of their plans to construct water and sanitary infrastructure projects across Burnaby over the next 5 years. Figure 1 shows the location of these anticipated regional projects:

- G5 Sperling Sanitary Pump Station
- G19 Douglas Sanitary Trunk Sewer
- G23 Winston Sanitary Trunk Sewer
- G24 South Slope Sanitary Interceptor
- G26 Lozells Sanitary Trunk Sewer
- G27 North Road Sanitary Trunk Sewer
- G34 Stoney Creek Sanitary Trunk Sewer
- G38 Glenbrook Sanitary Trunk Sewer
- M1 Douglas Road Main #2 Still Creek Section
- M2 Central Park Main #2
- M4 Douglas Road Main #2 Burnaby Heights Section
- U20 Westridge Sanitary Pump Station

There are regional projects being planned for construction to start in late 2018 and 2019 in which the City has identified an opportunity to replace or rehabilitate aging City assets as well as construct new City assets alongside Metro Vancouver infrastructure, which include:

- A new regional water transmission line within the Still Creek Area (Project M1, anticipated to start in 2019).
- A new regional water transmission line within the Burnaby/Vancouver Heights Area (Project M4, anticipated to start in Fall of 2018).
- A new regional water transmission line within the Kingsway pressure zone (Project M2, anticipated to start in 2019).
- Upgrades to the regional Westridge sanitary pump station and a new forcemain (Project U20, G26, anticipated to start in 2019).

The City works will consist of utility upgrades (sanitary, water, and drainage), new fibre optic ducts, curbs and gutters, sidewalks, and road rehabilitation. As a fully integrated effort, the City will enter into discussions with Metro Vancouver to coordinate City works, cost sharing agreements, property negotiations, and rights of way agreements.

Coordination with Metro Vancouver on this work will provide the City with an opportunity to optimize construction costs, expedite timing of constructing infrastructure, and minimize disruption to residents, businesses, and traffic.

With respect to Project M1 – Still Creek Area, Metro Vancouver plans to install their watermain via deep micro-tunneling under Elk Creek, between Still Creek Avenue and Still Creek, in order to eliminate any environmental disturbance to this watercourse. Figure 2 shows Metro Vancouver's proposed watermain in relation to Elk Creek. Metro Vancouver has submitted and received approval from the City's Environmental Review Committee (ERC) on 2017 December 11 that this is an acceptable construction methodology.
