vii) Burnaby Arts Council Operating Contribution

The Director Parks, Recreation and Cultural Services submitted a report requesting Commission approval for a 2019 contribution for operating assistance for the Burnaby Arts Council (BAC). In addition, the BAC has asked for consideration of running a 50/50 draw or raffle at the 2019 Burnaby Blues and Roots Festival. This request is compatible with the festival and can be accommodated, if approved, as a pilot project for 2019.

- 3. THAT the Burnaby Arts Council be commended for their work and commitment to the arts in Burnaby.
- 4. THAT the Burnaby Arts Council be so informed.

i) <u>Discounted Recreation Passes</u>

At the Parks, Recreation and Culture Commission Meeting on 2019 October 24, Ms. Alice Lum, resident, enquired about discounts on recreation passes. The report advised that the current bActive pass model provides opportunities to enjoy Burnaby's recreation facilities at a discounted rate and provided information obtained on a recent market survey conducted in November 2018.

ii) Burnaby Arts Council Licence Agreement Renewal

The Director Parks, Recreation and Cultural Services submitted a report seeking approval for a licence agreement renewal with the Burnaby Arts Council. The recommended term would continue from 2018 January 01 to 2020 December 31. The Burnaby Arts Council has used the City owned building at 6584 Deer Lake Avenue for over 20 years as their society office and program space and to operate the Deer Lake Gallery. Use of the house on Deer Lake Avenue was formalized in 2005 with a standard licence agreement which allows the society use of the building, along with custodial, gardening, maintenance and utility support provided by the city valued at approximately \$33,000 annually.

It was recommended:

- THAT approval be granted to renew the licence agreement with the Burnaby Arts Council for use of the house at 6584 Deer Lake Avenue for a further three year term.
- 2. THAT the Parks, Recreation and Culture Commission recommend Council approve the renewal of the licence with the Burnaby Arts Council as outlined in this report.
- 3. THAT the Parks, Recreation and Culture Commission recommend Council authorize the City Solicitor to execute a licence agreement with the Burnaby Arts Council as outlined in this report.
- THAT a copy of this report be sent to the Burnaby Arts Council.

iii) 2019 February – Parks, Recreation and Cultural Services Capital Funding Bylaw

The Director Parks, Recreation and Cultural Services submitted a report seeking a Capital Reserve Fund Bylaw in the amount of \$1,240,000 to finance five projects as outlined in the report. The projects are: Cafferky Park Site Development, Docks and Piers, Central Park Perimeter Trail, Burnaby Art Gallery Interior Fit Outs and Food Services Equipment.

It was recommended:

1. **THAT** the Parks, Recreation and Culture Commission recommend Council authorize the City Solicitor to bring forward a Capital Reserve Fund Bylaw in the amount of \$1,240,000 to finance the projects outlined in this report.

iv) 2019 Giro di Burnaby

The Director Parks, Recreation and Cultural Services submitted a report seeking approval for the road closure for the Giro di Burnaby criterium cycling event, scheduled to take place on Thursday, 2019 July 11 in the historic area of Burnaby Heights. The women's race will start at 6:00 p.m. and the men's race begins at approximately 7:15 p.m. Hastings Street and the surrounding streets are required to be closed to local traffic from 4:00 p.m. – 10:00 p.m. with restricted parking in the immediate area beginning at 3:00 p.m. In 2018, the Giro di Burnaby saw thousands of people attend the race. The race continues to gain momentum and community recognition and has become a signature event for the City of Burnaby. It is expected that 2019 will see more racers competing and additional spectators attending to enjoy the event.

It was recommended:

1. **THAT** the Parks, Recreation and Culture Commission recommend Council authorize the road closure for the Giro di Burnaby as identified in this report.
