#### DISCUSSION

Jubilee United Church is requesting the use and closure of Gray Ave between Rumble St & Irmin St and the laneway between 7551 & 7591 Gray Ave from 8:00am - 5:00pm on Saturday, 2019 September 14 (see attached map). The closure will allow time for set and take down. The event runs from 10:00 am to 4:00 pm.

The Street Fair is open to the community to come and meet their neighbors, giving them an opportunity to meet and participate in various events through the day which will include children's games, face painting, free crafts, bake sale, cake walk, local vendors, food trucks, fire truck, a band and other local performers.

The organizers are aware that approval is subject to the following conditions:

- 1. That the road closure be conducted under the supervision of one person as marshal or organizer.
- 2. That all participants be instructed to respect the rights and property of the individuals encountered enroute.
- 3. That the parade be covered with liability insurance in the minimum amount of \$2 million with the City of Burnaby named as co-insured, and that the insurance policy include a 30 day cancellation notice and a cross liability clause.
- 4. That the organizers send out letters to residents that are affected by the road closures at least 2 weeks prior to the event.
- 5. That the organizers are responsible for arranging for barricade volunteers for all barricade locations.
- 6. That a signed copy of the "City of Burnaby Permit For Short Term Use and Occupancy Of City Lands" be received no later than one week prior to the event.
