**4. PRESENTATIONS**

**A) Safety Award for Warming Centre Operation  
Presenter: Dave Ellenwood, Director Parks, Recreation and Cultural Services**

**Mr. Dave Ellenwood**, Director Parks, Recreation and Cultural Services, appeared before Council advising that Burnaby Warming Centre Team won the North American Occupational Safety and Health (NAOSH) Award in recognition of the dedication to workplace safety. NAOSH awards are distributed annually to the province's leaders in workplace safety.

The speaker provided an overview of the program, and noted that Warming Centres were provided at four locations throughout the City to assist patrons through a warm and safe place to take refuge in the evenings and overnight during the colder months. It was noted that the program was pulled together quickly, and was successful through excellent inter-departmental teamwork and cooperation from other agencies, including RCMP, Fire, and the community.

Mayor Hurley congratulated the City of Burnaby Warming Centre Team on winning the North American Occupational Safety and Health Week Team Award.

**B) Burnaby Fire USAR - Hurricane Dorian Deployment  
Presenter: Ian Hetherington, Acting Captain, Burnaby Fire Department**

**Mr. Ian Hetherington**, Acting Captain, Burnaby Fire Department, appeared before Council providing an overview of the search and rescue operations after hurricane Dorian hit the Bahamas in September.

The speaker advised that 13 members of Urban Search and Rescue (USAR), including four K-9s (dogs), were deployed for a week-long mission. Their objectives were: to search and recover in four separate areas, support critical infrastructure, and located three missing Canadians. The team was able to locate missing victims; support the local hospital; transport people and supplies to/from the hospital, airport and government docks; rescue distressed dogs from the disaster area; locate three Canadians listed as missing, and provide aid; and gained valuable disaster response experience.

**Mr. Jeff Clark**, President, Burnaby Firefighters Local 323, read letters of appreciation from six organizations that sponsored the team: Cathay Pacific, JetBlue Airways, Milwaukee Tools, Telus, Rogers, and Pacific Blue Cross.

Mayor Hurley extended Council's and the community's appreciation to the Burnaby Fire Team for their heroic work.
