**SUBJECT: CONTRACT AWARD 2016-13** 

2016 GILPIN STREET UPGRADE

PURPOSE: To obtain Council approval to award a contract for the 2016 Gilpin Street

Upgrade.

#### **RECOMMENDATION:**

**1. THAT** Council approve a contract award to Eurovia British Columbia Inc. for an estimated total cost of \$3,999,832.43 including GST in the amount of \$190,468.21 as outlined in this report. Final payment will be based on the actual quantity of goods and services delivered and unit prices as tendered.

### **REPORT**

Five tenders for this contract ranging from \$3,999,832.43 to \$5,997,600.00 were received by the closing time on 2016 June 02. The work of this assignment includes road upgrades to urban standard including street lighting upgrades, sidewalk and bus stop improvements, local road asphalt pavement, watermain renewal, sanitary and storm services, trail upgrades and IT communication conduit installation in the following locations:

Road upgrade to local collector urban standard including street lighting upgrades, sidewalk and bus pad improvements –

Parkway: \$2,117,800

1. Gilpin Street – Royal Oak Avenue to Deer Lake Parkway

**Roadworks:** (included in above)

- 2. Eglinton Street Mahon Avenue to cul-de-sac
- 3. Chapple Crescent Gilpin Street to Cedarwood Street
- 4. Cedarwood Street Chapple Crescent to 5750 Cedarwood Street

The lowest tenderer, Eurovia British Columbia Inc., has recently been awarded a contract for the City. They recently underwent an amalgamation of the Eurovia Canada Inc.'s sister companies of Imperial Paving Limited with BA Blacktop, both of which have completed a number of projects to the satisfaction of the City. Furthermore, Martens Asphalt Ltd. has rebranded under the name Eurovia British Columbia Inc. and has also completed similar projects to the satisfaction of the City. Our consultant's review indicates the contractor has the equipment and personnel capability to successfully complete the work required under this contract. The Director Engineering concurs with the above recommendation.

Reallocations have been made within Funding Bylaws #13501 and #13559 to accommodate this contract award. Funding has been provided for this capital work within the 2016 – 2020 Annual Financial Plan under the following WBS elements: ERA.0057 (\$2,117,800), EMC.0010 (\$258,800), EJA.0014 (\$1,099,500), EKA.0014 (\$37,300), ELA.0021 (\$241,700), and AEC.0009 (\$54,600).
