**SUBJECT: CONTRACT AWARD 2016-12** 

2016 WATERMAIN REPLACEMENT & ROAD REHABILITATION

PROGRAM - STANLEY

PURPOSE: To obtain Council approval to award a contract for the 2016 Watermain

Replacement and Road Rehabilitation Program – Stanley.

## **RECOMMENDATION:**

**1. THAT** Council approve a contract award to Pedre Contractors Ltd. for an estimated total cost of \$3,538,500 including GST in the amount of \$168,500 as outlined in this report. Final payment will be based on the actual quantity of goods and services delivered and unit prices as tendered.

## **REPORT**

Six tenders for this contract ranging from \$3,538,500.00 to \$4,428,603.38 were received by the closing time on 2016 May 25. The work of this assignment includes the construction of new ductile iron watermain and pavement rehabilitation in the Stanley area. The work includes approximately 2,100 lineal metres of watermain, 36,000 square metres of related asphalt milling and paving work, and 1,200 lineal metres of ducting for communication cable at the following locations:

## Watermain Installation & Road Works

- 1. 19<sup>th</sup> Avenue 4<sup>th</sup> Street to 2<sup>nd</sup> Street (includes IT conduit)
- 2. 18<sup>th</sup> Avenue 2<sup>nd</sup> Street to Newcombe Street (includes IT conduit)
- 3. 2<sup>nd</sup> Street 17<sup>th</sup> Avenue to Wedgewood Street (includes IT conduit)
- 4. 1<sup>st</sup> Street 18<sup>th</sup> Avenue to 19<sup>th</sup> Avenue
- 5. Newcombe Street  $18^{th}$  Avenue to  $19^{th}$  Avenue
- 6. Nursery Street Canada Way to 6<sup>th</sup> Street
- 7. 6<sup>th</sup> Street Nursery Street to Stanley Street

## **Road Works Only**

- 1. Wedgewood Street  $-2^{nd}$  Street to Newcombe Street
- 2. 19<sup>th</sup> Avenue 1<sup>st</sup> Street to Newcombe Street
- 3. 1<sup>st</sup> Street 19<sup>th</sup> Avenue to Wedgewood Street
- 4. Newcombe Street 19<sup>th</sup> Avenue to Wedgewood Street
- 5. Allman Street Canada Way to 6<sup>th</sup> Street (includes service replacements)
- 6. 6<sup>th</sup> Street Stanley Street to Walmsley Court
