# 3. CORRESPONDENCE

### 3.1 <u>Burnaby Board of Trade - Re: Burnaby Business Recovery Task Force -</u> <u>Quick Start Priorities</u>

Correspondence was received the Burnaby Board of Trade (BBOT) advising about creation of the Burnaby Business Recovery Task Force. The Task Force is identifying actions that can help businesses cope with the ongoing COVID-19 crisis, and ultimately rebuild the local economy for the long-term. It was noted that on May 25, the BBOT, on behalf of the Task Force, released the initial "quick start" priorities that the Task Force will work on immediately to advance, execute, and advocate for.

A staff note advised that the City is represented on the BBOT's Task Force. A Manager's Report, Item 5.1., includes three initiatives that are generated by the City's recovery plan which are closely aligned with the directions of the Task Force. Additional initiatives will be brought forward for Council consideration in the coming weeks.

### 4. <u>REPORTS</u>

### 4.1 <u>Planning and Development Committee - Re: Government Cannabis Store</u> <u>Guidelines</u>

The Planning and Development Committee submitted a report recommending guidelines regarding the location of government cannabis stores.

The Planning and Development Committee recommended:

1. THAT Council adopt the proposed guidelines for government cannabis stores, as discussed in Section 4.0 of the report.

2. THAT Council authorize the preparation of a bylaw amending the Building Bylaw to impose requirements with respect to fences and retaining walls, as outlined in Section 4.0 of the report.

#### 5. MANAGER'S REPORTS

#### 5.1 IMMEDIATE PANDEMIC RECOVERY MEASURES

The City Manager submitted a report from the Director Emergency Operations Centre, the Emergency Operation Centre Planning Section Chief, and the Director Engineering seeking Council approval for the potential closure of lanes, use of road right-of-way for commercial purposes, and general permission for expanded liquor licence service areas to assist residents and businesses with pandemic recovery efforts.

The City Manager recommended:

1. THAT Council authorize staff to implement temporary lane closures, as outlined in the report, should the need for physical distancing and/or enhanced active mobility increase, to assist residents and businesses with the pandemic recovery.

2. THAT Council authorize the approach for commercial use of road rights-ofway, as outlined in the report, to assist businesses with the pandemic recovery.

3. THAT Council grant pre-approval to cover all liquor primary and manufacturer establishments within the City who may apply for an expanded service area, as outlined in Option 1 of the report.

4. THAT Council forward a copy of the report to the Liquor and Cannabis Regulation Branch.

#### 7. <u>NEW BUSINESS</u>

#### His Worship, Mayor Hurley - Notice of Motion - Post-Covid Homelessness

His Worship, Mayor Mike Hurley, provided a notice of motion regarding homelessness and mental illness, seeking long term support and solutions from the Federal and Provincial Governments. The motion calls upon the Federal and Provincial Government to use the coming period of social reordering and economic rebuilding as an opportunity to address systemic housing insecurity issues related to mental health, poverty, and addiction - with the goal of safe and accessible housing for all.

With notice hereby given, the resolution and an accompanying letter to Prime Minister Trudeau and Premier Horgan will appear on the June 8 Council Agenda for Council's consideration.

# Councillor Jordan - Submission to Housing Committee

Councillor Jordan advised that a submission deadline to the UBCM's Expert Panel on the Future of Housing Supply and Affordability was extended to 2020 June 26, and inquired regarding the City of Burnaby's submission.

Staff will investigate and provide submission if appropriate.

# <u> Councillor Jordan – Gas Tax Fund</u>

Councillor Jordan advised that the Federal Government announced an advanced transfer of \$2.2 billion to municipalities that lost revenues due to the COVID-19 pandemic. The funding will come through the Federal Gas Tax Fund in a one-time payment, instead of two and does not represent an increase in funding – only early payment of anticipated transfers. The speaker further clarified that the funding can only be used for capital expenditures and cannot be used to cover operating costs such as salaries.

#### His Worship, Mayor Hurley - Rezoning Reference #19-26

His Worship, Mayor Mike Hurley brought to Council's attention an error that appeared on the report for Rezoning Reference #19-26 considered by Council on 2020 May 25. The report incorrectly stated that the subject property was located in the Edmonds Town Centre Plan; however, it is located just outside of the Edmonds Town Centre. As the reference to the Edmonds Town Centre would form a component of the zoning for the site, an amendment is required to remove the reference to the Edmonds Town Centre.
