I live on Ashgrove (Ash Grove) Crescent, and have done so for 34 years. It used to be a quiet and tranquil neighbourhood.

Now, since expansion of the tank farm, @ the Burnaby terminal, I find the area extremely busy and noisy. The trucks going in and out, sometimes in convoys, block many of the surrounding streets, and the truck drivers oftentimes drive over the lane dividing line, going over into the oncoming lane. Why not think of alternative access to the terminal? Get permission from City of Burnaby, and build a new road through your property so that it would not impact our neighbourhood?
