## 1. CALL TO ORDER

His Worship, Mayor Mike Hurley, called the Open meeting to order at 5:03 p.m. and conducted the roll call. Due to the COVID-19 pandemic, Councillors Johnston and Jordan participated electronically.

For the benefit of the Council members that were participating by electronic means, Mayor Mike Hurley reviewed the staff members present at the meeting.

His Worship, Mayor Mike Hurley, recognized the ancestral and unceded homelands of the hand and Skwxwú7mesh speaking peoples, and extended appreciation for the opportunity to hold a meeting on this shared territory.

## IN MEMORIUM - COUNCILLOR PAUL MCDONELL

His Worship, Mayor Mike Hurley, announced the recent passing of Councillor Paul McDonell. The text of the Mayor's statement follows:

"On behalf of City Council and the City of Burnaby, I want to extend my sincere condolences to the family and friends of Councillor Paul McDonell. Our thoughts are with you as you mourn the loss of your beloved partner, father and brother, grandfather and great-grandfather.

As a City, we have truly lost one of our best ambassadors. Paul was known affectionately by many as "Mr. Burnaby" – a nickname he earned through decades of volunteerism and commitment to the community. Public service was not only Paul's priority – it was his passion.

Paul's energy and creativity made Burnaby a more vibrant and dynamic City. He was a 'connector' and had a real talent for bringing people together. The partnerships Paul fostered were key to the success of our City and many local organizations.

Prior to joining the City of Burnaby, Paul spent his career helping those in need. He was a Vancouver firefighter and rescue service worker for more than three decades, and retired as Deputy Chief. But retirement was just the beginning of a very busy new chapter for Paul.

He joined the Burnaby Health Board in 1994 where he worked to build consensus and advance healthcare initiatives across the region.

He joined the Board of the United Way, becoming its chair and campaign cabinet member for many years. Through this experience Paul learned first-hand about some of the challenges faced by families in our community. He was determined to make a difference.

In 2008, Paul was elected to Burnaby Council and served four consecutive terms. He was a true community champion and had a special place in his heart for the Edmonds neighbourhood. He attended an early meeting of the Burnaby Edmonds Lions Club, and jumped in with both feet, eventually becoming Club president.

Paul loved the area's diversity and often boasted about the number of languages spoken in local schools. When the BASES thrift store wanted to set up shop to help local immigrant and refugee families, Paul did everything possible to help them get started – from sourcing store shelves and a cash station, to donating his own suits and ties. He would regularly visit the store to buy new ones.

Paul sought to create healthy activities that would unite the community in a positive way. In that spirit, he co-founded the Edmonds City Fair and Classic Car Show, and helped launch the Festival of Lights.

Paul also led the Organizing Committee for the World Taekwondo Junior Championships, which brought more than 800 athletes from 110 countries to Burnaby. He was instrumental in securing a Memorandum of Understanding between the City and Tennis Canada for a Western Canada Training Centre here in Burnaby.

As a member of the Parks, Recreation and Culture Commission and the Mayor's Task Force on Graffiti, Paul inspired the City's mural program, which brought beautiful art to neighbourhoods across Burnaby.

When Paul identified a need in the community, he dedicated himself to addressing it. He felt that there was a real gap in affordable housing for seniors in our province and that seniors needed more in-home support. Paul joined the Board of Trustees of New Vista, where he played a critical role in helping the organization grow.

Because he was so good at inspiring others, Paul was also an accomplished fundraiser. For his 80<sup>th</sup> birthday, he asked friends and family to make a donation to New Vista instead of bringing gifts. On that day, he raised \$100,000 dollars for seniors. Paul was always giving back.

Through his work on Council and on more than a dozen committees and commissions, Paul exemplified the spirit of volunteerism and public service. He was awarded the Queen's Jubilee Medal, the BC Community Achievement Award, and the Burnaby Business Excellence Community Service Award, among many others.

Paul had a big heart and was always ready to give of himself without expecting anything in return. He was kind and generous with his time and energy. He was a mentor and a friend to many.

On behalf of all Burnaby residents, City staff and Council members, we will miss Paul's enthusiasm, his warmth, his vision and his dedication. We are so thankful for his lifelong service to our community."
