Dear Council,

We are condominium-owner within a complex located at King's Crossing. We are not opposed to the legalization of marijuana. However, We strongly oppose the opening of a BC Cannabis Store in Kings Crossing as it would be harmful to our children and the youth population and a detriment to our community. Please see reasons listed below:

- Although the legal age to purchase cannabis has been set at 19, the commercialization of cannabis and sale of edible products may appeal more to children and under-aged youths. This proposed store would be less than 1 km away from elementary and secondary schools. Previous studies have shown that growing up within 20 km of a marijuana dispensary associates with early use of marijuana among adolescents (Palali et al., Health Econ 2014). Such findings can be extrapolated to pertain to cannabis stores that sell ready-made products.
- Full legalization and commercialization of marijuana substantially reduce the price of cannabis products (Caulkins et al., Addiction 2012). Children and adolescents may be influenced by price reductions as they have limited financial means and they may also be the primary target of sales.
- The adolescent years are crucial years for cognitive development and learning. Marijuana use during these years associates with: impairments in cognition and increase risk of developing cannabis dependence, school drop-out, psychiatric illnesses and risky behaviors. Additionally, the lost cognitive capacity does not recovery after completely stopping marijuana. Heavy use of marijuana more adversely affects adolescents than adults. (See scientific references below)

- The sale of edibles and other forms of cannabis to a community with many families places our youngest children at risk of unintentional toxicities and physical harm. In one study from an emergency room in Colorado, the number of unintentional ingestions among children <12 increased by over 10x after modifications to marijuana drug laws. Of these cases, half came from edibles.

In summary, the location of a BC Cannabis Store in King's Crossing places our Edmonds community and children at risk. The store would be close to educational facilities/schools and community centers, where our children, pre-teens, and teenagers learn and participate in after-school activities, at times without parental supervision. By placing a BC Cannabis Store in this location, it would entice youth to try marijuana including edible products which may pose significant long-term harm to their development as well as the overall safety of our community. We strongly advocate against this location and recommend further consideration be given to re-location as well as limitation of the kinds of products that are sold if the store will be in proximity to environments where children learn and socialize.



Dear Sir/Madam,

With reference to the Notice of Public Hearing on the above subject, I lodge my objection to the proposed change of zoning to accommodate the cannabis store at 7360 Kingsway.

The proposed location has 3 residential towers immediately above it. Smoking is not allowed in common areas of the building including carparks and residential balconies. It is often noticed that people go smoking on the service lane outside the building. The favourable spots are the carpark entrances and the loading bays on the service lane. Some smoke in the parked vehicles along the lane and blow smoke out of the car/truck windows. We live in the mid level of the tower and are still disturbed by the tobacco smell when our window or balcony door is opened. Second hand smoke is harmful to non-smokers.

If the cannabis store is opened, buyers of cannabis (for smoking) would be eager to enjoy their purchase. When smoking in front of the store is not allowed, the immediate side lane to the building would become a favourable spot. The residents above and nearby would suffer more apart from recent tobacco smoking nuisance. All these will increase our health hazard.

A cannabis store is not allowed within 200 meters of a park or a community centre. It seems unreasonable that it is allowed within a densely populated development with 3 residential towers above it. There are also rows of low rise townhouses immediately adjacent to the east side of the complex.

We strongly object to the proposed cannabis store to be accommodated at 7380 Kingsway inside a complex with high density population.
