As long-time Burnaby residents, our whole family would like to explicitly express our strong objection to the below zoning bylaw amendments, for the following reasons:

- * It is too close to the library and community centre where a lot of families take their kids for meaningful and healthy activities. With a cannabis store in the area, many parents will definitely want to prevent their children from getting close to it, to the extent that they may even consider reducing those meaningful and healthy activities for their children. Whether people like it or not, cannabis is very much associated with unhealthy and harmful behaviour and habit, for good reasons.
- * The smell from cannabis is unpleasant to a lot of people. With it lingering in the air, other local businesses will definitely negatively impacted because a lot of people will avoid going there for shopping purposes.

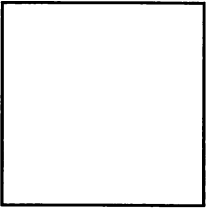


