His Worship, Mayor Mike Hurley recognized and thanked Deanne Burleigh, Officer In Charge, Burnaby RCMP Detachment, on her retirement. Following is the text of the Mayor's remarks:

“Tonight, I have the opportunity to thank someone who has done a tremendous amount of good for our community since she became the officer in charge of the Burnaby RCMP Detachment just over three years ago – our exceptional chief superintendent, Deanne Burleigh.

This is a bittersweet opportunity this evening, as we are honouring Deanne at the time of her retirement.

Deanne arrived in Burnaby as chief superintendent and officer in charge in December 2017, coming here from the upper Fraser Valley Regional Detachment, where she had been Officer In Charge, responsible for the policing of four municipalities. prior to that, Deanne had held many other high-level roles including: Officer In Charge of the Integrated Health and Resource Management Team at 'E' Division Headquarters; Operations Officer at the Richmond Detachment; and had served eight years in Commercial Crime Extensive Operational.

Deanne has been busy!

Most importantly, she has been busy doing work that has made our City and Region a much better and safer place for everyone. As the leader of our Burnaby police service, Deanne has been the face of the Burnaby RCMP. That fact has served our community very well, as Deanne's dedication to her role of keeping Burnaby citizens' safe has consistently been expressed with an integrity, openness and compassion that has ensured confidence in the professionalism, dedication and empathy of our policing. Deanne led by example. As she established herself as a leader in the Burnaby community, she did so in a way that ensured everyone saw her as a true member of our community.

Deanne set the stage for the style of policing that all communities strive for – maintaining the rule of law while staying accessible, approachable and dependable, regardless of the challenging situations.

As Deanne led one of the largest detachments in Canada, due to her rank, leadership skills and problem solving abilities, she also was called upon to take on many other roles and responsibilities for the RCMP, benefitting communities beyond Burnaby at the Provincial and National level.

Deanne embraced all of these responsibilities with complete dedication to ensuring every job would receive her full attention – and she never lost sight of her responsibility as an administrator, to ensure that the Burnaby RCMP is well-equipped with the facilities and equipment required to perform its critical role. The City and the Burnaby RCMP have both been fortunate to have been the beneficiaries of Deanne’s commitment to excellence and ability to achieve it.

Clearly, while many have benefitted from Deanne’s service, her achievements on our behalf are the kind that can only arise from a 24-7/365 commitment. During all of Deanne’s years of service, it’s clear that her time to spend enjoying personal pursuits would have been limited!

We hope that you’ll fully enjoy getting some of that time back now, Deanne – that as you now move away from a career in which so much of your time has been dedicated to the betterment of the Burnaby community – and the many communities you have served throughout your career – you will enjoy having time to indulge in activities we expect you’ve had little time for before now.

On behalf of Burnaby City Council and the entire Burnaby community, thank you for your service! We are and will continue to be a better community because of it – and are grateful for all you have accomplished and the lives you have touched with compassion, care and understanding.

All the best to you during what we are sure will be a very active and exciting retirement!

Thank you, Deanne, for your exceptional service!”

Council collectively thanked Chief Superintendent Burleigh for her dedication, professionalism and approachability, and wished her a happy retirement.

4. PRESENTATION

4.1 Metro Vancouver - Re: Metro 2050 - Update to the Regional Growth Strategy

Mr. Sean Galloway, Director Regional Planning, and **Ms. Erin Rennie**, Regional Planner, Metro Vancouver, appeared before Council via Zoom and provided a general review of the updates to the Metro 2050 Regional Growth Strategy.

The delegation informed Council that Metro Vancouver is in the process of updating Metro 2040. The update is being undertaken to extend the regional growth strategy to the year 2050, to consider significant drivers of change, to integrate with Transport 2050 (TransLink’s new Regional Transportation Strategy), and to implement policy improvements in a number of areas.

The presentation included information regarding timelines, policy reviews, and the anticipated engagement approach.

In conclusion, the delegation advised that Metro Vancouver is committed to working in close collaboration with member jurisdictions, TransLink, the Province, adjacent regional districts, and other regional agencies throughout the update. The updated strategy is anticipated to be completed in 2022.

5. DELEGATION

5.1 Pina Camerin - Re: Parkcrest Elementary School Seismic Upgrade

Ms. Pina Camerin, on behalf of herself and nine (9) other homeowners on Fell Avenue, appeared before Council via Zoom regarding the Parkcrest Elementary School seismic upgrade and new school addition project.

Ms. Camerin expressed the following concerns regarding the project: a lack of information and public consultation; loss of privacy, security and safety; access to the park; height of the addition; property value; destabilization of property; and construction noise and dust concerning the project.

In conclusion, the speaker requested that the City delay the building permit until such time as the residents have had an opportunity to meet with the Burnaby School District and design team.

Arising from discussion, Council requested that staff contact the Burnaby School District to bring forward the concerns raised by the delegation.

9.1 **Mayor Mike Hurley – Notice of Motion - Overdose Crisis**

His Worship, Mayor Mike Hurley, submitted a Notice of Motion regarding the overdose crisis and the increased numbers of deaths. The resolution calls on the Federal Government to declare the overdose crisis a national public health emergency and decriminalize personal possession of all psychoactive substances.

WHEREAS the overdose crisis continues to claim many lives, with 49 deaths in Burnaby between January and November 2020. This represents a 72% increase from 2019; and

WHEREAS the COVID-19 pandemic has negatively impacted access to harm reduction services, and fueled greater toxicity within the illicit drug supply; and

WHEREAS Premier Horgan wrote to Prime Minister Trudeau on July 20, 2020, asking the federal government to decriminalize personal possession of all psychoactive substances, as a necessary next step to reduce the stigma associated with substance use and encourage people at risk to access lifesaving harm reduction and treatment services; and

WHEREAS the Canadian Association of Chiefs of Police agree that decriminalization of simple possession is an effective way to reduce public health and public safety harms associated with substance use and endorses alternatives to criminal sanctions for simple possession of illicit drugs; and

WHEREAS Provincial Health Officer Dr. Bonnie Henry has called for the decriminalization of personal possession of illegal substances, as an urgent and necessary next step to addressing the overdose crisis; and

WHEREAS decriminalization is a step toward addressing anti-Black, anti-poor, and colonial policing at this time.

THEREFORE BE IT RESOLVED THAT the Government of Canada declare the overdose crisis a national public health emergency so that it is taken seriously and funded appropriately; and

THEREFORE BE IT FURTHER RESOLVED THAT the Government of Canada immediately seek input from the people most affected by this crisis and meet with provinces/territories and local governments to develop a comprehensive, pan-Canadian overdose action plan.
