#### 1. CALL TO ORDER

His Worship, Mayor Mike Hurley, called the Open meeting to order at 5:00 p.m. and conducted the roll call. Due to the COVID-19 pandemic, Councillors Calendino, Johnston and Jordan participated electronically.

For the benefit of the Council members that were participating by electronic means, Mayor Mike Hurley reviewed the staff members present at the meeting.

His Worship, Mayor Mike Hurley, recognized the ancestral and unceded homelands of the hənqəminəm and Skwxwú7mesh speaking peoples, and extended appreciation for the opportunity to hold a meeting on this territory.

#### In Memoriam - Colonel Howe Yet Lee

His Worship, Mayor Mike Hurley formally acknowledged the life and passing of Colonel Howe Yet Lee. Following is the text of the Mayor's remarks:

"I want to take a moment to reflect on the life and service of Burnaby community member and retired Army Colonel Howe Yet Lee.

Colonel Lee passed away on 2021 March 11. He was a third-generation Chinese Canadian with a distinguished military career of over 35 years. He grew up on his family's farm in Armstrong, but later made Burnaby his home.

Colonel Lee was an active volunteer, who coordinated cadet programs, promoted Remembrance Day in public schools, and was a founding board member of the Chinese Canadian Historical Society of BC.

He was also the co-founder and first president of the Chinese Canadian Military Museum Society. In that role, Colonel Lee worked hard to ensure Canadians remembered the many Chinese Canadian veterans who served in the First and Second World War. These veterans participated in the war efforts, despite the discrimination they faced back home in Canada. And it was important for Colonel Lee that their accomplishments be recognized by their fellow Canadians.

In 2012, he received the designation of "Colonel" as an honorary title, in recognition of his 35 years of distinguished military service.

Many in Burnaby remember Colonel Howe Lee as "Mr. Lee." He was a popular high school math and science teacher in Burnaby for 40 years.

More recently, he contributed photographs and stories to the Across the Pacific exhibit currently on display at the Burnaby Village Museum, and supported the work of staff to research and uncover stories of Chinese Canadian history in Burnaby.

On behalf of Council and the City of Burnaby, I would like to express our sympathy to Colonel Howe Lee's family, as well as our gratitude for his contributions to Burnaby, and to our country."

### 3.1 Simon Fraser Student Society - Re: Burnaby Mountain Gondola Project Speaker: Osob Mohamed, President

<u>Ms. Osob Mohamed</u>, President of the Simon Fraser Student Society, appeared before Council via Zoom expressing support for the Burnaby Mountain Gondola Project.

The speaker advised that over 26,000 students are members of the Simon Fraser Student Society, and 88% of the members commute to school. The Student Society conducted an open house garnering feedback from members regarding the Burnaby Mountain Gondola Project. The majority of students polled were in favour of the gondola.

The speaker informed Council that the gondola would address: environmental sustainability; reduction of emissions from diesel busses; reliability during inclement weather; and a safe alternative in the event of an earthquake, fire, or other emergency event.

In conclusion, Ms. Mohamed requested Council's endorsement and support for the Burnaby Mountain Gondola project.

It was noted that since receiving this correspondence from the City of New Westminster, a press release was issued by the Provincial Government regarding proposed amendments to the local government legislation and the School Act, allowing candidates and their representatives access to strata properties and other multifamily properties for the purpose of canvassing and distributing candidate information.

  - b) The deposit of sufficient monies including a 4% Engineering Administration Fee to cover the costs of all additional services necessary to serve the site and the completion of a servicing agreement covering all additional requisite services. All services are to be designed to City standards and constructed in accordance with the Engineering Design. One of the conditions for the release of occupancy permits will be the completion of all requisite services.
  - c) The utilization of an amenity bonus through the provision of a cash in-lieu contribution in accordance with Section 4.7 of this report.
  - d) The granting of any necessary statutory rights-of-way, easements and/or covenants.
  - e) The submission of a suitable Solid Waste and Recycling Plan to the approval of the Director Engineering.
  - f) The deposit of the applicable Parkland Acquisition Charge.
  - g) The deposit of the applicable GVS & DD Sewerage Charge.
  - h) The deposit of the applicable School Site Acquisition Charge.
  - i) The deposit of the applicable Regional Transportation Development Cost Charge.
  - j) The submission of a written undertaking to distribute area plan notification forms, prepared by the City, with disclosure statements; and, to post area plan notification signs, also prepared by the City, on the development site and in the sales office in prominent and visible locations prior to Third Reading, or at the time marketing for the subject development commences, whichever is first, and remain posted for a period of one year, or until such time that all units are sold, whichever is greater.
