<u>In Memoriam – Dave Mercier</u>

His Worship, Mayor Mike Hurley, formally acknowledged the life and passing of Dave Mercier. Following is the text of the Mayor's remarks:

"I have some sad news to share tonight. Dave Mercier has passed away. He was 81 years old.

A former City Councillor, Mayor and MLA for Burnaby-Edmonds, Dave served and represented the people of Burnaby for more than 30 years.

Those who served with Dave knew him as an intelligent and dedicated public servant.

He was first elected to council in 1968 for a three year term, and was elected again in 1977. He then served as Mayor of the City of Burnaby from 1979 to 1981.

As Mayor, he was a champion of public transit, and oversaw the approval of Burnaby's Comprehensive Transportation Plan. He prioritized the natural beauty of Burnaby's major parks, and advocated for the preservation of Deer Lake Park as an area of quiet tranquility. And he believed in that Burnaby's increasingly diverse population was a great thing for our community.

Though he stepped down after one term as Mayor, it wouldn't be long until he stepped back into public life on behalf of Burnaby residents. As a member of the Social Credit Party, Dave represented Burnaby-Edmonds as MLA from 1986 to 1991.

Dave believed in our community, and dedicated so much of his life to the people of Burnaby. We are grateful for everything he did for this community.

On behalf of Burnaby City Council, I would like to offer our condolences to Dave Mercier's friends and family."

4. <u>DELEGATION</u>

4.1 UNITE HERE! Local 40 - Re: Hilton Metrotown Hotel Workers Speaker: Kevin Malone

Mr. Kevin Malone, representing the UNITE HERE! Local 40 of the BC Union for Hotel and Hospitality Workers, appeared before Council via Zoom advocating for employees at the Hilton Metrotown Hotel. The speaker advised that the Hilton Metrotown has terminated approximately 100 long-term employees, a majority of whom are women and racialized persons, and refusing to commit to re-hiring them as the industry recovers.

Mr. Malone informed Council that management at the Hilton Metrotown is using the pandemic terminations as a means to roll back jobs to minimum wage and deprive workers of economic security. The hotel recently issued a 72-hour lockout notice.

In conclusion, the speaker requested that the City of Burnaby join several union organizations in ceasing patronage of the Hilton Metrotown until management commits to re-hiring terminated employees.

His Worship, Mayor Hurley thanked Mr. Malone for his presentation and pledged to support the laid-off employees and the provision for their recall.

 - b) The consolidation of the two properties within the BCIT campus into one legal parcel.

 - (a) Off-Street Parking Reserve Fund; and
 - (b) Active Transportation Infrastructure Reserve Fund; as outlined in this report, to receive payment-in-lieu of the required off-street parking spaces.

THAT Council be authorize the City Solicitor to bring forward a Reserve Fund Transfer Bylaw to transfer all funds, including accrued interest, in the Hastings Off-Street Parking Reserve Fund and Metrotown Centre Off-Street Parking Reserve Fund (currently totaling \$2,462,333) to the new City-wide Off-Street Parking Reserve Fund.
- 5. THAT Council authorize the City Solicitor to bring forward a bylaw to repeal the Burnaby Off-Street Parking Reserve Funds Bylaw once the above reserve fund transfers are completed.

WHEREAS these changes threaten the livelihood of millions of farmers and farm workers whose sole source of income is directly tied to farming; and

WHEREAS these legislative changes will not only hurt Indian farmers, farm workers and their families but will also jeopardize food security for countries that trade in agricultural commodities with India; and

WHEREAS despite the horrific pandemic, hundreds of thousands of farmers and their supporters have risked their lives while protesting peacefully for months, far from their families, properties, crops and livestock under insufferable conditions; and

WHEREAS reportedly hundreds of protesters have died in their struggle to secure fair and just legislation to protect their livelihoods; and

WHEREAS when there is global opposition to a legislation, a democratically elected government is expected to respond in good faith; and

WHEREAS the City of Burnaby Council, as a strong supporter of individual and workers' rights, opposes the heavy-handed treatment of peaceful protestors;

THEREFORE BE IT RESOLVED that Burnaby City Council expresses its solidarity with farmers and farm workers of India and calls on Prime Minster Justin Trudeau to impress upon the government of India to immediately dialogue with the aggrieved farmers to finding a solution to their grievances.

AND BE IT FURTHER RESOLVED that a copy of the letter be sent to the leaders of the federal opposition parties and members of Parliament from the City of Burnaby.
