1. CALL TO ORDER

The Chair called the Open Committee meeting to order at 2:00 p.m. and conducted the roll call. Due to the COVID-19 pandemic, Councillors Dhaliwal and Keithley participated electronically.

The Chair, Councillor Pietro Calendino, recognized the ancestral and unceded homelands of the hənqəminəm and Skwxwu7mesh speaking peoples, and extended appreciation for the opportunity to hold a meeting on this territory.

2. MINUTES

2.1 <u>Minutes of the Planning and Development Committee Open meeting held on 2021 April 27</u>

3. PRESENTATION

3.1 <u>Burnaby Transportation Plan Update</u>

Presenter: Zeralynne Te, Planner 3

<u>Ms.Te</u> provided an update of the work completed to date on the Burnaby Transportation Plan, while also seeking concurrence from the Committee.

Staff recognize local First Nations as important stakeholders and partners in the decision making process of the Transportation Plan, and will continue to seek their engagement and consultation.

Based on feedback received during the Phase 2 Public Consultation Program and peer review, staff have refined the goals, removed Land Use and Public Realm from modes, and created a Foundations section. The Foundations section will establish policy direction and actions which will supplement and support modes.

The Foundations topic areas are:

- Land Use Integration supporting the region's goals of compact, complete communities centred around transit and Frequent Transit Networks (FTNs); and supporting affordable residential development along or near the FTNs.
- Streets are for Everyone establish street design standard that is accessible and inclusive, street activation, animation and beautification programs, and engagement with stakeholders and local First Nations.
- Public Realm and Place-making develop opportunities for temporary and permanent creative street programming; and engage with local First Nations to identify Special Places; respectful of local First Nations traditions, beliefs and uses of the space.
- Transportation Demand Management Strategies identify staff resources to develop and market projects and programs that promote sustainable

modes within the community; and support regional initiatives towards shared vehicle use.

 Behavior Change – model corporate leadership by identifying staff resources to lead work with the community and stakeholders to develop programs to enable and encourage a shift to sustainable transportation; and engage with neighbouring cities, First Nations, TransLink and other stakeholders to coordinate policies, programs and infrastructure supports such as wayfinding to encourage sustainable transportation.

The Big Moves initiatives:

- Walking and Rolling by 2030, 80% of the City's pedestrian network will be completed to provide accessible, safe, and comfortable walking and rolling environments.
- Cycling by 2030, the Phase 1 cycle network will be completed, providing clear, consistent and continuous connections between town centres, major destinations and to neighbouring municipalities.
- Transit by 2030, the City will install 200 additional bus shelters or bus benches to increase transit passenger comfort; and by 2025, the City in partnership with TransLink, will complete feasibility studies for future rapid transit corridors to inform the upcoming OCP review, and identify necessary land investments to protect specific corridors.
- Goods and Services Movement by 2023, the City will establish policies to require all multi-family developments provide secured storage amenities for oversized deliveries and goods requiring cold storage; and require the provision of EV charging infrastructure for fleet vehicles across businesses, industries and institutions.
- Driving by 2026, develop and implement a Smart City Plan for Burnaby comprising of sensor technology, real-time data transmission and analytics to improve safety and optimize network performance.

In conclusion, Ms. Te advised a further presentation will be forthcoming encompassing: Key Policies and Actions, Networks (multi-modal corridors), and the Implementation Strategy.

The Committee thanked staff for the presentation and requested that staff followup on the items listed below:

- ensure cycling is accessible and safe for all ages and skill levels;
- provide wider sidewalks in all areas of the City;
- inclusion of separated bike lanes wherever feasible;

- increase north/south rapid transit corridors, specifically along Willingdon Avenue; and
- accelerate the timing and number of proposed bus benches and/or shelter installations.

Further, the Committee requested that staff complete work on the bus stop renovation at Canada Way and Deer Lake Parkway.

Engineering Department staff undertook to follow-up.

4. **CORRESPONDENCE**

4.1 Kensington Gardens - Re: Lochdale Urban Village Community Plan

Correspondence was received from Mr. Graham Dodd, Vice President and Ms. Kimberley Wong, President, Owners Committee of Kensington Gardens, located in the 5700 block of Hastings Street, requesting that the City consider expanding the area of the Lochdale Urban Village Community Plan one block to the west to include Kensington Gardens.

The Committee requested that staff review the inclusion of the area between Kensington Avenue to Holdom Avenue in Phase 2 consultation of the Lochdale Urban Village Plan.
