1. CALL TO ORDER

2. MINUTES

2.1 <u>Minutes of the Executive Committee of Council Open meeting held on 2021</u> <u>June 09</u>

3. CORRESPONDENCE

3.1 <u>Correspondence from Burnaby Hospital Foundation - Re: Gift Agreement Between the Foundation and the City of Burnaby</u>

Correspondence was received from the Burnaby Hospital Foundation expressing appreciation for funding support and providing the Gift Agreement between the City and the Foundation. The Agreement sets out the pledge schedule and the Statement of Purpose to support the construction of a new hospital tower, and the expansion and renovation of the Facilities Services building.

Staff certified that the Agreement describes what Council had previously agreed to. Staff will execute the Agreement once the Committee approves the proposed name on the exterior of the renovated Facilities Service Building – Emergency Department: "City of Burnaby Emergency Department".

3.2 <u>Correspondence from Navreen Gill - Re: Thank you freezing rental rates for non-profits</u>

Correspondence was received from Navreen Gill, Executive Director, Burnaby Family Life, expressing appreciation for Council's decision to continue the 2021 lease rates, and corresponding grants levels, for the duration of the 2022 calendar year for non-profit tenants at City-owned Community Resource Centres in recognition of the financial impact of the pandemic.

3.3 <u>Correspondence from Take a Hike Foundation - Re: Letter of Appreciation and Report (#20.20)</u>

Correspondence was received from Larissa Hayes, Director of Development Take a Hike Foundation, expressing appreciation to the City for funding in support of the organization's programming. Ms. Hayes provided information on the positive impact of the Foundation on youth in 2020.

4. <u>REPORT</u>

4.1 Report from the Chief Election Officer and the Director Engineering - Re: Sign Bylaw Violations During the 2021 City of Burnaby By-Election

The Chief Election Officer and the Director Engineering submitted a report providing information on the Sign Bylaw violations during the 2021 City of Burnaby By-Election.

The Chief Election Officer and the Director Engineering recommended:

1. THAT the Committee recommend Council receive this report for information.

The Committee raised concerns regarding staff enforcement of the Sign Bylaw during the recent by-election, and specifically the wording in the Bylaw as it pertains to the waving of signs on sidewalks and at intersections.

The Committee advised that the waving of signs on street corners promote good democracy. This activity not only levels the playing field among candidates in terms of campaign resources, but also raises public awareness about an upcoming election. As such, the Bylaw wording should allow for temporary waving of signs by people during an election.

Staff advised that they would review the Bylaw wording to allow for a broader interpretation, as well as enforcement activity during the by-election with respect to "human billboards".

Staff undertook to follow up.

6.1.1 #21-L-001 - UniverCity Community Association

SFU StreetFest @ UniverCity 2021

REQUEST: \$12,000

An application was received from the UniverCity Community Association for the SFU StreetFest @ UniverCity 2021 event to be held on 2021 September 1-3 at University High Street, Burnaby Mountain. This is an annual Festival (although cancelled last year due to the COVID-19 pandemic) created to further engage SFU students and staff, local businesses, SFU services, elementary school and residents. This free festival highlights various activities with performances, vendors, food and activities.

8.1 #21.21.I - United Way of the Lower Mainland - United Way Street Banners REQUEST: (I) \$10,000

An application was received from the United Way of the Lower Mainland requesting an in-kind grant for \$10,000 to cover banner installation and removal expenses along the Kingsway corridor, between Boundary Road and Royal Oak Avenue. The banners would be installed from 2021 October 01 to December 31. Approximately 37,500 residents benefit from United Way programs.

8.2 #21.22.P Stream of Dreams Murals Society - Métis Camps

REQUEST: (P) \$13,110

An application was received from the Stream of Dreams Murals Society requesting a program grant in support of the Métis Camps taking place from 2021 July 17 to December 31. This is an ecology-based program, employing at least five Burnaby residents, for children ages 6-12. The program teaches Métis children about their culture and their roots through medicinal plant walks at Burnaby Lake, creating medicine bags, making dream catchers and traditional foods. About 30 Burnaby families will participate in this year's program.

8.3 #21.23.I - Young Elite Vancouver Business Association – Golf Tournament and Fundraiser

REQUEST: (I) Not specified

A first time application was received from Young Elite Vancouver requesting an in-kind grant (green fee waiver) in support of a golf tournament fundraiser for the Burnaby Hospital Foundation to be held in 2021 September (date to be determined) at Burnaby's Riverway Golf Course. The organization plans to donate the majority of the profits from the event, as well as any corporate sponsorship money received. The Vancouver International Volunteer Association, a Burnaby-based registered society, is co-hosting this event.

A staff note advised that they had not received confirmation of a booking at Riverway Golf Course.

History: no previous application

The Committee inquired regarding the applicant's budget, including the retaining fee, and forecast donation amount to the Burnaby Hospital Foundation.

The Chair requested staff confirm with the applicant that all net proceeds from the tournament, including sponsorship monies, will go to the Foundation.

Staff undertook to follow up.
