#### **4. DELEGATIONS**

##### **4.1 Metro Vancouver - Re: Introduction of Metro Vancouver's Regional Economic Prosperity Service**

**Speakers: Jacquie Griffiths, Executive Vice President, Regional Economic Prosperity  
Jerry Dobrovolny, Chief Administrative Officer**

**Ms. Jacquie Griffiths**, Executive Vice President, Regional Economic Prosperity Service, and **Mr. Jerry Dobrovolny**, Chief Administrative Officer, Metro Vancouver, appeared before Council via Zoom.

Mr. Dobrovolny acknowledged that the region's residents live, work, and learn on the shared territories of many Indigenous peoples, including 10 local First Nations. Invest Vancouver, formerly known as the Regional Economic Prosperity Service, is the Metro Vancouver region's economic development leadership service representing 21 municipalities, one treaty First Nation, and one electoral area.

Mr. Dobrovolny noted that the 2019 gross domestic product (GDP) of Metro Vancouver was \$149 billion, approximately 60% of the overall economic activity of the Province. The area employs 1.5 million workers, with 2.7 million people residing in the Metro Vancouver area.

Ms. Griffiths advised that as of the 2016 census, Burnaby's population was 232,755 representing 9.4% of Metro Vancouver's population, within 3.1% of the region's land area. The City has a thriving post-secondary ecosystem, with the top industries (by employment) being: retail trade; professional, scientific and technical services; health care and social assistance; and accommodation and food services.

Invest Vancouver has identified seven key regional industries: agritech; international trade and transportation; apparel; digital media and entertainment; green economy; high tech; and life sciences, advising that Burnaby is strongly aligned with four of the seven industries.

In conclusion, Ms. Griffiths advised that the regional priorities of Invest Vancouver are to invest in people, catalyze innovation capacities, build demand-side capacity, and increase global connectedness in an effort to compete locally and globally in attracting investment opportunities.

Council thanked the delegation for the informative presentation.

##### **4.2 Simon Fraser University - Re: Burnaby Mountain Urban Transit Gondola**

**Speakers: Gabe Liosis, President, SFU Student Association**  
**Mario Guisado, President, UniverCity Community Association**

**Mr. Gabe Liosis,** President of the Simon Fraser University (SFU) Student Society, and **Mr. Mario Guisado,** President of the UniverCity Community Association, appeared before Council via Zoom regarding a request for reliable public transit.

Mr. Liosis informed that students at SFU have been contending with overcrowding, long wait times, and unreliability in regard to public transit to and from Burnaby Mountain. The speaker, on behalf of the SFU Student Society, endorsed the proposed Burnaby Mountain gondola citing it as an option for reliable, safe and efficient transportation.

Mr. Guisado spoke on behalf of the UniverCity Community Association advising that residents of the area are currently facing the same barriers to public transit as SFU students. The speaker informed Council that 6,000 residents live in UniverCity, many of whom are not associated with SFU. The community feel underserved by the current transit system, as transportation is geared to students and not residents. Busses are taken off Burnaby Mountain routes when the student demand is less, resulting in long wait times for residents. In order to promote a greener community, the speaker requested a viable transit system that would support residents moving from cars to transit.

In conclusion, Mr. Guisado advised that UniverCity residents would support the proposed Burnaby Mountain Urban Transit Gondola.

**6.1 AMENDMENTS TO SOLID WASTE AND RECYCLING BYLAW 2010 FOR SINGLE-FAMILY, TWO-FAMILY, AND ROW HOUSE PROPERTIES**

### **Website Award**

Mayor Hurley advised that after being live for only 78 days, the City has received the 2021 Acquia Engage Award in the category of Leader of the Pack – Public Sector for the newly designed website. The Acquia Engage Awards recognizes high-impact digital experiences that demonstrate an advanced level of functionality, integration, performance and user experience. Mayor Hurley thanked staff for their hard-work.

### **Eerie Illusions**

Mayor Hurley advised that this year's Halloween event at Burnaby Village Museum, "Eerie Illusions", was very successful. The City sold out in 20,215 tickets, the most tickets the City sold to any event in its history. In addition, an additional 675 tickets were provided



for low-income families and youth through local not-for-profit organizations. Mayor Hurley congratulated staff.

**10. INQUIRIES**

**3550 Wayburne Drive**

Councillor Jordan queried whether neighbourhood consultation and/or community outreach had been conducted regarding 3550 Wayburne Drive, in accordance with the Official Community Plan Residential Framework.

Staff advised that two Open House consultations were held by the developer, in conjunction with City staff. In response to the consultations, the number of housing units were amended from 208 to 130. The notification area for the consultation was in excess of 100 metres.

**Norland Supportive Housing**

Councillor Jordan requested information regarding the status of the Norland Supportive Housing project.

Staff advised that the manufacturing for the development has been delayed.
