**Ms. Lee-Ann Garnett**, Deputy Director Planning and Building provided the Committee with an overview of HOME: Burnaby's Housing + Homelessness Strategy (Strategy) which is a 10-year plan of action addressing housing and homelessness as a system. The Strategy responds to the housing needs of the City's residents, as documented in the Burnaby Housing Needs Report and Mayor's Task Force on Community Housing recommendations.

The Strategy identifies the following five goals, and strategies and actions to facilitate their implementation:

- inclusive and livable neighbourhoods;
- options for secure tenure;
- renter-friendly community;
- healthy supply of non-market housing; and
- a place where homeliness is rare, brief, and one time.

Should Council approve the Strategy, the next steps would include:

- public communications;
- preparation of the first implementation report, detailing the actions to be undertaken in 2022; and
- advancement of Phase I of the infill program, including amendment of the Official Community Plan and development of detailed guidelines and Zoning regulations to permit laneway homes and suites in duplexes.

Council expressed concern regarding Actions in Phase 1 of the Strategy which would launch a multi-phase program to expand housing choices in R District neighbourhoods, and requested that staff ensure that all residents are aware of the proposed changes.

Staff advised that Actions which have broad reaching implications would require additional public consultation, in addition to Council approval.

Staff introduced **Ms. Johnna Sparrow**, Aboriginal Relations Advisor, Aquilini Development, who provided opening remarks regarding the Willingdon Lands proposal.

Ms. Sparrow advised that this proposal provides the Musqueam and Tsleil-Waututh Nations a living legacy as traditional stewards and owners of the lands, and to continue to advance reconciliation and create a positive legacy for future generations. The speaker thanked Aquilini Developments and the City for the opportunity to partner on this proposal to advance economic self-determination, training and employment.

Staff noted that the history of the lands, and historical and contemporary values, will be reflected in all aspects of the site development. The concept vision for the Contemporary Musqueam and Tsleil-Waututh Urban Village will balance the goals of cultural, social and economic self-determination for the Nations. The vision is supported by the following guiding principles:



- respect the past and embrace the future;
- nurture a sense of place,
- connect with the land and water; and
- advance reconciliation and accommodation.

The guiding principles will each have a set of design directives that will inform the site design. The Master Plan will be comprised of four character areas (districts) that include a Park District, Trade District, Storytelling District, and Residential District.

The next steps would be to seek Council endorsement of the preliminary concepts and vision, an Official Community Plan bylaw amendment, community consultation and feedback, and a finalized master plan to Public Hearing.

## **7. NEW BUSINESS**

### **Dr. Ambedkar**

Councillor Dhaliwal apprised Council that 2021 December 06 is the 66<sup>th</sup> anniversary of the passing of Dr. Ambedkar who was instrumental in drafting the Constitution of India. Dr. Ambedkar was an advocate for civil liberties, which included economic and social empowerment, freedom of religion, evolution of untouchability, as well as gender equality and all forms of discrimination.

Councillor Dhaliwal also thanked and acknowledged the work of the Chetna Association, which continues to bring awareness to Dr. Ambedkar's contributions to India, and democracies all over the world.

### **Ecole Polytechnique Mass Shooting**

Councillor Jordan and Councillor Gu recognized 2021 December 06 as the 32<sup>nd</sup> anniversary of the mass shooting at Montreal's Ecole Polytechnique, which took the lives of 14 young women. In 1991, the Parliament of Canada declared 6 December to be a National Day of Remembrance and Action on Violence Against Women.

In recognition, a moment of silence was observed.

### **Bill 26 – Municipal Affairs Statutes Amendment Act (No. 2)**

Councillor Jordan advised that Bill 26 was passed through the House last week and requested that staff bring forward information regarding the implications of this legislation.

Staff undertook to provide this information.
