Dear mayor and Burnaby City Councillors,


I am writing to express my support to the rezoning number REZ 17-10001 at Oliver Court.

I hope this email finds you as sick to your stomach as the communities you are destroying. You should be absolutely embarrassed by your lack of action concerning what is happening on Olive Avenue in Burnaby. We are in a Pandemic and you are destroying people's lives and neighborhoods. There are currently two rezoning applications happening on a block with moderate income housing for luxury properties. These are perfectly well kept, reasonable housing units. They are built in the last 40 years or so. Destroying these units to create profit housing is despicable. It is also not sustainable. Buildings should be built to last with green space. These buildings are perfectly hospitable. Moving people out while you spend three years + building a bigger "better" tower is not a solution. Nor is it creating effective solutions for the housing crisis. CLEARLY. These are for profit building designed as investments and money harboring, not for providing places that people can LIVE. They provide a minimal amount of sub par rental units while handing over mega profits for developers.

Over the last year the population of un housed people has grew rapidly downtown and incredibly more violent, friends of mine are left displaced with no where to move to. Businesses are destroyed from desperate people on the street. You are feeding a mental health crisis and addiction with your spinelessness towards predatory developers. These are not solutions designed for us.

Rent top ups are not enough.

High rises poorly built, small and for profit "rooms" are not enough.

Children being displaced from their neighborhoods and friends. It's not ENOUGH!

Wasting resources by destroying liveable homes. Is not enough.

Preying on people during a international health crisis is vile.

Buildings without green roofs and properties. Is not enough.

We've had enough of your pathetic excuses. DO SOMETHING! STOP DISPLACING FAMILIES, no matter what family looks like to them.

There should be no property approved without mandatory green space and green roof tops that support bio diversity and local food production. This is real action to moderate local temperatures and produce food locally.

We've been faced with a wave of climate crises and supply chain issues this year. Yet you refuse to implement changes. Yesterday was the time to take action, now you need to be in overdrive.
