REPORT

1.0 INTRODUCTION

Approval for a new name is requested of the Executive Committee for the venue formerly known as Horizons. With much thought and consideration, the name "Mintara" has been proposed to replace "Horizons" as the latter is owned by the previous restaurant owners.

As the venue is being upgraded, there is some urgency to establish the name in order to begin applying for operating licenses with Fraser Health, liquor licensing board, etc.

3.0 BACKGROUND

Following, please find some key reasons this name is considered well-suited for this venue:

- Mintara is the Japanese moniker for Burnaby Mountain's iconic Playground of the Gods, which is referred to as Kamui Mintara in Japanese.
- When conducting an online search for Mintara, the name/search already conveniently and directly brings users to this stunning Burnaby Mountain location.
- As a name, Mintara is wholly unique and shows as being available.
- The name Mintara is derived from ancient Japanese and loosely translates to garden.
- The name Mintara is directly associated with Burnaby Mountain versus culture/ language; indeed, the name Mintara is already directly related to the site.
- As a name, Mintara represents the kind of elegance and refinement associated with special events such as weddings and other memorable celebrations, which is especially important for this venue.

4.0 RECOMMENDATION

It is recommended that the name "Mintara" be approved for the restaurant on Burnaby Mountain. If this name is acceptable and approved by the Executive Committee, the City will continue their trademark and copyright search to ensure the legality of the name.
