#### REPORT

#### **1.0 INTRODUCTION**

On 2022 February 14, Council received a report introducing the parameters and purposes of the forthcoming Official Community Plan (OCP) update. The report notes the importance of population, dwelling and employment projections in guiding the land use and infrastructure policies of the OCP.

This report highlights key information from two recent data releases relevant to the OCP update: the initial release of the 2021 Census of Population ("Census") and the 2021 Metro Vancouver Growth Projections ("MV Projections"). These highlights are presented in graphic format in *Appendix A* and *Appendix B*.

This is the first in a series of reports that will summarize forthcoming Census releases, on topics such as demographics, housing, income, employment, mobility and migration, and First Nations, Indigenous, and Inuit statistics, as outlined in *Section 2.0*. These reports will contribute to a full community profile to inform the OCP update.

#### 2.0 CITY POLICY FRAMEWORK

Data review in support of the OCP update aligns broadly with all City policies, including the *Corporate Strategic Plan* (2017) and standalone policy documents such as the current OCP, the "sustainability trio" of the *Burnaby Economic Development Strategy* (2007), the *Burnaby Social Sustainability Strategy* (2011), and the *Environmental Sustainability Strategy* (2016), and the more recent *Climate Action Framework* (2020), *HOME: Burnaby's Housing and Homelessness Strategy* (2021), and *Connecting Burnaby: Burnaby's Transportation Plan* (2021).

#### 3.0 2021 CENSUS OF POPULATION

On 2022 February 9, Statistics Canada ("StatCan") issued its first major Census release from the 2021 census count. This release includes population and dwelling counts for different geographic levels, from nation-wide to individual blocks. In Burnaby, key levels include:

- Census subdivision (the entire municipality)
- Census tracts (larger neighbourhood areas)
- Dissemination areas (smaller neighbourhood areas)
- Dissemination blocks (individual blocks)

As shown in *Appendix A*, Burnaby's population grew by 7%, or 16,370 people from 2016 to 2021. This percentage change is equal to the percentage change in the Metro Vancouver region as a whole. Burnaby's population grew in all four quadrants, but growth varied widely between census tracts. Some Town Centres showed double-digit growth (Brentwood, at 73% being the highest), the result largely of recent tower development, while many lower density neighbourhoods experienced little to no growth, or a slight decline in population. The latter trend may signify aging households, and affordability challenges for larger families seeking housing.

The percentage increase in number of dwelling units was 9%, slightly higher than population growth, and higher than the regional average of 7%. This growth was also unevenly distributed, with most occurring in Town Centres. In some lower density areas, a decrease in housing units aligned with a decrease in population, while in others housing units increased slightly while population declined.

The 2022 February 9 release was the first in a series of seven major census releases to be made this year. A schedule for these releases is provided in Table 1 below:

Staff will summarize these releases in future reports.

#### 4.0 2021 METRO VANCOUVER GROWTH PROJECTIONS

In support of both regional and municipal planning efforts, Metro Vancouver periodically provides growth projections for population, housing, and employment. These projections rely on census data, as well as other sources such as BC Statistics estimates, local government data, and non-census estimates from StatCan. They also factor in a standard undercount percentage provided by StatCan. As a result, these projections feature higher population estimates than census population counts.

Metro Vancouver released a new set of growth projections in December 2021, which extend to 2050. The projections for Burnaby are provided in graphic format in *Appendix B*. Key projections for 2020 to 2050 include:

- A 38% increase in population from 259,210 to 358,220
- A 52% increase in number of households, from 102,520 to 156,000
- A 28% increase in jobs, from 156,260 to 199,990

For all three projections, the most significant period of growth in Burnaby is between 2020 and 2030. Projections for this time period include a:

- 16% growth in population
- 22% growth in number of households
- 12.5% growth in jobs

Burnaby's projected population and household growth to 2050 is similar to the projections for Metro Vancouver as a whole, which are 38% and 48% respectively. Burnaby's projected growth in jobs is slightly less than the regional projection of 33%.

It is important to note that these projections are estimates, not targets, and are based on population estimates that differ from others. Population counts and projections can vary significantly depending on sources and methodology. Table 2 shows differing population counts from the census, BC Statistics, and Metro Vancouver.

While none are exact, these population estimates establish a range on which to base further analysis. Similarly, growth projections establish general trends and possible growth scenarios to guide long range planning.

#### 5.0 DISCUSSION

Both the Census data and Metro Vancouver projections are important references for the forthcoming OCP update. While the data do not provide specific targets, they do provide baseline figures, trends and insight into our current population and household numbers, and the magnitude of growth to be accommodated by the updated OCP.

Understanding population, employment, and demographic trends can help the City decide how and where it should grow; what types and amount of housing is needed; what service levels should be planned for both physical and social infrastructure, what priority should be placed on protecting and expanding employment lands, and many other questions integral to the OCP update. Following the issuance of the last census release, in November 2022, staff will provide a full community profile for use in development of the OCP.

In addition, Metro Vancouver projections will shape the OCP update through the Regional Context Statement (RCS) process. These projections have informed the draft regional growth strategy update, *Metro 2050*, which is currently under review. Once adopted, *Metro 2050* will guide planning throughout the region, as each member government will be required to adopt a regional context statement (RCS) demonstrating consistency between *Metro 2050* and their OCP. Burnaby's new RCS will be an appendix to the updated OCP.

#### 6.0 CONCLUSION

This report highlights key information from two recent data releases that will inform the OCP update: the initial release of the 2021 Census and the 2021 Metro Vancouver Growth Projections. Key data are provided in graphic format in *Appendix A* and *Appendix B*. Future reports will summarize forthcoming Census releases, with a final report providing a full community profile. It is recommended that this report be forwarded to Council for information.



There were 249,125 people in Burnaby in 2021. The population has grown by 16,370 people (7%) since 2016.




### **Population by Quadrant**

The population increased in all four quadrants of the City from 2016-2021. The northwest quadrant, which includes Brentwood Town Centre, had the highest growth rate, at 15%.


### Population, Regional Comparisons 2016-2021

Burnaby's population is the third highest in Metro Vancouver. Burnaby's 5-year growth rate from 2016 to 2021 was equal to the regional growth rate. Approximately 9% of people in Metro Vancouver live in Burnaby.


### Population Change, 2016-2021






## HOUSING

There were 107,046 private dwellings<sup>1</sup> in Burnaby in 2021. This was up 9% from 98,030 in 2016.

1. Private Dwellings: A Private dwelling refers to a separate set of living quarters with a private entrance either from outside the building or from a common hall, lobby, vestibule or stairway inside the building. 
### Housing, Regional Comparisons 2016-2021

In 2021, Burnaby had the third highest number of housing units in Metro Vancouver. Burnaby's 5-year growth rate, at 9% is higher than the regional growth rate at 7%. The City of Burnaby accounts for 9.7% of the regional housing units.






- Projections undertaken for the Regional Growth Strategy were completed before the 2021 Census data were released.
