## **BYLAW NO. 14436**

A BYLAW to amend Bylaw No. 4742, being Burnaby Zoning Bylaw 1965, as amended by Bylaw Nos. 8460, 9094, 9368, 9662, 9936, 10567, 10584, 11527, 11528, 11871, 12081, 12420, 13133 and 13442 being Burnaby Zoning Bylaw 1965, Amendment Bylaw Nos. 70, 1985, 67, 1988, 21, 1990, 50, 1991, 37, 1993, 22, 1997, 25, 1997, 25, 2003, 26, 2003, 06, 2005, 13, 2006, 09, 2008, 36, 2012 and 05, 2015

WHEREAS application for rezoning has been made to the Council;

AND WHEREAS the Council has held a public hearing thereon after duly giving notice of the time and place of such hearing as prescribed by Sections 466 and 467 of the *Local Government Act*, R.S.B.C. 2015, c.1;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as **BURNABY ZONING BYLAW 1965**, **AMENDMENT BYLAW NO. 07, 2022**.
- 2. Bylaw No. 4742, as amended by Bylaw Nos. 8460, 9094, 9368, 9662, 9936, 10567, 10584, 11527, 11528, 11871, 12081, 12420, 13133 and 13442, is further amended as follows:
- (a) The Map (hereinafter called "Map 'A""), attached to and forming an integral part of Bylaw No. 4742, being "Burnaby Zoning Bylaw 1965", and designated as the Official Zoning Map of the City of Burnaby, is hereby amended according to the Map (hereinafter called "Map 'B""), marginally numbered REZ. 4401, annexed to this Bylaw, and in accordance with the explanatory legend, notations, references and boundaries designated, described, delimited and specified in particularity shown upon said Map 'B'; and the various boundaries and districts shown

upon said Map 'B' respectively are an amendment of and in addition to the respective districts, designated and marked on said Map 'A' insofar as the same are changed, modified or varied thereby, and the said Map 'A' shall be deemed to be and is hereby declared to be amended accordingly and the said Map 'B' is hereby declared to be and shall form an integral part of said Map 'A', as if originally incorporated therein and shall be interpreted accordingly.

(b) The Comprehensive Development Plan(s), more particularly described in Bylaw Nos. 8460, 9094, 9368, 9662, 9936, 10567, 10584, 11527, 11528, 11871, 12081, 12420, 13133 and 13442, are amended as may be necessary by the development plan entitled "Metrotower Childcare" prepared by Mara & Natha Architecture Ltd. and on file in the office of the General Manager Planning and Development; and any development on the lands rezoned by this Bylaw shall be in conformity with the said Comprehensive Development Plans as amended.


