We the residents of this neighbourhood, have reviewed the above proposed development and we would like to express our objections for the Proposed Development for the Burnaby Zoning Bylaw 1965, Amendment Bylaw No. 4, 2023 – Bylaw No. 4552, Rez. #22-03 7730 6th Street, from CD Comprehensive Development District (based on RM1 Multiple Family District).

The KEY points for this objection are listed below:

- 1. The size of the lot in proportion to the **Proposed Building HEIGHT particularly concerns us**, as it will stand out over neighbouring buildings, blocking sunrise, airflow, and scenery views for our peaceful residents in the surrounding area. The existing local infrastructure is at its capacity.
- 2. Such a high-rise building would dramatically **increase traffic** in the surrounding streets, especially during peak hours.
- 3. Insufficient **parking** provision, with the **scale**, **height**, and **density** of the proposed development will be an issue and will only exacerbate the circumstances, impacting our peaceful neighbourhood and will pose risks to the neighbourhood children playing at the Eastburn Park, next to the proposed building.
- 4. Alongside the proposed building, generators, air conditioners, traffic congestions, will increase noise, pollution, and end the peaceful ambience enjoyed by the current residents of the area.
- 5. This proposed additional HEIGHT in this residential area will become detrimental, impacting the ambiance of this neighbourhood as well as the large number of apartments planned with the proposed daycare will create additional parking issues.
- 6. With the plans to include "affordable" housing, this often brings into the neighborhood undesirable individuals who may bring drugs, alcohol, illicit behaviours into the existing quiet and peaceful family-oriented neighbourhood.

Finally, as residents, we ask the city to approve a smaller building, consisting maximum of 2 storeys along 13th Avenue, and 3 storeys along 12th Avenue, and a different architectural design that better fits in with our community.
