#### 1. CALL TO ORDER

Mayor Hurley called the Special Open Council meeting to order at 8:36 a.m.

Mayor Hurley recognized the ancestral and unceded homelands of the həndəminəm and Skwxwú7mesh speaking peoples, and extended appreciation for the opportunity to hold a meeting on this territory.

# 2. DRAFT 2024 - 2028 FINANCIAL PLAN - CAPITAL PLAN PRESENTATIONS

The Deputy Chief Administrative Officer / Chief Financial Officer provided an overview of the draft 2024-2028 Capital Plan Presentations and 2024-2028 Financial Plan process.

The speaker advised Council came up with the following strategic direction during strategic planning sessions held on January 9 and 10, 2023, which is the basis of the 2024-2028 Capital Plan:

- housing (affordability/delivery/authority);
- carbon neutrality;
- cycling network;
- safety;
- arts community engagement;
- maintenance standards; and
- program/program management accountability.

The speaker advised the Capital Plan proposed for 2024 is \$363.6 million, 59% of which is tied to the Lands & Facilities Department.

The speaker noted the Capital Asset Works Financing Fund (CAWFF) is depleting over the next five years, and although the expansion of Community Benefit Bonus and Parkland Development Cost Charges and the recently approved Growing Communities Grant will relieve some of the pressure, the reserve is being consumed faster than it is being replenished.

The Deputy Chief Administrative Officer / Chief Financial Officer highlighted considerations for Council to keep in mind during the departmental Capital Plan presentations:

- use of replacement savings to fund new projects;
- · replacement savings for replacements;
- ambitious Capital Plan with new facilities every year;
- operating impacts of new assets;
- increase in assets and aging of assets leads to increase in maintenance costs;

- internal resourcing/capacity constraints;
- difficult labour market;
- ongoing use of project management consultants;
- First Nations consultation processes;
- inflation rate to date approximately 4.3%;
- increase in cost of construction and materials;
- slow down in construction;
- significant lead time for materials, vehicles and equipment; and
- depletion of reserves.
