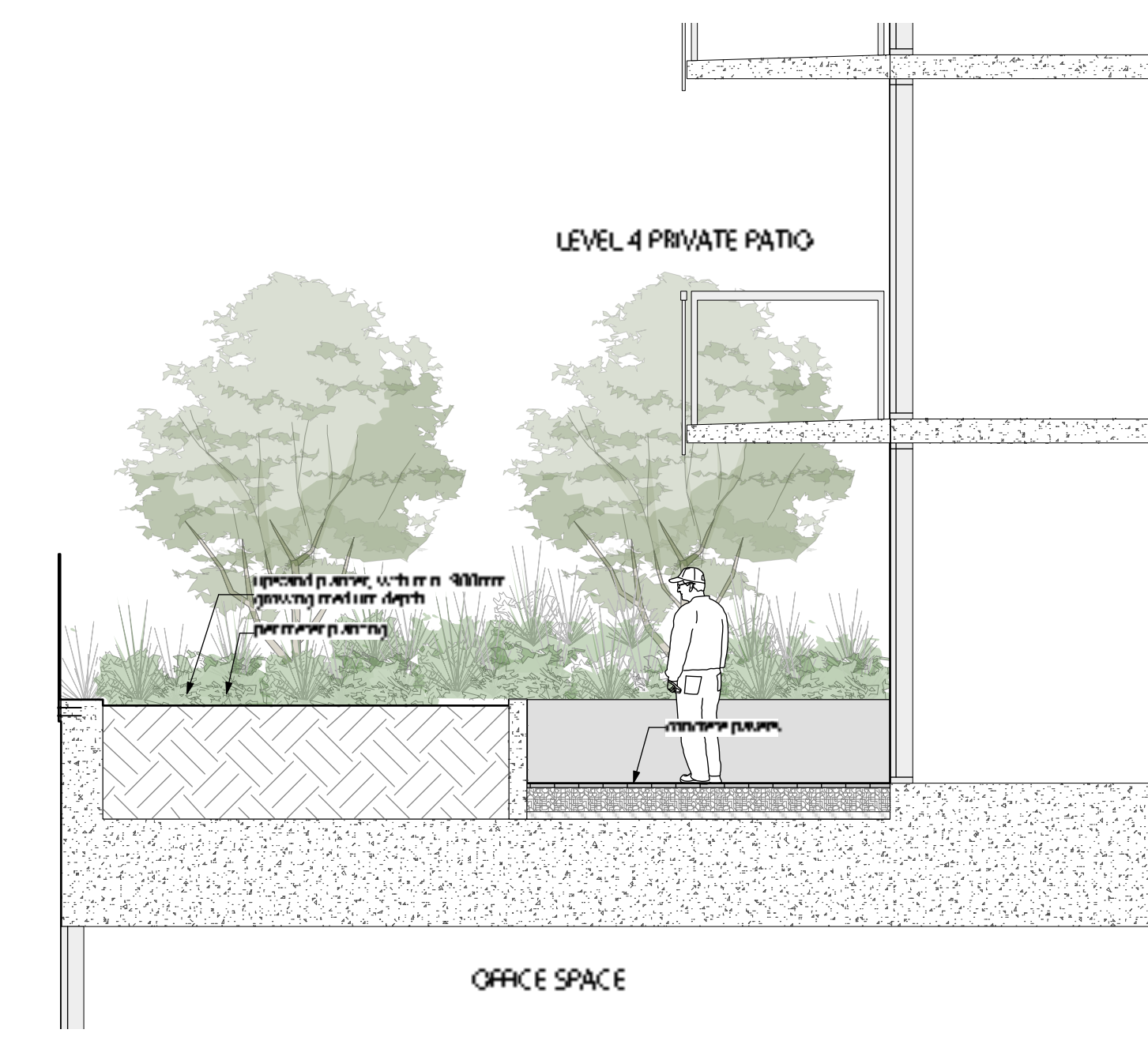
4 South to North, Level 2 Podium
