I have lived at Seton Villa for 4years.


I feel this building is important because it is desperately needed. I've lived in Burnaby since 1992 and would hate the thought of having to leave should my physical health change.

Another benefit is that we would not have to relocate our loved ones to another facility. Since change can affect their morale and be cause for depression setting in.


My wish is that you take what is already a wonderful seniors residence and expand it, in order to help the seniors in need.
