BYLAW NO. 14488

A BYLAW to amend Burnaby Building Bylaw 2016

- (m) at subsection 19(4), by deleting "Burnaby Planning and Building Fees Bylaw" and replacing it with "Burnaby Consolidated Fees and Charges Bylaw"; and
- (n) at subsection 26(1)(a), by deleting "Burnaby Planning and Building Fees Bylaw" and replacing it with "Burnaby Consolidated Fees and Charges Bylaw".
