# 5. ADMINISTRATIVE REPORTS

# 5.1 BARNET MARINE PARK PARKING OPTIONS

The General Manager Parks, Recreation and Culture submitted a report presenting the following potential options for parking management at Barnet Marine Park and seeking feedback on how to proceed with their implementation. These options are:

- Option 1: Pay Parking Program; or
- Option 2: Free Pre-Registered Parking Program; or
- Option 3: Status Quo Existing Parking Program

Councillor Wang expressed the need for data analysis focusing on parking usage and peak times of use.

The Chair noted the need for additional information on the implementation of Option 2 and the impacts of the program. In addition, he noted the need for Council to support the current annual operating budget required for the parking program. Arising from discussion, the original recommendation was not adopted and the following motion was introduced:

**THAT** staff prepare a report providing additional information on the implementation of Option 2: Free Pre-Registered Parking Program, as outlined in the report "Barnet Marine Park Parking Options", and include data analysis of park use and peak operating times, and

**THAT** the operating cost of \$250,000 annually for the implementation and administration of Option 2, as outlined in the report "Barnet Marine Park Parking Options" be supported by Council.

# 5.2 BURNABY RECREATION FINANCIAL ASSISTANCE AND INCLUSION PROGRAM

The General Manager Parks, Recreation and Culture submitted a report seeking the adoption of the "Financial Assistance and Inclusion for Residents Policy and Program" and the extension of the current program funding with Burnaby Community Services until May 31, 2025, to assist with the administration of the Fair Play Program.

**THAT** the current program funding with Burnaby Community Services be extended until May 31, 2025, to assist with the administration of the Fair Play Program.
