- Impact of recent adjustments to focus on free, large scale, broadly accessible events

1. Stabilization- 2024 Program Changes

Burnaby Blooms – focused on Deer Lake Park with some displays at the BC Parkway

Free Summer Community Events – neighbourhood level performances and events returns to pre-pandemic schedule.

New Music Event at Deer Lake – a new event with diverse music and increased audience capacity and the same excellent audience experience

Haunted Village at the Burnaby Village Museum – scale programming in alignment with 2019 Haunted Village



1. Stabilization - Funding

The Program would benefit from stable, multi-year funding commitments





2. Evaluation Framework:

Draft Vision:

Burnaby consistently delivers accessible, safe and diverse special events that:

- reflect community's cultural aspirations;
- contribute to vibrant parks, streets and neighbourhoods; and
- create memorable experiences for residents and visitors.

2. Evaluation Framework

Draft Objectives:

- 1. Special events allow residents to participate in shared cultural experiences, improving community cohesion.
- 2. Residents and visitors have access to diverse, high quality artistic and cultural performance and other forms of expression.
- 3. Equity deserving artists have support to create new work, perform, develop audiences and build awareness of their work in Burnaby.
- 4. Host Nation artists and forms of cultural expression are visible and supported.
- 5. Public spaces are welcoming, safe and activated for all ages and demographics.





3. Infrastructure & Servicing Investments

Service connections and infrastructure upgrades will reduce event costs and the complexity of production.



4. Support for Community Event Organizers

Improvements to support in two key areas:

- Festivals Burnaby Grant Program
- Community Special Event Process Review

- Quantifying the input of other departments to Special Events
- Supporting a growing City with new event spaces
