**1. CALL TO ORDER**

Mayor Hurley called the Open meeting to order at 5:00 p.m.

Mayor Hurley recognized the ancestral and unceded homelands of the hən̓q̓əmi̓n̓əm̓ and Skwxwú7mesh speaking peoples, and extended appreciation for the opportunity to hold a meeting on this territory.

**4.2 Public Hearing (Heritage Designation) held March 26, 2024**

**5. DELEGATIONS AND INVITED PRESENTATIONS**

**5.1 Delegation: New Westminster & District Labour Council - Re: Day of Mourning**

**Speakers: Karina Santiago and Azra Hubanic**

Karina Santiago and Azra Hubanic, representing New Westminster & District Labour Council, appeared before Council seeking support to recognize April 28 as a Day of Mourning for the workers killed on the job.

Azra Hubanic noted that in 2022, almost 1,000 people in Canada died as a result of the work injuries and noted that education is a key prevention to injuries on the job.

Karina Santiago called upon all levels of government for accountability for health and safety, and ensuring accident investigations are carried out. The speaker noted that employers and unions can help by providing personal protection equipment that fits all users, create national plan to remove toxic substances from workplace, eliminate harassments, and ensure that workers know their rights to be safe on the job.

In conclusion, the delegation encouraged attendance at the Day of Mourning Ceremony at the Westminster Pier Park in New Westminster at 11 a.m. on April 28, 2024.

Mayor Hurley thanked the delegation for their presentation and noted that Burnaby Council fully support Day of Mourning and workers' safety, and asked Council, staff and public to observe a moment of silence for the workers killed on the job.

**5.2 Delegation: Movement - Metro Vancouver Transit Riders - Re: Support for Rapid Transit in Burnaby Heights**  
**Speakers: Michelle Scarr and Spencer Powell**

Michelle Scarr and Spencer Powell, volunteers representing Movement - Metro Vancouver Transit Riders (advocacy group for transit riders in Metro Vancouver), appeared before Council seeking support of the originally proposed route alignment along Hastings and Willingdon.

Michelle Scarr noted that density is increasing around the Heights and rapid transit routes should be prioritized. The speaker noted that buses are safer than private vehicles, and in addition, a bus priority lane has been found to reduce collisions by 14% and decrease deaths and serious injuries by 31%.

Spencer Powell noted that the group has been collecting signatures, and 965 signatures were collected in support of the original alignment. The speaker advised that most of the riders are from Burnaby, and either live and/or work in the Heights. The Heights is growing and changing, and with foot traffic, cycle, walk and bus rides, the City can build transit system in the neighbourhood.

The General Manager Parks, Recreation and Culture (PRC) submitted a report providing Council with an update on the 2023 pilot program and seeking approval to bring forward a bylaw to make the program year-round and permanent.

The General Manager PRC provided opening remarks and introduced Carmen Gonzalez, Deputy General Manager PRC, and Rebecca Thandi, Director PRC Strategic Initiatives, who provided a PowerPoint presentation summarizing the report, noting that Option 4 providing simplicity to the program as well as enforcement.
